Ijma:-

Ijma refers to the consensus or agreement among Muslim scholars or the Muslim community on a particular issue. It is considered as a source of Islamic law alongside the Quran, Sunnah and Qiyas. Ijma is based on the belief of collective opinion of Muslim

Community holds authority and can be used to derive legal ruling in the absence of clear guidance from the Quran and Sunnah.

Qiyas:-

Qiyas refers to the process of reasoning by analogy in Islamic legal thoughts.

It involves applying the reasoning behind an established rule to a new case that is not explicitly addressed in the Quran or Sunnah.

Qiyas allows jurists to derive new rulings by analogical reasoning from existing principles in Islamic law. It is used as a tool for interpreting and applying Islamic law to new situations that arise.
