- ① Expensive Agreements with APPs
- ② Overwhelming dependency on hydrocarbons
- ③ Failure of transmission and distribution sector.

Open with introduction:

Expensive Agreements:

Expensive Agreements with APPs gave a huge blow to the energy sector. From July 2023 to July 2024, 29 billion were paid to 33 APPs in the context of capacity Payments. Capacity Payments are made to APP just to maintain the capacity in case of increase demand but these Power Plants remain idle and received Payments without Producing electricity. The burden of these Payments was shouldered by Public and it made them come out on streets due to massive hikes in electricity Prices.

Dependency On Hydrocarbons:

Unfortunately Pakistan is dependent on hydrocarbons while the whole world is shifting towards green energy. Pakistan's economy is not an oil based economy and it doesn't have hydrocarbons resources to generate energy so fluctuations in international oil market adds insult to the injury. It is the failure of leadership that Pakistan didn't focus on growing Parallel resources.

Transmission & Distribution Sector:

Lack of Infrastructure, Poor maintenance and deficient investment in this sector results in energy losses. These losses not only increases the electricity Price but also questions the reliability of supply. These losses are increasing instead of decreasing. FY24 these losses increased by 18.31%, up from 16.84% in Previous fiscal year exceeding the average target of 11.77% by 6.54%.

Critical Analysis:

When capacity payments are made in dollars for the electricity from which no one gets benefits, when energy/electricity is produced by using imported coal and oil instead of growing parallel resources, when losses in transmission and distribution sectors are continuously increasing then one cannot expect other outcome, the only outcome is increase electricity prices. It is the failure of leadership that increase the burden on public and made them come out on streets.

Renegotiate Contracts with APPs:

Renegotiating contracts with APPs and only paying them for what they are producing can ease the burden for public or let them produce upto their full capacity and utilize this extra electricity for industrial sector as well as export. If APPs don't want to renegotiate then termination of contracts is available option for remaining APPs.
