There has been an important role of judiciary on grounds of political and government level.

The judicial system of Pakistan had maintained its role and legacy in the history of Pakistan. In the present month

the changes appeared in the amendment mainly focused on role of judiciary. The twenty sixth amendment act 2024 also known as Constitutional package

that takes away Supreme Court's suo moto powers, sets the Chief Justice of Pakistan term at three years and empowers the PM to appoint next CJP of Pakistan among most senior judges.

The main changes in the amendment

Power of Chief Justice

The power of Chief Justice has been made weak through

bringing certain changes into the amendment. The powers of chief justice has been modified by keeping CJ less interfered in the affairs. The chief justice of Pakistan would be aside by taking suo moto actions. The power of suo moto from any entity and the decision of other provinces high courts would be done by the political entities.

The Composition of judicial Commission of Pakistan

The judicial Commission of Pakistan (JCP) nominates judges of Supreme and high Courts. Before 26 Constitutional amendment the JCP comprised majority of judges. However, the amendment changed the composition of JCP and also included two members of national assembly, two members of senate or 9

woman or non muslim. The changes in CJP Composition allow direct interference of political influence, and reduce CJP members to minority

Administrative powers of judicial Commission of Pakistan

The mutual involvement of matters involving interpretation of the Constitution and enforcement of fundamental rights, was to CJP, now this has got political influence making decisions. The amendment also provide that all pending petitions, appeals and reviews that relate matters shall fall under Constitutional bench' be transferred to them.

Rationale behind the amendment

The apparent scerio tells that rationale behind changes were transparency, accountability and balance. The core concern is case management and decision making by keeping

view the transparency to ensure
checks and balance within

Limitation on judicial autonomy

has limited the powers of

He founded educational committees societies and conferences so that people can have open discussions for their issues to talk on. On the other hand,

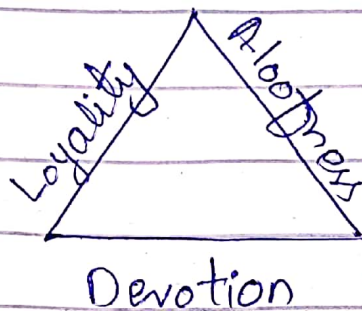
he wrote book to spread knowledge and wisdom among people. These book conveyed
