Factors that are fundamental for their failure. To

start with weak rule of law and democracy are main reasons for failure

of a nation. Similarly, in big nations the resources are divided upon the basis of power and quality of education is not upto the mark. Also, the politics is

just consisting on blame game of political leaders and dynastic politics as well.

Moreover, nations fail due to poor economic conditions and brain drain dilemma.

However, a successful nation needs to promote merit, education and rule of law for becoming a powerful nation. A nation fails

due to multiple factors which are obstructions in development of that nation. However, by working on faults a nation can rise and progress.

Firstly, weak rule of law is the main factor behind a nation's failure.

To begin with, when rule of law is weak in the country then all the people and institutions in the country trying to exceed their limits. As a result, the nation face criticism from local and international level.

Similarly, the people who have power they exploit the people with less power. In this way, the weak segment of the society depressed

For example, the report of U.N 2022, the merit is just a paper word in developing countries. Therefore, due to low merit, people can't become the part of nations progress, and as a result, nation fails.

Also, unequal distribution of resources in the society is main cause of failure of a nation. To start with, all people of country have equal right on the resources, but in third world nation the rule of might is

right is still working. People having social recognition and status can overcome on all the resources. While, the middle class or below middle class people have no right on the resources equally, which creates an inequality in society. This unequal distribution of resources is unlike an ulcer of nations progress. For example, the case study of Earthquake aid distribution in 2005 in Azad Kashmir. Therefore a nation can't proceed by ensuring equal distribution of resources.

In the same way, the blame game by political leaders in many countries

is a main cause for the failure of a nation.

To start with, when leaders start to blame one another then the main focus of the people and leaders shift from progress to conflicts. Also, people starts talking about their representatives rather than focusing to get their rights.

For example, all the third world countries have blame game in their politics. Therefore they are flop as a nation due to blame game.

Also, poor quality of education in many nations is factor of failure. Firstly, a nation can't compete with the international

world due to poor quality of education. Education is the main factor for the development of a nation. Low quality of education creates a communication gap between developed and developing nations. For instance, the literacy rate of US is 99.9% which indicates that education is main priority for developed nations. Therefore, low education is the main reason behind failure of a nation.
