After withdraw of French 1946 from Syria. Country went under influence of extractive institutions which lead to civil unrest, corruption and patronage Network. Due to that inequality and human crises rise and a civil war broke out and many people died and

went into dark ages. Extractive institutions like elite enjoying their status and getting benefit while his neighbour Jordan is doing very well because of Inclusive institutions.

Inclusive institutions lead towards virtuous cycle such as Sir Robert Walpole domestic policy. He empowered the political parties in England. He evolves the Cabinet system which lead to strong inclusive institutions. He introduced the "Let the sleeping dogs lie" policy. He adopted a method where state don't interfere in other institutions. how good governance prevent from failure as we look into Bangalore's participatory model of governance. Bangalore Municipal corporation has 198 wards each with own committee. Ward committee comprise of citizens, councillors, and experts. They allocate budget 10-20% from local projects. They launched online portal and apps for that. Regular meetings also conducted. This good governance method is reason of inclusive institutions.

Botswana Consensus Model emphasizes national unity and cooperation. The government engages with opposition, parties, civil society, and traditional leaders to build consensus on key policies. This approach has fostered stability and economic growth.

Singapore's Rule Law model ensures a fair and justice in society. The city state's strong judicial

system, anti corruption laws, and strict enforcement of regulation have created a stable and attractive business environment.

Western Europe's administration model emphasizes efficiency, effectiveness, and citizen-centric services. Governments have implemented reforms to streamline bureaucracy, enhance transparency, and improve public service delivery.
