ii Gaza being the largest open air prison in the world:

Gaza is called the largest open air prison in the world as the west of Gaza is adjacent to the Mediterranean Sea while Israel's navy is all over there in the Mediterranean Sea. Secondly, east and North Gaza is bordered with Israel. legally there are three crossings along this border but Palestinians can not escape from this border. Thirdly, South of Gaza is bordered with Egypt but there is only one crossing there which is called Rafah crossing. vi Escalation of the war:

More than ~~40,000~~ 40,000 people have killed by the Israeli forces including children, women & journalists and doctors since October 2023. Hamas and Israel war would not end any soon. The non-state actors in Middle East have started attacking Israel. Hezbollah in Lebanon attacks on Israel, Houthi in Yemen attacks on Israel,

Pakistan has been facing multiple serious challenges such as political instability, constitutional crises, terrorism, and economic crises.

One of the serious crises face by the state is energy crisis. Energy crises include electricity loadshedding and mounting electricity bills. The electricity prices hike is due to expensive agreements with Independent Power Producers (IPPs), overwhelming dependency on Hydrocarbons (HCs), line and other losses in transmission and distribution sector. Energy crisis have far reaching repercussions on industry, domestic and other crucial sectors. There is an urgent need of addressing energy crisis and controlling price hike of electricity to reduce the negative effects on economy of the country and to reduce inflation in the country.

There are following reasons of the price hike in electricity bills :-

1. expensive agreements with Independent Power Producers (IPPs):
Independent Power Producers (IPPs) or private sector producers generate electricity primarily from hydrocarbon (HC) sources. These IPPs were established in 1994, 2005, 2011, and 2014, with additional installations made to meet the increasing electricity demand. One of the main reasons for high electricity costs is the capacity payments made to these IPPs. During summer, demand peaks - for instance, in July 2023, electricity demand reached 28,000 MW. In contrast, this demand drops by 50% in winter. However, the agreements with IPPs are based on maximum demand requirements. Furthermore, all payments to IPPs are made in dollars while foreign-owned IPPs must be paid in dollars, local IPPs should ideally be paid in PKR. Payment in dollars to these IPPs is main reason of price hike in electricity bills.

2. Overwhelming dependency on hydrocarbons:
Pakistan generates more than 60% electricity through hydrocarbons. Such as diesel, liquefied natural

Gas (LNG), and coal. Pakistan imports these hydrocarbons in dollars. As Pakistani rupee is devalued against dollar, import of these hydrocarbons is causing huge hike in price of electricity bills. Moreover, the ongoing Russia-Ukraine war has further repercussions on the prices of hydrocarbons due to sanctions on Russia. Pakistan's overwhelming dependency on hydrocarbons is leading it towards energy crisis.

iii Line and other losses in the transmission of electricity:

In Pakistan there is outdated infrastructure for the transmission of electricity. This old and outdated infrastructure causes huge electricity losses during transmission. That is why there is electricity bill hike.

All of those reasons of price hike in electricity bills have far reaching impacts on industry, domestic and other crucial sectors.

i Implications on Industry:

As industries require electricity for their functioning and manufacturing processes, price hike in electricity bills affects negatively these industries, leading to burdening these industries. Small-scale industries often face more challenges to cope up with these type of energy crisis, ultimately leading towards closure of the industries. These closures left many people unemployed. Moreover, production of necessary goods reduce. These goods then need to be imported in dollars. Hence, country reserves of dollars decrease, leading to inflation in the country. That is how price hike in electricity bills has repercussions on economy condition of the country.

ii Effects on Domestic level:

More than 40% of the income of the middle class family has been consuming in payment of electricity bills due to an unprecedented hike in electricity bills. This affects the budget of the

families. To cope up with this challenges, families adopt different strategies. often families are forced to become unable to pay the tuition fees of their children, leading to educational losses. Routine life of families becomes completely disturbed, leading to civil unrest and ultimately protests occur in the country, further hindering the economic activities.

iii Set back for agriculture: More than 30% of the agriculture of Pakistan is based on tube wells and digwells. Majority of these tube wells are powered by electricity. The more the price hike, the more set back for agriculture. The cost of agricultural products rises with the increase in the price of electricity.

In the same way, other crucial sectors of the country face major challenges due to the price hike of electricity. There is an urgent need to solve this issue.

Some of the recommendations to cope up with the price hike in electricity bills are given below:

i. Renegotiation of agreements with IPPs:

The agreements with Independent Power Producers should have been renegotiated long ago, specially those signed in 1986, 1991, 1994, 2002, 2005. Unfortunately, successive governments delayed this process. It was not until 2020 that those agreements were renegotiated, eliminating capacity payment issue and making sure to pay to local IPPs in rupees rather than in dollars.

This renegotiation solved the 40% of the issue. The majority of the IPPs were installed in 2011 and 2014, these can not be renegotiated until 2028. Successive governments should make sure that these agreements are renegotiated well in time.

Install local and cheaper electricity projects:

Governments need to install more and more local and cheaper electricity projects to meet up the electricity demand of the country. In this way, expensive electricity bills can be made cheaper. As payments will be in PKR. Energy policy 2030 already focusing on indigenization of electricity production, which is a good step. Moreover, the government needs to focus on producing electricity from local coal of Thar. The state needs to be less dependent on imported hydrocarbons for electricity generation.

Investment in renewable energy sources:

The government needs to shift its policy for the production of electricity. It needs to invest in renewable sources of energy such as solar power, wind energy, hydropower and geothermal and biomass.

Solar Power is abundant and solar panels can generate significant clean energy. In the same way, harnessing wind power to produce electricity is a step recommended to produce clean energy and to reduce dependency on hydrocarbons. Moreover, hydroelectric power from dams or small-scale hydropower plants can provide a steady energy supply.

iv Updating of transmission lines:
Though it is an expensive phenomenon but the country is in dire need to revamp its transmission lines. Outdated transmission lines are causing huge electricity losses. This is the major issue the country is facing in regard of electricity crisis.

In conclusion, Pakistan is facing challenges due to hike in electricity bills from domestic to industrial life, everybody is affected. These challenges can be resolved by
