Introduction

It has been witnessed through the history that India ^{govt} has always blamed ^{Pakistan} for any insurgent activities. For instance the Pulwama attack of 2019. At the moment, the Indian government has put blame on Pakistan for the sponsoring of the terrorist attack, occurred on 27 April, 2005, resulted in 26 casualties in Pahalgam, Indian-occupied territory in Kashmir. As a result, it has taken severe actions against the state of Pakistan, including the suspension of Indus Water Treaty. This suspension has various impacts on the India, and the People of Pakistan. Therefore Pakistan needs to take measures to tackle the foreseeable issue.

India's baseless Action.

The government of India, has blatantly held the Pakistan responsible for the terrorist attack and has claimed the government of Pakistan, being involved in

the cross-border terrorism. Moreover, it has downgraded the diplomatic ties by summoning Indian High Commission in Pakistan, closing the Attari Border, reducing the number of diplomats to 30, and lastly, by ~~unilaterally~~ suspending the Indus Water Treaty in abeyance. Their government has taken these ~~actions~~ without any provision of evidence, threatening the existence and survival of people of Pakistan.

Pakistan's Retaliatory Response.

The government of Pakistan has condemned the attack. However, denied its any sort of involvement in the terrorist act. Additionally in response to the severe actions taken by the government of India, Pakistan has retaliated by the ~~closing~~^{ending} of bilateral trade agreement (Simla Agreement, 1972). It has closed the Wagah border, summoned the Pakistan High Commission. In response to the suspension of IWT, the Pakistani government has responded by declaring it as the "act of war".
