In 1948, Israel was created after the end of British rule in Palestine. This led to the first Arab-Israeli War, and many Palestinians were displaced. After the Six-day War, Israel occupied the West Bank, Gaza Strip and East Jerusalem. The Conflict has caused many wars, military operations, and uprisings, with thousands of civilian deaths. The most recent one was the attack on Oct 7, 2024 by Hamas (armed group in Gaza) on Israel, leading the situation towards committing more war crimes by both sides.

Is war crimes go against the International laws, especially the Geneva Conventions, whose purpose is to protect the individuals who are not fighting during an armed conflict. Similarly, International Justice refers to the pursuit of justice for crimes and violation of law, often involving accountability for serious offenses of genocide, war crimes, crime against humanity.~~

~~In 2021, the international criminal court officially opened an investigation into war crimes in the occupied Palestinian territories. Israel did not recognize the ICC authority, and refused to cooperate. Therefore, International justice cannot be achieved without cooperation from either side. Israel bombing the civilians and not showing the ICC a green signal for cooperation is a threat to international justice.~~

~~Political biasedness is another reason which prove that war crimes in Palestine-Israel conflict is a challenge to international justice. Majority of the big powers always sided with Israel on its atrocities against the Palestinians. When a resolution for a cease fire in the Gaza war was moved, U.S vetoed it by not supporting it. So this political biasedness also curtail the international justice.~~
