When more and more people get justice through legal system, it strengthens the masses' trust in public institutions. This trust is essential for a functioning democracy. Crime deterrence is the ability to swiftly end the crime at its root. One of the primary goals of justice system are to ensure that criminal behaviour is swiftly and fairly punished. Effective policing sends a clear message that unlawful acts will not go unpunished. If the steps are followed sequentially, they can help deter crimes. In Pakistan, crime rates in major cities like Lahore and Peshawar have risen by over 200% in recent years. The percentage represents a serious gap in the system.

Police plays a vital role in creating a safe and secure environment for individuals and businesses to thrive and prosper. Courts are responsible for settling residential and trade disputes. with settlements on time, foreign investments start coming in leading to economic cooperation. Safe and peaceful environment in countries attracts other countries to develop friendly ties, sign agreements for trade and cooperation boosting countries' GDP.

This inefficiency is further worsened by moral and ethical decay of Police. Unfortunately, bribery, corruption and similar social evils are prevalent in Police. Influence from powerful groups and misuse of authority is also fairly common. This leads to distorted evidence, and intentionally slow investigations. Kasaz traffic accident in Karachi, Pakistan and brutal murder of Noor Mukadam in Islamabad, Pakistan are prominent examples where the influential were able to delay and distort investigations.
