## Russia-Ukraine war:

Ukraine being a former territory of Russia is now on 1269 days long war with it. Russia being a vast empire as compared Ukraine has successfully occupied **20%** of Ukraine through Crimean peninsula. It aims to occupy more but the NATO military with advanced weapons is resisting Russia. Despite mass migration and casualties the war is still continued.

## Historic Alaska Summit 2025:

U.S president Mr. Donald Trump who claims to be a competitive contender for noble peace prize announced a historic meeting with former rival Russia. The meeting was held between the presidents of two global powers on 15th August 2025 in Alaska under high security. The meeting aimed to discuss an end to 3-years long Russia-Ukraine war for regional peace. Rather to discuss the war, the meeting looked more trade centric and about mutual interest.

In the end Russian president Mr. Putin summarized the meeting as mentioning that Russia and U.S. share a history and in the light of current dynamics there is still room for cooperation. There was not a single word about war. It seemed that meeting ended on **zero-sum gain** for U.S. and Russia respectively.

### Russia's stance on war:

The only conditionality that continuously appears from Russian side about war is **removal of NATO forces from Russia-Ukraine border.**

Without NATO, Ukraine has no trained army and no advanced weapons against Russia. Mr. Zelensky is afraid of Russia's power and military and does not want to give up on his territory in Ukraine. While Russia exhibits claims on Ukrainian territory as it was a part of Soviet union. This continuous rift and no mutual interest are prolonging the war even after 3 years.

## In a nutshell:

In the historical context, Russia-Ukraine war is just the exhibition of power by Russia. After the division of USSR when Russia lost cold war from U.S., it worked on its defense and military. So after the years, when Russia started a war with Ukraine and captured, it was a practice to declare that **Russia is back** in balance of power against U.S. To exercise this war, Russia just want to break the narrative of **U.S - the only hegemon**. However, this time, the dynamics of war has been shifted towards non-traditional.

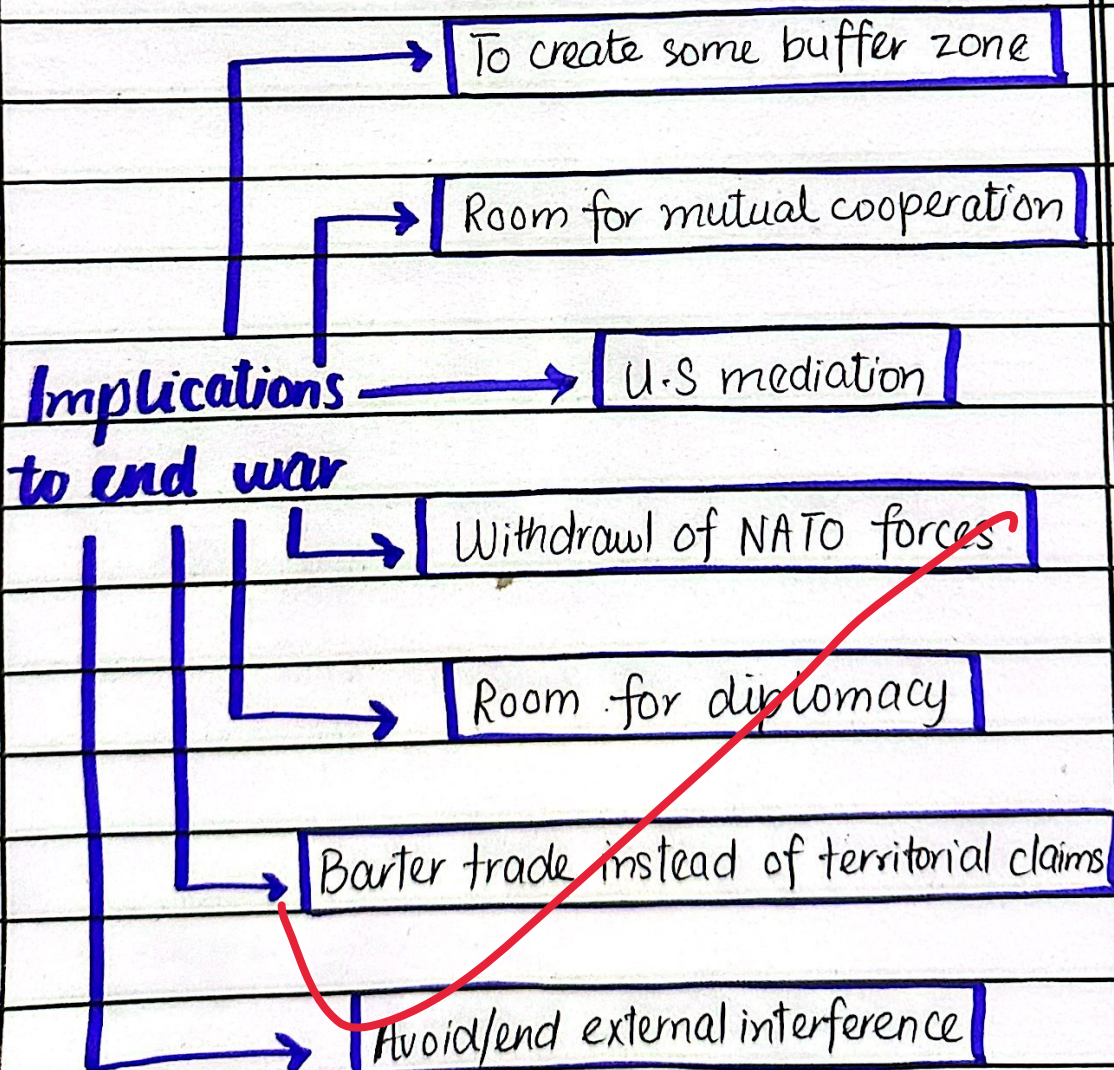

## Future of nuclear politics in middle East post U.S.-Israel attack on Iran?

### Introduction:

In the light of recent US-Israel attack on Iranian nuclear sites in Natanz, Asfahan and Fordow portrays that for now bubbles have been settled down as U.S claims to completely destroyed the nukes of Iran. A neutral reaction from Iran paints a picture of temporary peace in the region but soon Iran will bounce back with its nukes in middle east. Because according to Iran, it has its nukes still intact.

### Pre-emptive strike by Israel:

When a genocide was not enough to attract global attention, on June 13, 2025 violating article 2(4) of UN charter Israel launched pre-emptive strikes on Iran killing its key military officials and nuclear scientist. The attack was launched from

Iranian soil. Later on, Israel came up with clarification that Israel had a threat of nuclear attack from Iran as Iran has successfully enriched its uranium by 60%. It was an unlawful pre-emptive strike.

### Operation Sadiq-III:

Iran launched operation Sadiq-III in light of article 51 of UN charter which allows a state to retaliate in self defense. Despite the defense system like iron dome, Israel failed to intercept Iranian missile. In retaliation, Iranian missile spread destruction in Tel Aviv.

### B-2 bombers:

In this exchange of missiles and drones b/w Iran and Israel, U.S officially stepped in the war and launched B-2 bombers (that have capacity to destroy upto 60km under earth) on Iran. These bombers were launched on 3-key nuclear sites of Iran in Fordow, Natanz and Arak. Later on this attack was confirmed by President Trump in a tweet on X.

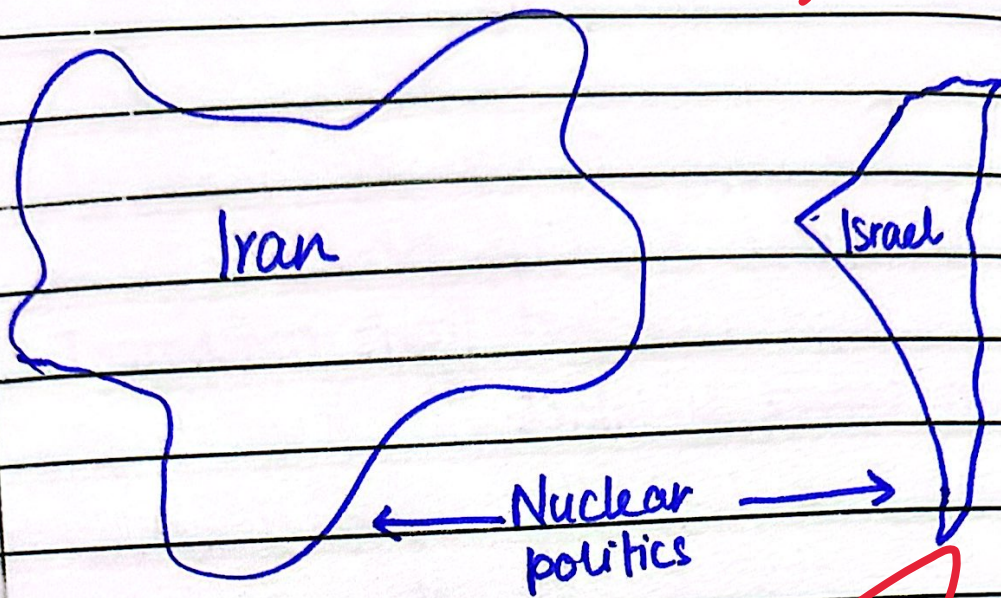
## Post-war dynamics:

As U.S president announced that he destroyed uranium enrichment plants of Iran. Iran president Imam Khomeini in a public appearance after war declared that **Iran's enrichment plants are secure & intact**. The IAEA officials also confirmed that there was no sign of nuclear leakage. It might be possible that Iran had shifted his missiles before the attack.

## Current situation in middle east:

Days after the war now Iran has resumed the oil trade. The Iran is still standing on his stance that he will not give up on his nukes. The IAEA expert says that Iran can rebuild its nukes in less than two years but as for now the bubbles of nuclear power in Iran has been settle down.

In the light of the above discussion and US-Israel attack on Iran, the future of nuclear politics is quite evident in middle east now. To maintain its territorial integrity and to protect its sovereignty against global hegemony Iran will ~~ret~~ reattain its nukes in near future. 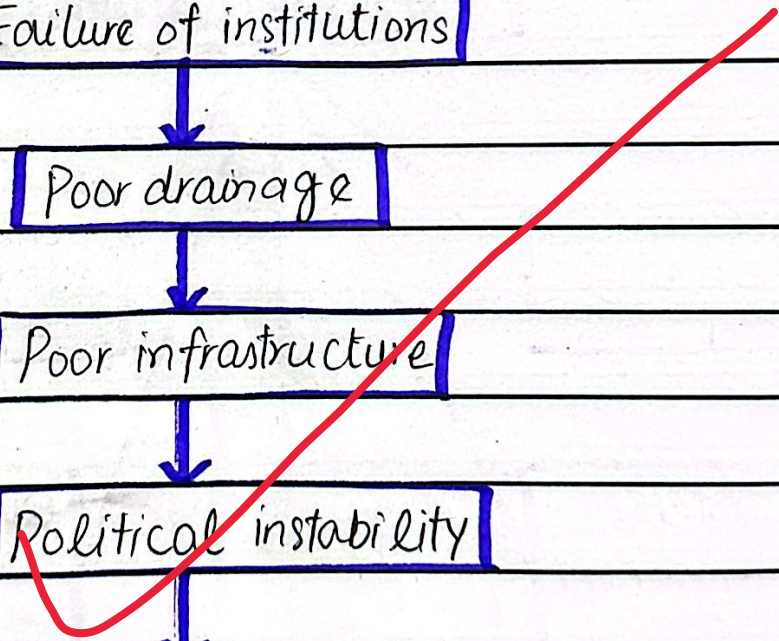

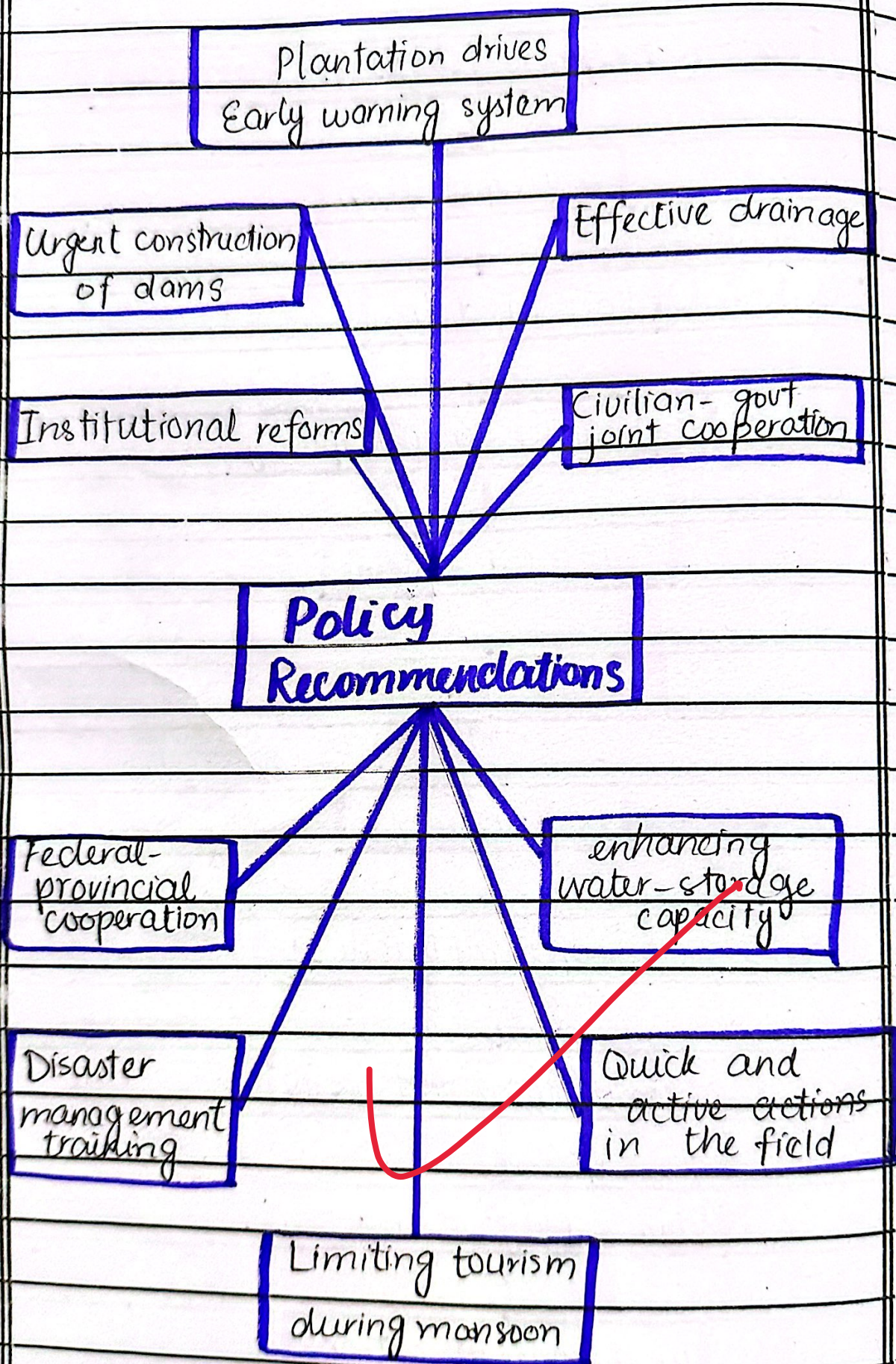
