2- Sanction issue:-

Russia is heavily sanctioned yet its economy is thriving. USA has concerns about what will happen if Russian economy is allowed to grow.

3- Cult of personalities:-

Putin, Trump and Zelenski all three have a cult of personality which is based on state based propaganda to show more victories. The problem is accepting loss is not possible if political careers are at stake, which is case for Zelenski.

4- Security assurance or guarantee? :-

Ukraine was given security assurance by both USA and Russia but Ukraine needs security guarantee. The best way to do that is NATO but Russia cannot afford that hence the negotiations turn into zero sum gain.

1- Demilitarized zone:-

In South Asia water has been weaponized. After India suspended IWT and China started construction of Brahmaputra river dam. This rise in water politics coupled by environmental degradation has resulted in water security dilemma for Pakistan as well as India. This can turn into an armed conflict.

Pakistan's dilemma:-

John Lilinthan once famously wrote that India can "destroy" Pakistan if they were to "divert" water flowing into Pakistan. This makes a water issue a matter of existence for Pakistan. Similarly Pakistan's economy, culture are entirely dependent on these rivers. The COAS of Pakistan was reportedly quoted say that Pakistan will destroy any dam that India builds on western rivers.

Indian dilemma:-

India is caught between a rock and a hard place. If they block water flowing into Pakistan and violates IWT. China can have a precedent to stop flow of Brahmaputra river. Just so, India logically cannot set precedent of weaponized water.

Even though only 30% of Indian population will suffer directly. In a country of 1.5 billion that is 90% of lost lives.

China has not signed any formal treaty about rivers with India so unless China signs a treaty India and Bangladesh are at stake.

Bangladesh's Dilemma

The Bangladesh is an agricultural economy which is sustained by rivers flowing from China to India than to Bangladesh. A fight on water will leave Bangladesh extremely vulnerable to environmental problems.
