US' check and balance system

1- Introduction

US' check and balance system is one of the best in the world where executive, legislation and judiciary keep each other in check on the principles of Montesquieu.

It is effective in a sense that it prevents from tyranny of any organ containing a lot of power and ensures stability. There are many lessons for Pakistan in this system.

2- Analyzing the checks and balances in the US constitution

US constitution has described the powers of the three organs of government.

based on the theory of Montesquieu. Based on this theory all the organs function on the basis of non-interfering principles.

2.1- Congress' powers to check the ^{president}

Following are Congress' powers.

2.1.1- Power of the purse.

Congress has the constitutional authority to control government spending and revenue. It ensures that no government spending is done without legislative approval.

In ~~2.1.2~~ this system, the philosopher king / president has to convince the philosophers' council or legislative body for approval of funds.

2.1.2- Impeachment of the president

Congress can impeach the president if it does not its abilities. It is similar to Lockean social contract where the ruler

can be removed if found unable to perform

2.1.3 - Senate power of treaties and appointments

Senate has the power to sign treaties and appointing judges. However, this power is also exercised by the executive or the president. Therefore, both keep each other in check.

2.1.4 - War-declaring authority

This authority is primarily exercised by the president. However, unless the congress approves it, cannot be declared. Here, the system reflects Rousseau's General will for approval.

2.2 - Powers of the executive

The Executive has the following powers under the US constitution.

2.2.1 - Veto power

The president can veto the Congress' financial and policies

and treaties proposed. Philosopher King/ president has the authority to counter general will for the larger national interests.

2.2.2 - Executive orders

The president can declare wars and call for treaties but it needs approval of the senate. Therefore both legislation and the executive rely on each other for the smooth functioning of the political system.

2.2.3 - Appointments of the cabinet and judges

The president of USA can appoint cabinet members on the arbitrary basis. However, for the appointment of judges, it needs approval of the congress.

2.2.4 - Calls special session

The president can call special sessions on different ^{national} issues and the house has to respond

to it.

2.3- Judicial power

2.3.1- Judicial review

The judiciary has the special power of judicial review on the constitutional matters. The famous Marbury vs Madison case is the best example of judicial review which wrote off the history of USA.

2.3.2- Strike down the unconstitutional legislation and executive orders

Any legislation or executive orders that hinders the rights of life, liberty and pursuit of happiness can be struck down by the judiciary.

3- Effectiveness of checks and balances in the US constitution

→ This system of checks and balances is effective in the following ways.

3.1- Prevention of absolute power.

It prevents all organs from gaining absolute power which prevents tyranny. As Lord Acton said,

"Power corrupts and absolute power corrupts absolutely."

3.2- Protection of civil liberties

These checks and balances protect civil liberties. This ensures Lockean right to life, liberty and property. In US, it is pursuit of happiness.

3.3- Continuity and stability

This automatic checks keep every organ function properly. Therefore, the political system continues stably with despite the issues. The American constitution has successfully endured the civil war and war of independence.

3.4- Accountability through investigative bodies

The American constitution encourages investigation from sovereign bodies in case if one of the organ tries to override. The famous Watergate scandal is the best example.

3.5- Weaknesses of the separation of power based system

This system's ~~can~~ checks and balances often lead to gridlock among legislation and the executive. Judicial activism for personal benefits can also be another weakness of it. Further, this system can create serious political polarization in the country.

4- Lessons for Pakistan through the separation of power model

Following can be lessons for Pakistan for pursuing this

model.

4.1- True autonomy of each branch

Separation of power model can offer Pakistan a balanced approach towards governance. It can lessen executive overreach by empowering legislation to balance their powers.

4.2- Ending institutional encroachments

Civil and military bureaucracies often frequently influence political process. The US system can be a good way to prevent them from overreaching.

4.3- Judicial independence

Pakistan's judiciary often oscillates between activism and compromises. A balanced political system can ensure an independent judiciary safe from executive influence and military's coercive powers.

2.4) Ceasefire and peace dialogues

Pakistan struck Afghanistan hard to show its strength, however, it also showed its

peaceful intentions to cease fire and dialogue. Because as Machiavelli suggests that peace with neighbours should always be the primary goals of the state. Therefore, Pakistan accepted the peace proposals by Qatar and Türkiye.

2.5) Psychological response to Indo-Afghan nexus

India's long-term strategy to encircle Pakistan from two-fronts has been a dream which they showed by inviting Taliban's foreign minister. Pakistan's hitting Afghanistan was a message to both countries. It was a Bismarckian realist approach towards enemies.

2.6) Ensuring peaceful life for its citizens

Pakistan's response was a clear message that it

can fulfill its responsibility to ensure lockean rights to life, liberty and property.

3) Effectiveness of Pakistan's Afghanistan policies

3.1) Establish a deterrence against Taliban

Pakistan set a strong deterrence against Taliban. This response was enough to instill fear in Taliban's hearts.

It was also conveyed message to India not to play with fire.

3.2) Perfect use of kinetic and non-kinetic actions against terrorism

the state must encourage productive excellence for collective growth.

3.4) Energy sector reforms

Energy cost in Pakistan is too high that industrial set-up here seems irrational. Therefore, the government needs to manage the energy prices ~~for~~ to encourage productivity.
