The current economic situation of Pakistan is falling apart. It was assumed in 2023 that Pakistan will default, though it has not defaulted, the economy is crippled to a great extent.

Pakistan is facing numerous economic challenges.

Inflation is one of the major challenges that Pakistan is facing right now. Due to unemployment and increased prices of products, people are hardly managing to meet both ends. The excessive amounts of tax and increased prices of food, medicines and goods have caused economic disrupt. Poverty rate has increased and unemployment rate is 6.3% to 7.1% according to some reports by Dawn and The Express Tribune.

Pakistan's **fiscal deficit** for year (FY 2024) narrowed to 6.8% of GDP in the fiscal year (2023-2024), down from 7.7% of GDP in the previous year. Pakistan's fiscal gap widened to Rs 7.21 Trillion rupees compared to Rs 6.53 Trillion last year.

According to recent stats, Pakistan's budget deficit was recorded at Rs 6.17 Trillion approximately 5.4% of the GDP, during the fiscal year 2024-25. This marks a 9-year low in history.

For year 2026, the IMF expects the fiscal deficit to clock in at 4.41% of GDP, the lowest in two decades.

The total external debt is \$129.718 billion in 2024 with long-term external debt amounting to \$107.88 billion. However, 40% of export earnings go towards debt servicing, a significant burden on the country's economy.

IMF has approved a \$1.2 billion loan to Pakistan, the country received about \$3.3 billion since last year under the IMF bailout. Pakistan needs to repay \$100 billion in foreign debt within the next four years, with \$18 billion due in the current financial year.

Critically assess the 26th and 27th amendments in Pakistan in the context of military dominations and erosion of judicial norms. How have these amendments affected governance, institutional autonomy and balance of powers?

The 26th and 27th amendments to Pakistan's Constitution have significantly altered the country's governance structure, leading to concerns about military domination and erosion of judicial norms.

'Absolute power corrupts absolutely'

- The 23rd amendment creates a new court that will have exclusive jurisdiction over constitutional matters, potentially undermining the supreme court's authority.
- The amendments grant the executive significant influence over judicial appointments, with the President appointing the Chief Justice of the ECC on the advice of Prime Minister.
- The amendments codify the army chief's dominance by creating the position of Chief of Defence Forces which will be held by the army chief and it has bestowed many privileges to the military of Pakistan.
- The amendment provides lifetime immunity to the President and top military officials. It has resulted in the shift of balance of power in the favour of executive and military, eroded judicial independence, centralized power, weakening of check and balance, impact on institutional autonomy.

These are some of the significant implications for Pakistan's governance, institutional autonomy and balance of power and it has further raised concern about country's democratic future.
