### Introduction

Awaz movement was socio-educational movement started in the aftermath of 1857 war of Independence. In the aftermath of 1857 was, Muslims suffered due to their educational backwardness and their reluctance to adopt western education system. In this backdrop, Sir Syed Ahmad Khan started this movement. Its purpose was the educational <sup>upliftment</sup> of Muslims. However, the political deprivation of Muslims after the growing prejudices of Congress <sup>converted</sup> it into a platform for Muslims to achieve their political objective. It nurtured Muslim leadership that played a key role in the reinforcing of Muslim nationalism in subcontinent.

### Background

After the war of Independence 1857, British blamed Muslims

It was founded under the leadership of Sir Syed Ahmad Khan. It used to hold its annual session. Many intellectual leaders like Nagas Muhsin ul Mulk, Nawab Salim Ullah Khan gave addresses in its annual sessions to raise awareness among Muslims about diverse topics. How Aligarh movement with

Liakat Ali Khan, Nawab Salim Ullah Khan, Nawab Inayat ul Mulk and Mohsin ul Mulk, and Maulana Muhammad Ali Jauhar were the graduates of Aligarh university. These all lead Muslims in the political arena to achieve political objectives of Muslims.

2. Founding of All-India Muslim League in the annual session of All-India Muhammadan Education Conference. Under the leadership of Nawab Salim Ullah Khan, All-India Muslim League was founded. All-India Muslim League spearheaded the movement for an independent country for Muslims.

3. Securing Separate Electorates for Muslims Graduates of Aligarh

### Impacts of the Movement on Muslim Nationalism

#### 1. Political Consciousness

The movement raised political consciousness among Muslims in the annual sessions of Muhammadan Educational Conference as various issues including political deprivation were discussed.

#### 2. Separate Muslim Identity

For provision of separate electorate for Muslims in the Minto-Morley reform of 1909, separate Muslim identity was reinforced.

#### 4. Reinforcing of Two Nation Theory

It reinforced the Two-Nation Theory. In the annual session of All-India Muslim League, Allama Iqbal gave the two Nation theory that Muslims and Hindus are two separate nations because of their differences in religion, culture and social values.

#### 5. Lahore Resolution

Lahore Resolution was passed in 1940 in the annual session of All-India Muslim League that demanded a separate homeland for Muslims of the Subcontinent.

does not go beyond 5%. During the war on Terror, it was the largest recipient of foreign aid. However, its leaders did not utilize the given amount in introducing structural reform in the economy. Therefore, Pakistan is trapped in the boom and bust cycle. Mubeen Lodhi in her book "Pakistan's search for stability" argues that when inflow of dollars in the form of grants and aid increases, its productivity increases and results in a boom. When this inflow of dollars depletes, then a bust is resulted in which economic productivity declines. Furthermore, Pakistan is abundant in natural resources. However, there is no efficient utilization of resources to make the country self-sufficient. How political will of leaders lead countries toward economic prosperity.

1. Introduction of structural reform.



Structural Reforms include.

- Taxation reforms
- Industrialization policy
- Import-substituting policy

These structural reforms are introduced when leaders have the will to bring changes to the economy.

In Pakistan, there is no political will to introduce them. Therefore, according to Economic Survey of Pakistan 2024-2025, tax-to-GDP ratio is only 10%. Moreover, according to the same survey imports are \$48.6 billion while exports are \$28.3 billion. These figures substantiate the fact that it is not grants but political will that leads countries toward long-term prosperity.

- Initiation of legal Reforms
- Legal reforms are initiated due to political will. Legal reforms introduce such provision that ensure speedy justice to the aggrieved party.

Policy discontinuity injects a sense of insecurity in investors. They deem that frequent changes of policies
