Only, From 1951- to 1957, nine prime ministers had got changed due to political instability. This lead to four military coups subsequently. Civilian rules, which are supposed to be the guardian of democracy, have been weakened and frequently substituted by military rulers. The constitution of 1973 was a big win for democracy of Pakistan but that too was marred by dictators by introducing amendments such as 8th and 17th amendments. Nonetheless, 18th amendment became a ray of hope and civilian rule got reinstated. Unfortunately, hybrid regime in 2018 and 2024 again reinvigorated democratic unrest in the country.

From the early years of the country, democracy had been paralysed by the irresponsible behaviour of Governor General Chaudhri Muhammad Ali Jinnah who dissolved the constitutional assembly, and removed civilian government. Along with this, Feudal system and Tribalism are the other important causes of democratic unrest in Pakistan. For instance, Pakistan has four provinces and numerous ethnicities. It is a common norm here that people vote after their nationality. They do not prefer democracy. One can witness this from increasing provincialism in Pakistan. Political parties usually quarrel with centre for the provinces' ~~interest~~ ^{interest}, in order to secure their vote banks back in provinces. Not only tribalism but feudalism is also a major

cause of democratic unrest in the country. The politics have been granted to feudal lords like an inheritance. No common person can be a politician in Pakistan. The system is made as such in the country. So, one can say, feudalism along with tribalism are causes of lack of democratic values in Pakistan.

Judicial Activism can be another major ^{cause} of democratic unrest in Pakistan. From the very beginning to the contemporary political landscape, judiciary has become a constant bone of contention in democracy of Pakistan. For example, from Muhammad Ali Jinnah then prime minister in 1954 to Benazir Bhutto and from prime minister Imran Khan to Mian Nawaz Sharif each and every democratically elected ruler got removed or justified by the judiciary to be removed from the office.

Thus, almost all the democratic governments impacted due to unconstitutional behaviour of judiciary in Pakistan.

Last but not least, lack of literate masses and most importantly social media are the real reasons of democratic unrest in Pakistan. The people do not know about their importance. Similarly, the rise of social media and its use by unaware masses have severely impacted the entire landscape of democracy in Pakistan. Cult following and hero worship increased. Culture of abusive language and intolerance increased by many fold. Decent politics and difference of opinion have lost. In short, the illiterate masses and increasing unbridled social media pose a big threat to democracy ~~unrest~~ of the country.

According to recent survey of International Labour Organization (ILO) unemployment rate in Pakistan is 7.1%, which a huge one. Corruption increases due to political and democratic unrest. the recent IMF's diagnostic report about Pakistan reveals that 6.5% of GDP go into ^{corrupt} practices in Pakistan. Therefore, democratic unrest has a huge cost on Pakistan.

Moreover, ~~over~~ frequent changes in democratic governments and the hybrid regimes leads to lack of accountability, and inefficient Public Service delivery. Developments embargement and

nepotism prevail. The meritocracy becomes a hollow dream. The officials become the king, the public and ordinary citizens suffer. This is all because of undemocratic trends in the country.

In addition, policies with regional countries such as Afghanistan weakens due to democratic unrest at home. For instance, today there are two political thoughts in Pakistan one that is last government of Imran Khan favoured the dialogue with Taliban; However, the incumbent government is having an opposite thinking. They want ~~elimination~~ ^{elimination} of Tehrik-e-Taliban Pakistan (TTP)'s unconditional surrender or war even at the cost of Pak-Afghan relations. This is just an example that how democratic thinking effect the regional relation of Pakistan.

Last but not least, living standards of people, literacy rate, health and overall HDI index only improves, once a true democratic system got installed in the country. Today, HDI score of Pakistan is low as compared to its regional peers. Similarly, literacy rate of the country is almost stagnant at 60% for last many years. In the same fashion, the health, public infrastructure, roads and schools, etc are in deteriorating conditions because the governments are busy to adjust themselves in the system. They do not focus aforementioned public services. In short, once true democracy culture nourished in the country, then the governments will and could work for the peace, progress and prosperity of the nation and country.
