"Small number of People holding large number of resources"

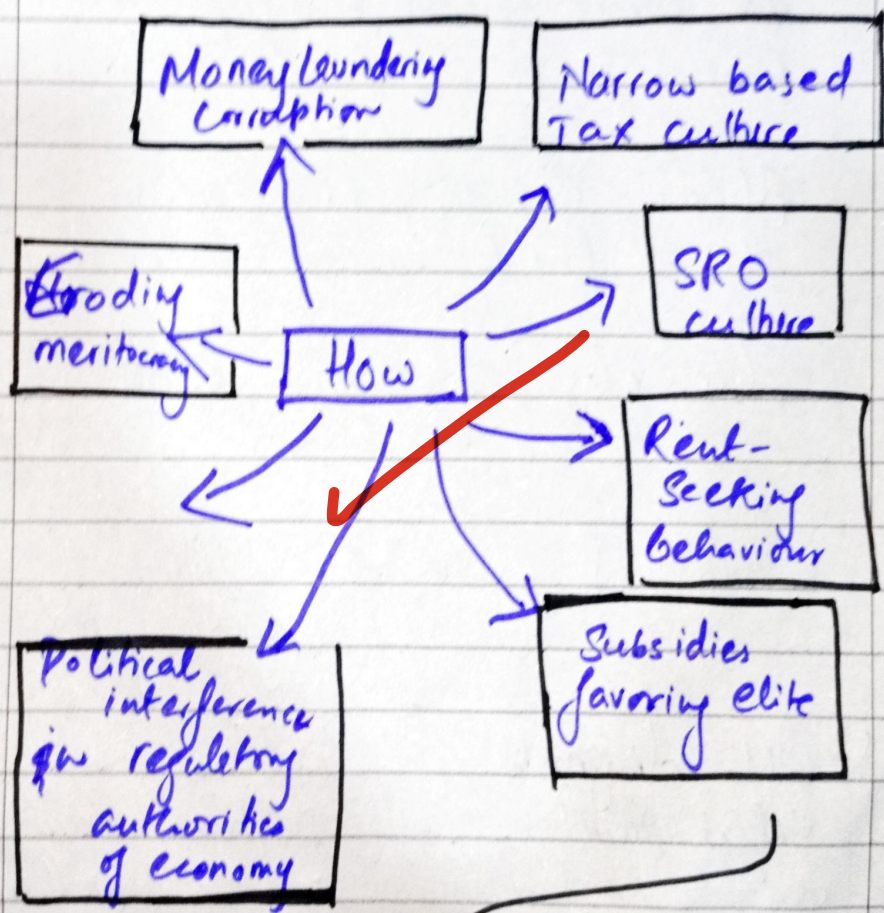
"Few people hold major portion of land or economic benefits"

- 1) Elite Capture — Tax evasion, Tax avoidance and SRO culture leads to economic failures or stagnation.

The elite in Pakistan face no strong accountability. They evade or avoid tax.

80% of the jobs in industries are based on favoritism of elites. Meritocracy has eroded in Pakistan — IMF Report.

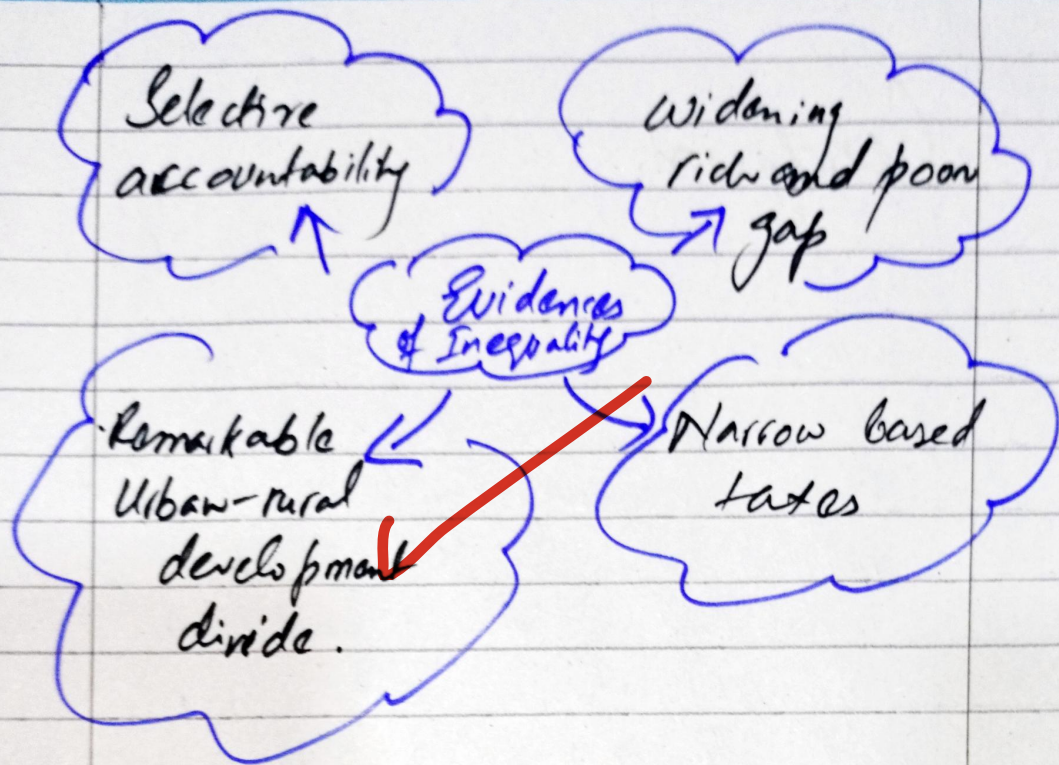
Elite Capture in Pakistan favours the people that benefit them. They gain benefits by destroying merits and talents. Ultimately, this gives birth to inequality in nation.

3- Subsidies favoring rich and loose hand on money laundering and corruption are all evidence of elite capture which is hindering economic development.

"50 Billion of subsidies given by Pakistan has favored the large agriculture owners. It has never favored the small farmers" - IMF Report 2025

Different language, living and practices made muslims have ideology of Muslim nation which gave birth to Two nation theory in Indian sub continent. and, ultimately, Pakistan. The discrimination and conflicted ideas with Hindus made Muslims realize the concept of two nation theory. For 1937 rule of congress consolidated the idea irrevocably. This ultimately led to formation of Pakistan.

Ideology of Pakistan.

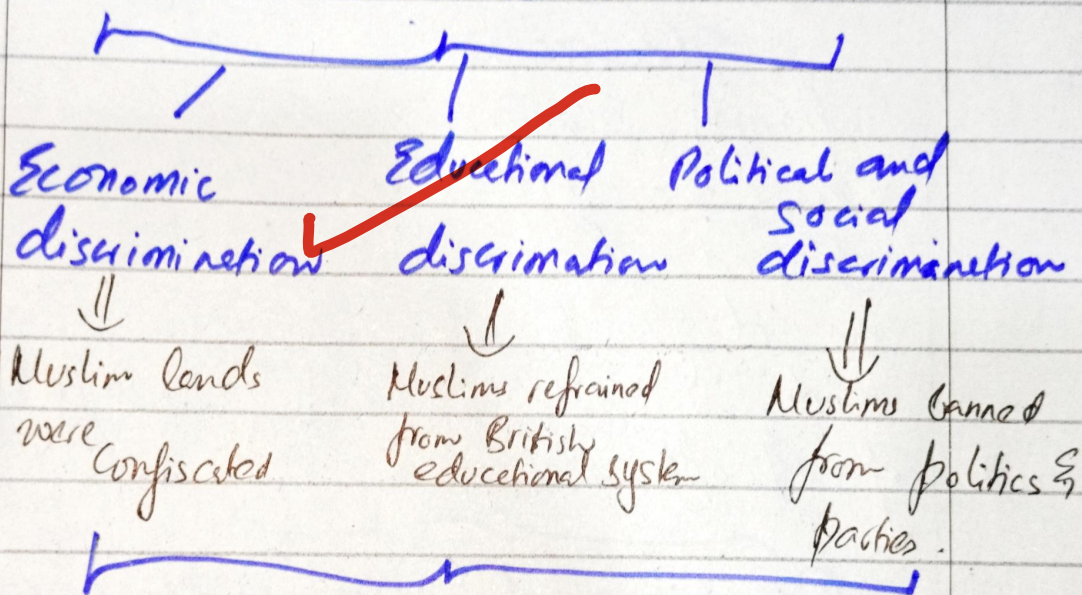
Pakistan came into existence on the religion, cultural and civilization bases. The main reason for Pakistan's existence was its ~~Ideology~~ which incorporated the ~~idea~~ of Islam and Islamic ~~livings~~. The Islamic civilization and culture made Muslims suffer with Hindu ideology. This conflict gave the idea of Two nation. Hence, ~~Pakistan~~^{Muslim} demanded the separate nation for its peaceful living.

Separate Electrates concept was the one that fully secured the idea of Muslims as different identity from Hindus in the heart of majority of people.

Provision of separate electates in 1909 Morley Minto reforms Consolidated the idea of Two-nation.

"Muslims and Hindus are distinct identities with distinct civilizations" — Said by Morley.

- o 1930 - Allama Iqbal address at Lahore made highlights. as Iqbal said:

"Muslim and Hindus can never be a single nation"

"Muslims and Hindus can never live under one rule, they need two nations"

"Muslims culture, language and livings have always conflicted the Hindus living standards. They are different and need different nations"

Iqbal clearly asked for two nations in his speech.

Later, Chaudry Rehmat Ali in 1933 published pamphlet "Now or Never"

gave a name Pakistan for Muslim Nation.

- 1839 - Resign of Ministries and Day of Deliverance

Muslims relieved from Hindus rule — it was celebrated.

- 1946 — Elections and Direct Action day was final stroke

Quaid-Azam said:

"No one can stop Muslims from having separate identity"

Muslim League won majority of seats and demanded separate land.

- 1947 — 14 Aug → Two Nation Theory was practically implemented.
