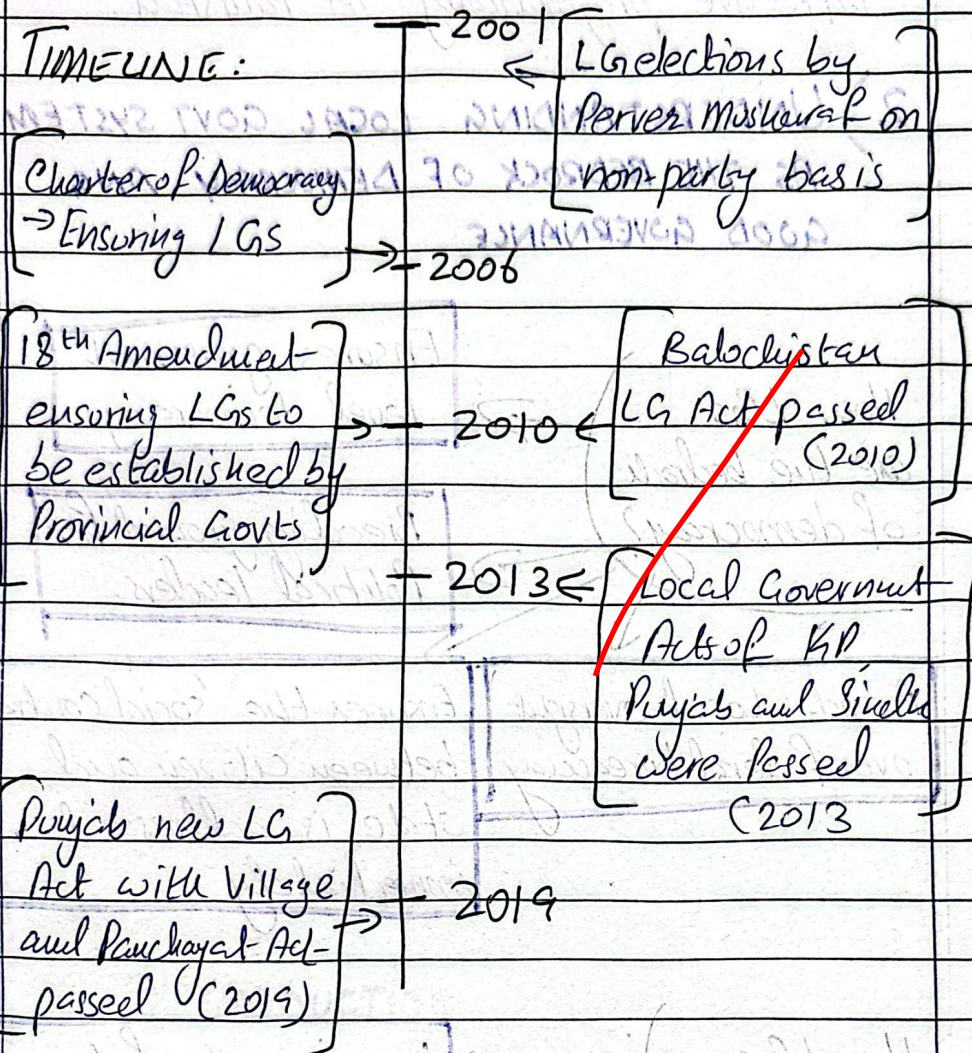

4) PERFORMANCE, SUCCESS AND FAILURES OF LOCAL GOVT SYSTEM IN PAKISTAN SINCE 2001

4.1) Failures of LGs

(i) No Actual devolvement of power. Provincial government dominates LGs

(ii) Financial autonomy is not given to LGs by provincial governments. This lead to inefficiencies in public delivery.

Example: Domination of provincial bureaucracy in Provincial Finance Commission.

(iii) Pakistan's local government system is based on 'de-concentration' model. This lead to few subjects devolved by the provincial government.

(iv) The provincial governments often violate article 140A of LG Act. Local government elections are often delayed.

(v) Chief officer of the local govt is from provincial bureaucracy.

(vi) Musharraf conducted LG elections on non-party basis; This weakened the democratic growth.

4.2) Success

- (i), All provinces passed their respective Local provincial government acts.
- (ii) 18th Amendment made provincial governments responsible to conduct elections within 120 days of expiry of an LG.
- (iii) The successes were mostly legal. This started the evolution of LGs in Pakistan.

5) CRITICAL ANALYSIS

Local government system is indispensable for heterogeneous societies like Pakistan. At present the LG system is weak; and Moreover, its practical implementation remains at the disposal of provincial governments. Basically, the LG system is in embryo period in Pakistan; it needs democratic evolution through time. However, Kerala model in India can be followed to achieve rapid progress.

REFORMS AND RESTRUCTURING REQUIRED IN CIVIL BUREAUCRACY OF PAKISTAN

(i) According to Rational Choice Theory, the tasks of the civil bureaucracy should be aligned with appropriate incentives; this will incentivize effective and efficient work by bureaucracy through cost-benefit analysis.

(ii) According to John Stuart Mill, there should be a strict political oversight over civil bureaucracy to avoid despotism.

1.1) MERITS

(i) It leads to the laissez-faire model of free economy which is helpful in connecting to global market.

1.2) DEMERITS

1) PRESIDENTIAL VERSUS PARLIAMENTARY FORM OF GOVERNMENT IN PAKISTAN

1.1) Parliamentary form of government.

It is a form of government where parliament (upper house and the lower house) is the supreme institution. The Chief Executive of government is elected indirectly through parliament.

Examples:

→ At present Pakistan's system is based on parliamentary form of govt including National assembly (lower house) and Senate (upper house). ~~These~~

1.2) Presidential Form of government

It is a form of government where the President (Chief executive) is elected directly through elections and heads the executive branch of the government.

Example:

→ In Pakistan, the era of Ayub Khan, Yahya Khan & Pervez Musharraf depicts presidential form of government where president is the head of executive branch.

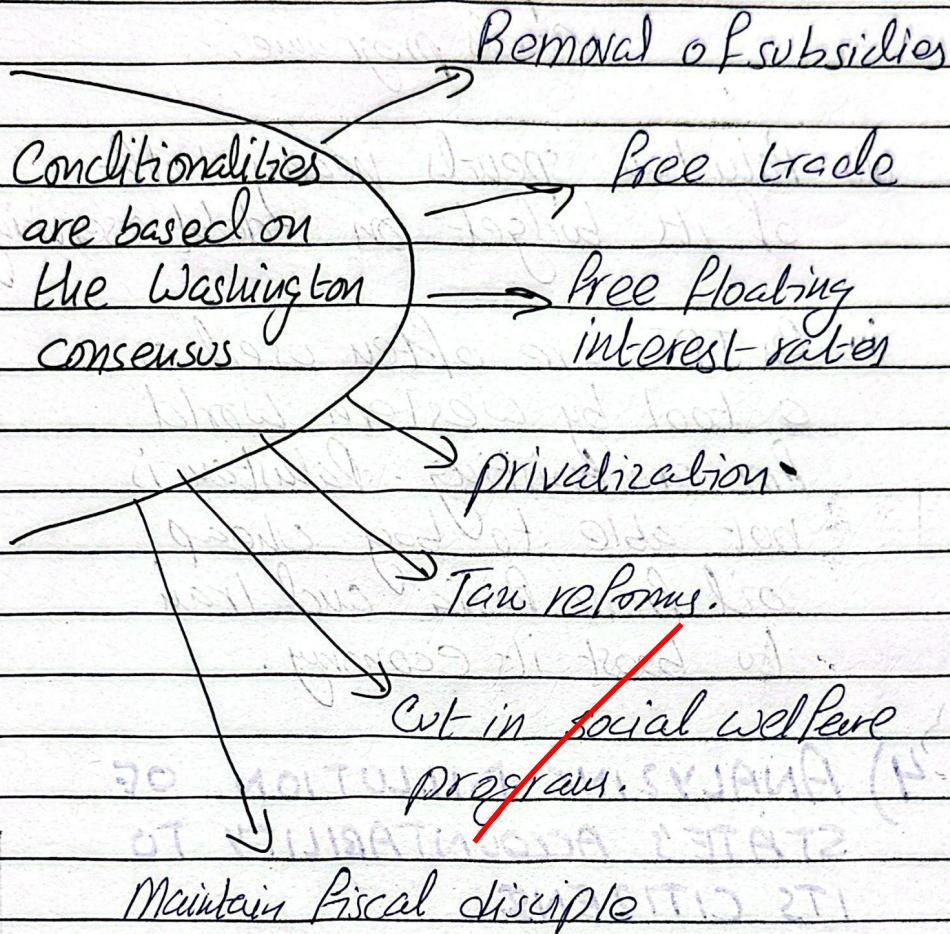

The growing reliance of Pakistan on International Financial Institutions (IFI) is visible in recent IMF bailout package. IFI's strict compliance with conditions approach is a very poor strategy when it comes to dealing with developing nations. Though IFI's provides function of stabilizing global financial situation, Pakistan, due to its structural economic flaws, needs immediate reforms in order to safeguard itself from structural violence of International Financial Institutions.

- (iv) IFIs are often used as a tool by western world for arm-twisting. Pakistan is not able to buy cheap oil from Russia and Iran to boost its economy.

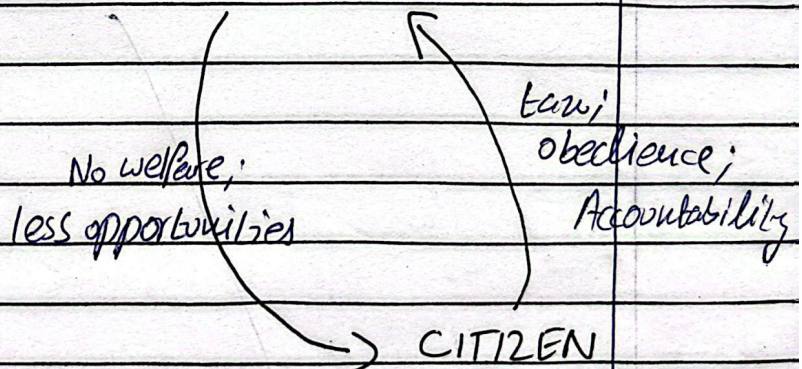
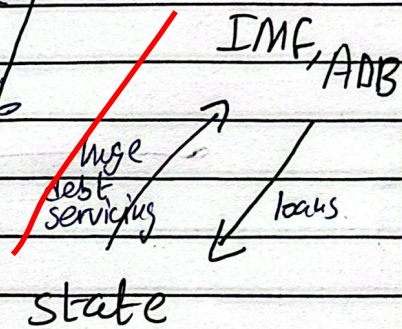
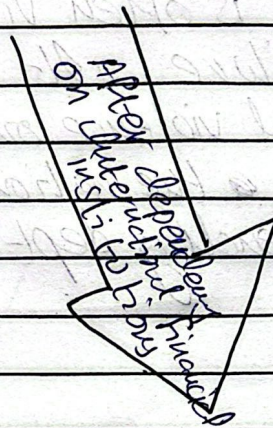
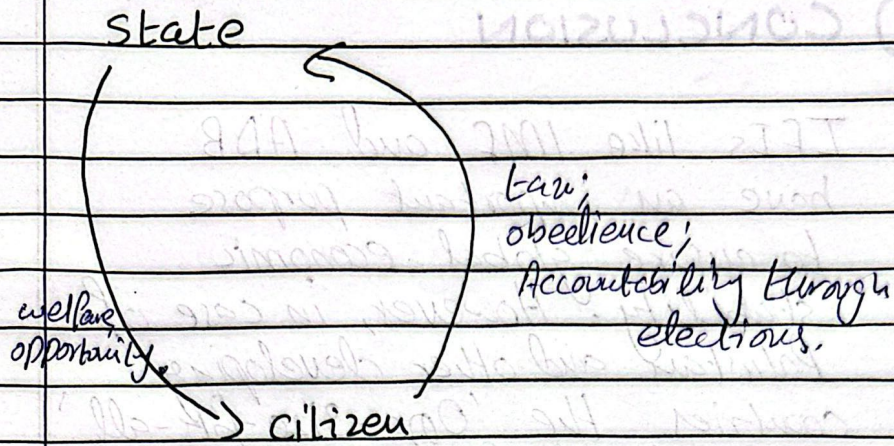
4) ANALYZING DILLUTION OF STATE'S ACCOUNTABILITY TO ITS CITIZENS
