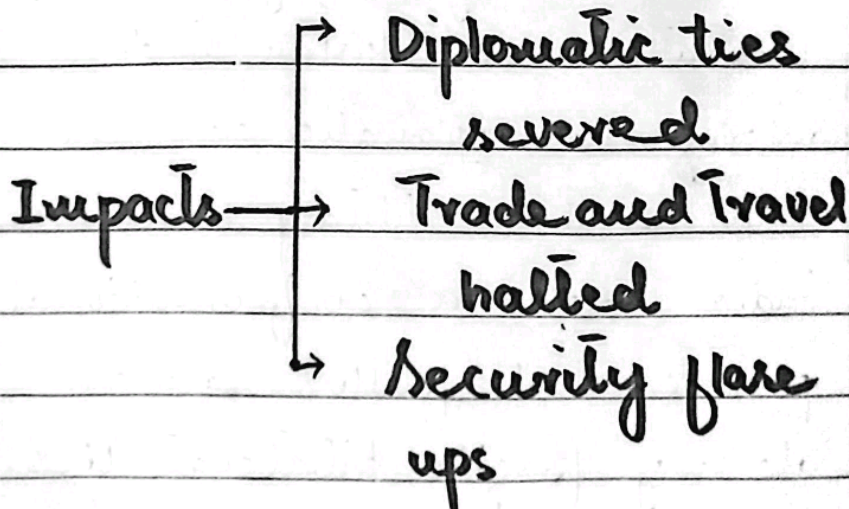

2- Impacts on Indo-Pak Bilateral relations:



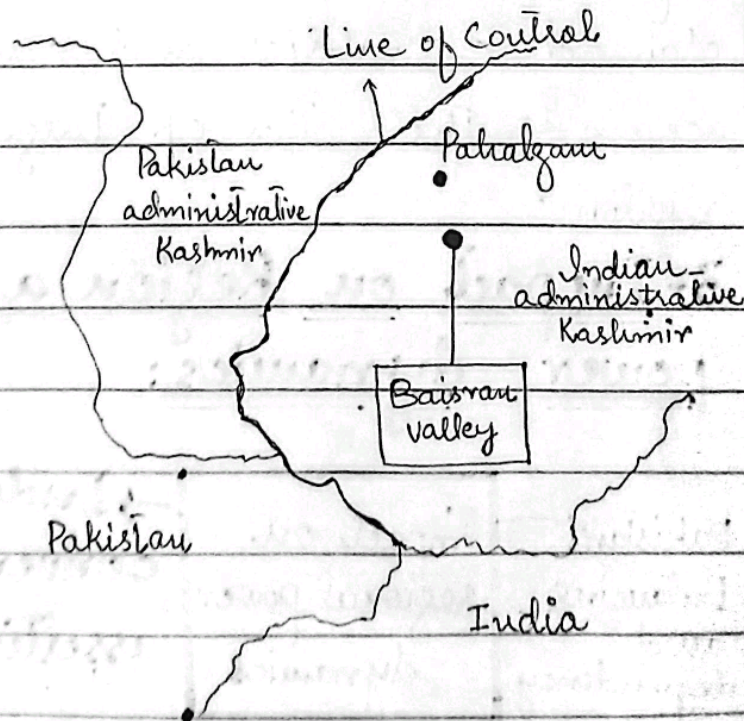

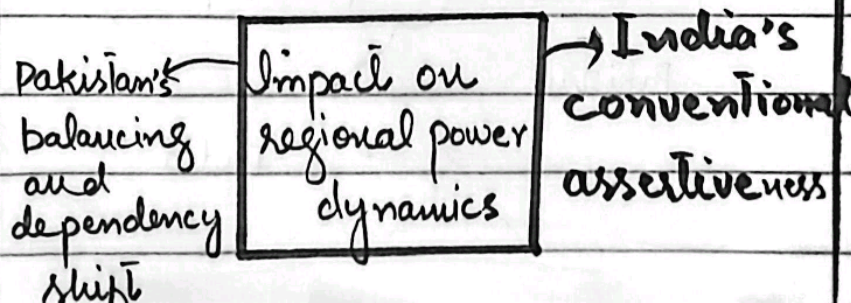

23- Security flare ups:

Clashes along the line of Control (LOC) intensified. India and Pakistan traded artillery and small arms fire almost daily after the attack. Both sides claimed casualties and each accused the other of targeting civilians.

4.3: Gulf state and regional mediator:

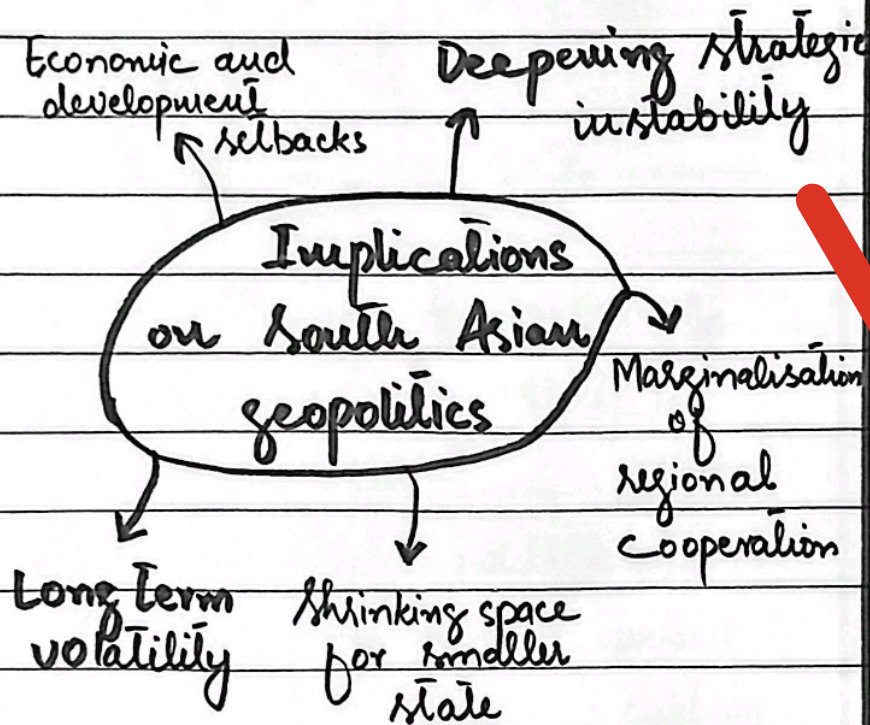
Gulf state acted as a discreet mediator using economic ties with both countries. Their involvement illustrated growing Gulf influence in South Asian.
