Indians were headed by Field Marshal Sam Manekshaw while Captain Ahsan Malik of 31st Baluch, with his 140 soldiers, was tasked to defend the village of Kamalpur. Ahsan fought bravely and was awarded Sitara-e-Jurat on recommendation of his enemy, Manekshaw. Ahsan returned a Ghazi, a war hero and retired from the army as a Colonel.

Charles Brown was a bomber pilot flying B-17 bomber plane and returning from a bombing mission in Bremen, Germany. His plane was severely damaged with only a few engines running when he was intercepted by a fighter plane flown by Franz Stigler.
