i) Narrow View:

The narrow view of international relations suggests that the IR is the study of political interest based relations among states. This view argues that the core relations are only of political nature and do not involve non-political relations. Furthermore, it indicates that relations are only among the states. To support this view, Hans J. Morganthau says that political relations are nucleus of an atom where all other relations ~~can~~ revolve around it as for establishing non-political relations, the establishment of political relations is a prerequisite.

ii) Broad View:

The broader view of international relations argues that the IR is the study of interest based ~~relations~~ political and non-political relations between states and non-state actors. This view argues that IR ~~can~~ is not only about

political relations but also about non-political relations in the international system. For instance, the IMF maintains its economic relations with states to help them out in the times of crisis. This suggests that non-political relations between states and non-state actors is as mandatory as political ~~relations~~ to ensure stability ~~of~~ international order.

The reason why this theory explains current global politics is due to its core assumptions of common beliefs, norms, and ideas.
