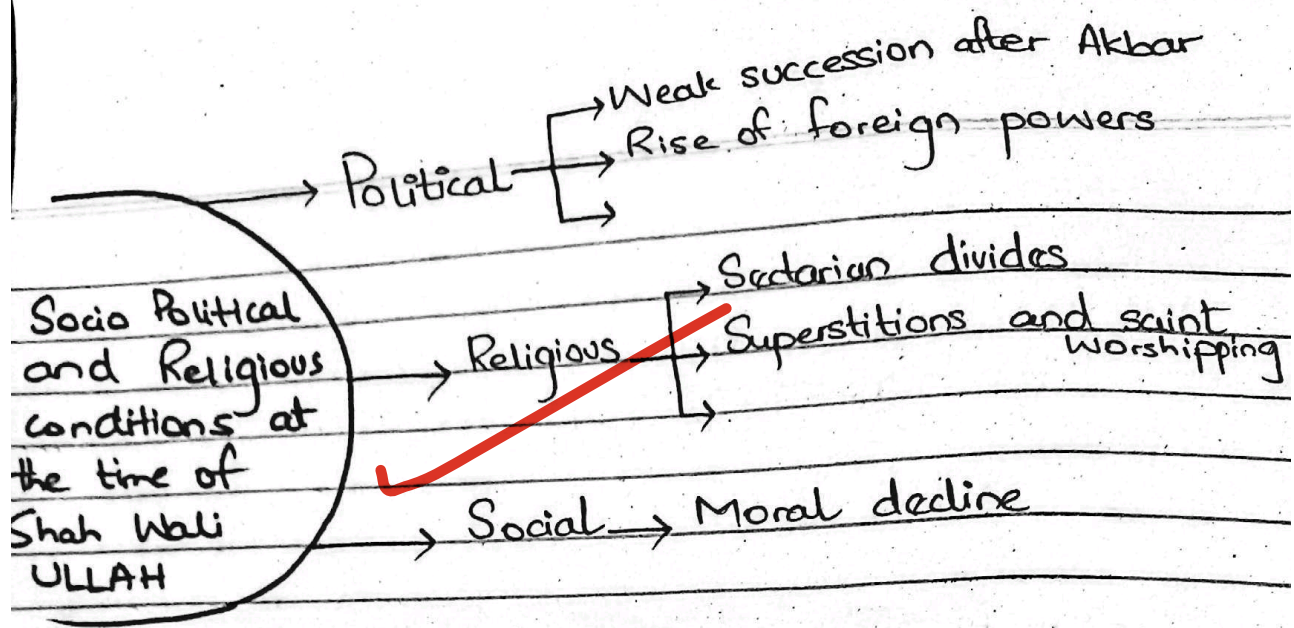
Religious and Political conditions at the time of Sheikh Ahmed Sirhandi
