

Q4: OVERVIEW OF THE 27th AMENDMENT:

The 27th amendment to the Constitution of Pakistan (enacted in 2024) introduced specific changes to the constitutional framework, primarily affecting the judiciary and the distribution of governmental powers. TRICHOTOMY OF POWER:

EFFECTS ON THE TRICHOTOMY OF POWER:-

Q3:

SHEIKH AHMED SIRHINDI:

Sheikh Ahmed Sirhindi was a prominent Naqshbandi Sufi leader and a Mujadid of the 11th century Hijri. Born in Sirhind, Punjab, he emphasized the importance of spiritual purification and adherence to the Quran and Hadith. His teachings focused on the renewal of Islamic practices and the elimination of innovations. He also played a significant role in shaping the Naqshbandi order in the region.

1. REVIVAL OF ISLAMIC IDEOLOGY:

Sirhindi, known as Mujadid Alf Thani, emphasized the purification of Islamic practices from perceived innovations and syncretism. He promoted the concept of *Wahdat al-shuhud* (Unity of witnessing), countering the prevalent *Wahdat al-wujud* (Unity of existence) philosophy, to reinforce orthodox Sunni beliefs. His writings, especially *Makhtubat* (letters), focused on revitalizing Islamic spirituality and adherence to sharia, influencing religious thought in the Mughal era.

2. CONTRIBUTION TO MUSLIM NATIONALISM:

Sirhindi's emphasis on a distinct Islamic identity helped shape a sense of religious consciousness among Muslims.

SHAH WALIULLAH:

Shah waliullah Dehlawi was a renowned Islamic scholar, reformer and sufi from Delhi. He was known for his expertise in various Islamic sciences, including Hadith, fiqh and Tafsir. Shah waliullah advocated for Islamic revival through education, ijtihad and the purification of Islamic practices. He also emphasized the importance of understanding the Quran in its original contexts and translating it into local languages to make it more accessible. His works had a profound impact on Islamic thought and reform in the Indian subcontinent.

1. REVIVAL OF ISLAMIC IDEOLOGY.

Shah waliullah worked on reconciling Islamic teachings with contemporary socio-political conditions, translating the Quran into Persian to make it accessible.

He advocated for ijtihad to address modern challenges and reform.

Islamic scholarship, focusing on Hadith and Fiqh.

His works emphasized social justice, unity and purification of religious practices, aiming to strengthen Muslim intellectual and spiritual life.

2. CONTRIBUTION TO MUSLIM NATIONALISM:

He highlighted the need for Muslims to unite politically and culturally, fostering a distinct Muslim identity in India.

His thoughts influenced subsequent leaders like Syed Ahmad Barelvi, who mobilized Muslims politically, contributing to the ideological basis of Muslim nationalism leading to the Pakistan movement.

Q2:- INTRODUCTION:

The Indo-Pak relationship has indeed been complex despite the shared linguistic, cultural, geographic and economic ties between the two nations.

The partition of British India in 1947, based on the two nation theory, led to the creation of India and Pakistan, resulting in massive population transfers, violence and deep-seated mistrust. Disputes over the princely state of Kashmir ensued, triggering several wars b/w India and Pakistan in 1947, 1965 and 1999. The Kashmir issue remains a major point of contention, fueling tensions and affecting bilateral relations.

GEOPOLITICAL:

The geopolitical dynamics of the Cold War also influenced Indo-Pak relations, with Pakistan aligning with the United States and India adopting a non-aligned stance, which later shifted toward closer ties with the Soviet Union. This alignment affected their foreign policies and interactions.

ECONOMIC COMPETITION:

Economic competition and water resource disputes, such as those over the Indus Waters Treaty, have added to the tensions. Additionally, accusations of

cross-border terrorism have strained relations with Pakistan alleging Indian involvement in supporting separatist movements and India accusing Pakistan of harboring militants.

CULTURAL AND LINGUISTIC TIES:-

Cultural and linguistic ties, though strong, have often been overshadowed by political differences. Efforts at normalization such as dialogues and agreements have intermittently eased tensions, but deep-rooted historical grievances and political agendas continue to complicate the relations between India and Pakistan.

CENTRIPETAL FORCE OF NATIONAL INTEGRATION IN PAKISTAN:

Centripetal forces are factors that pull the nation together, promoting unity and cohesion.

• IDEOLOGICAL FOUNDATION:

The "Two Nation theory" that led to Pakistan's creation provides an ideological glue, emphasizing a shared muslim identity that transcends regional differences.

• NATIONAL INSTITUTIONS

Strong central government structures, the military and institutions like the Pakistan civil service foster a unified administrative framework and national loyalty.

• COMMON LANGUAGE POLICY:

Promotion of urdu as the national language aims to create a unifying linguistic medium, facilitating communication across diverse ethnic groups.

• EDUCATION SYSTEM:

National curriculum and textbooks that emphasize Pakistan's shared history and values seek to instill a collective national identity among youth.

• **Economic Interdependence**
Development projects and infrastructure that link provinces economically encourage inter-regional cooperation and mutual benefit.

• **MEDIA AND NATIONAL NARRATIVES:**
State controlled media often broadcast message that highlight national unity, heroic national events and common aspirations.

CENTRIFUGAL FORCES OF NATIONAL INTEGRATION IN PAKISTAN:

Centrifugal forces are factors that push regions or groups apart, challenging national unity.

1. **Ethnic and linguistic diversity:**
Pakistan has multiple ethnic groups (Punjabi, Sindhi, Baloch, Pashtun etc.) with distinct languages and cultures, which can lead to demands for provincial autonomy or recognition.

2. **PROVINCIAL GRIEVANCES:**
perceived unequal distribution of resources, development funds or political power often fuels resentment in provinces like Balochistan and Sindh toward the central government.

◦ RELIGIOUS SECTARIANISM:

Differences between sunni and shia sects, or other religious groups, sometimes spark divisions that affect social cohesion. ✓

◦ REGIONAL SEPARATIST MOVEMENTS:

Groups in Balochistan and formerly in East Pakistan have pursued independence highlighting disintegration tendencies. ✓

ECONOMIC DISPARITIES:

Uneven economic development between provinces creates feelings of neglect, encouraging regionalism over nationalism. ✓

POLITICAL DECENTRALIZATION DEBATES:

Demands for greater provincial autonomy or federalism can weaken central authority and fragment national unity. ✓

EFFECTS OF THESE FORCES ON NATIONAL INTEGRATION IN PAKISTAN:

◦ POLITICAL STABILITY:

Balance between centripetal and centrifugal forces influences government policies, sometimes leading to constitutional amendments to ✓

manage tensions.

• SOCIAL COHESION:

Centripetal forces can strengthen a shared national identity, while centrifugal forces may cause ethnic or sectarian clashes that require mediation.

• ECONOMIC DEVELOPMENT:

Effective management of centripetal forces can spur unified economic planning, whereas unchecked centrifugal forces may hinder national projects due to regional disputes.
