Another causes are corruption and poor governance. Widespread corruption and ineffective governance have its effects on public trust in elected officials and institutions, fueling dissatisfaction and unrest. For example, High-profile scandals like the Panama Papers (2016) exposed offshore assets of political leaders, including former PM Nawaz Sharif, shaking public confidence in the integrity of politicians. Failure of civilian governments to deliver basic services and ensure accountability. For instance Pak's healthcare system remains underfunded, and frequent power outages have sparked public protests against mismanagement. Ethnic and religious differences have been exploited in politics, leading to social tensions and unrest that destabilize democracy.

Ethnic groups like Baloch, Sindhi & Pashtun have demanded greater autonomy. The

Balochistan conflict involves separatist movements protesting perceived neglect and exploitation of resources. Political

parties often use sectarian rhetoric to mobilize support, exacerbating violence.

For example, sectarian clashes between Shia and Sunni groups have led to bombing and riots, undermining national unity.

projects. Investor confidence and economic
instability e.g. During the Arab Spring,
investor confidence in Egypt collapsed,
leading to capital flight and economic
contraction due to political uncertainty.

Social unrest and extremism i.e. rise
of extremist groups and their impact on

society e.g. Post-election violence in Kenya (2007-2008) saw the emergence of militant factions that targeted communities, deepening societal divisions. And also the link between democratic unrest and social instability e.g. In Sri Lanka, political protests against the government have sometimes escalated into communal clashes, showing how unrest fuels social instability. The impact of democratic unrest on human rights and rule of law. e.g. During protests in Hong Kong (2019), allegations of police brutality and rights violations rose, weakening the rule of law perception. Restrictions on civil liberties and media freedom. E.g. In Turkey after the 2016 attempted coup, the government imposed media blackouts and detained journalists, curbing civil freedoms amid political turmoil.

In conclusion, democratic unrest is a complex and multi-faceted issue that arises from a combination of political, economic and social factors. The erosion of trust in democratic institutions, fueled by corruption, inequality, and social injustice can have far-reaching consequences, including political instability, economic turmoil, social unrest and the erosion of human rights.
