The famous American civil rights activist, Martin Luther King once said, "Injustice anywhere is a threat to justice everywhere." These words emphasize on the importance of protecting the vulnerable and weak members of society. Pakistan itself was formed primarily to counter the injustice being inflicted upon the Muslim minority of the Indian sub-continent. Upon its creation, the state of Pakistan recognized the importance of safeguarding minorities, and issued constitutional guarantees to protect the rights and minorities interests of minorities. These provisions gradually evolved over the course of Pakistan's constitutional history. In the

1973 constitution of Pakistan, the state ~~recognised~~ many rights related to life, safety, status, and property of minorities of Pakistan. For instance, the article 20 of 1973 constitution of Pakistan guarantees the freedom of religion for all citizens of Pakistan. Although the constitutional guarantees and protection of minority rights align with international standards, the implementation of these legal frameworks has consistently been a challenge for the state. The ground realities for the religious groups differ drastically from the constitution's promises. Since the start of the century, over 100 people have been killed in extrajudicial violence following blasphemy allegations, according to a report by Human Rights Commission of Pakistan. Other than the threat to physical safety, legal discrimination against minorities has also been reported. The socio-culture barrier has also made the attainment of employment difficult for minority groups. Mob violence and vigilantism remains a persistent threat for Christians, Hindus, Sikhs, Zoroastrians, Ahmadi, Buddhists, and atheist people of Pakistan. However, the creation of stronger procedures and legal safeguards may help in mitigating the situation. Public awareness and religious tolerance are also long-term solutions which could create a pluralistic society. Therefore, these solutions can be

critical in stopping the wave of hate and intolerance in Pakistan. Thus, despite the presence of strong constitutional guarantees, the ground reality indicates that the system has failed in implementing strong measures to protect the legitimate rights and interests of minorities.
