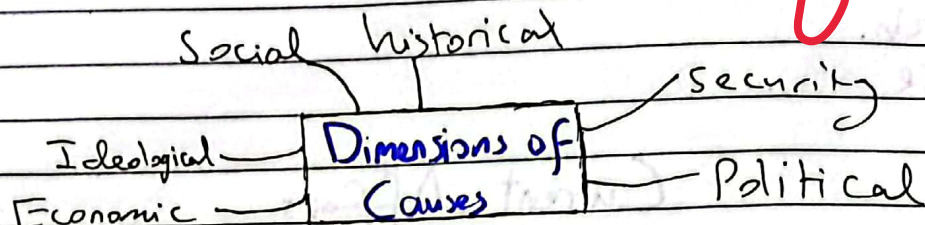

UNDERLYING FACTORS

1) Security Threats:

i) Housing TTP:

The biggest point of contention between Afghanistan and Pakistan is the housing of TTP commanders on Afghan soil. TTP terrorists move in and out of Afghanistan to conduct attacks in Pakistan and use Kabul as their base.

ii) Lack of Border control:

Afghanistan's lack of border control allows for arms to reach BLA and for TTP to exploit these loopholes for their diabolical agenda.

2) Political factors:

i) Deep-rooted Indian influence:

The Afghan foreign minister's visit to India are a growing reflection of Indian influence dominating in Afghanistan to be able to restrain Pakistan from two fronts.

ii) Recognition Seeking:

Pakistan's refusal to recognize the illegitimate Afghan Taliban government fuels Afghan animosity against Pakistan.

3) Historical issues:

i) Claims for KPTK

For decades voices from Afghanistan were heard that the demand line is unjust and that KPTK is theirs. This illegitimate claim has no legal base yet it is a background factor.

ii) Regional instability:

Pakistan and Afghanistan have always had a complicated relationship and this partly owing to Afghanistan's instability whose shocks disturb Pakistan as well.

4) Social factors:

i) Pashtun Identity:

The Pashtuns of Afghanistan have wanted the Pashtuns of Pakistan to unite with them but the people of Pakistan want no such thing.

ii) Lack of Discipline:

Afghans have never, in modern times, had discipline, control and structure in any of their socio-economic and political aspects which make them hard to work with.

5) Ideological factors:

i) Religious Fanaticism:

The religious extremism and fanaticism found in the Afghan Taliban and a sizable chunk of the population has led to ideological differences with Pakistan where moderate and balanced thinking systems are ~~more~~ preferred.

ii) Cultural Difference:

Afghans let their cultural uniqueness become a weakness which adds to their rigidity and inflexibility.

6) Economic factors:

i) Clandestine American exertion of control:

Through an American-influenced international financial institution the US has given over 80 million dollars of aid which has led to Afghanistan looking towards the US-India bloc.

ii) Missing Proper Economic structure:

Afghanistan is running on a ragtag economic framework which barely resembles a real economy. Their economic weaknesses have led to them switching their alliances despite China's mediation.

REMEDIAL MEASURES

1) Afghan Commitment to Peace.

If Afghanistan simply fulfil its promise for regional stability and peace, unlike in the Doha talks, it can lead to the revival of Pak-Afghan relations. They can do this by implementing draconian measures upon all terrorist organisations taking refuge there.

2) Installation of a Buffer Zone.

A one kilometre buffer zone between Pakistan's and Afghanistan's borders can effectively halt any inflow/spillover of unnecessary migrants and terrorists.

3) Ouster of TTP.

If the Afghan government oust the TTP terrorists by handing them over to Pakistani authorities then that can resolve relations.

4) Tightening of Afghan Border Control.

The Afghan Taliban need to implement stringent border control measures so that Pakistan can be at ease about threats originating from there.

5) Prevent Indian Influence.

The Afghans need to stop the Indian government from extending their agenda to it.

Halting talks with them and renegotiating peace with Pakistan can bear fruit.

6) Intervention of Multilateral institutions.

If institutions like the UN intervene and get both parties to conduct effective dialogue then it can perhaps lead to the first stage of betterment of relations.

HURDLES

1) Insufficient Funds.

Pakistan lacks the required economic power and funding to set up new provinces. This would require making new secretariats, new government buildings, institutions along with much more which isn't financially feasible.

2) Lack of Institutional Mechanisms.

Pakistan lacks the necessary institutional mechanisms to be able to divide provinces effectively and share power justly.

3) Absence of Policy Framework.

An exhaustive policy framework is required to bring into existence new provinces. This would demand time and resources, both of which Pakistan has little of. This would require hefty changes in laws, rules and regulations which is not a pragmatic option.

4) Divide on Ethnic lines.

Pakistan would further stir up ethnic faultlines which have already wreaked havoc. Further dividing the country could give leeway for some ethnic groups to take offense and take to the streets. It could possibly fuel ethnocentric tendencies.

5) Security issue.

A great concern for in terms of making new provinces is that the security infrastructure would be further divided up and strained.

RECOMMENDATIONS

1) Revise NFC Award.

Revising the NFC award and giving slightly increased shares to Balochistan, Sindh and HPD would allow for the discourse of new provinces to die down.

2) National integration.

By involving the other 3 provinces except for Punjab, in decision making process and integrating them could strengthen national unity.

3) Better distribution of Resources.

Distributing the resources of Pakistan and the resultant profits can enhance national cohesion.
