According to the author, if a lawyer has no strong arguments for progress in a case, he can highlight illogical details of the opponent to divert the attention from main argument. This phenomenon was, similarly, used by a young lawyer Lincoln. He showed his skillfulness by using 'ad hominem'. His counterpart was an extraordinary lawyer with strong arguments and deep knowledge.
