"The Judicious Use of Ad-hominem"

fallacy involves attacking the person instead of addressing their argument.

In the British court of law, Ad-rem and Ad-hominem can be used interchangeably according to one's ease. It can be seen via the story of (Abraham) Lincoln as a young lawyer, who during one of his first jury cases was clever enough to judiciously use Ad-hominem against his experienced opponent. The history of Ad-hominem goes back to the 1956 nominations of president Eisenhower and president Franklin Roosevelt in 1944 whose opponents used a cruel type of Ad-hominem and a reputation for giving a wrong argument policy.
