Question no. 2 :

The ad hominem fallacy occurs where one attacks the person rather than addressing the argument itself. A classical example is in a British court, where a lawyer is advised to abuse the plaintiff's attorney, if the argument cannot be refuted. Lincoln once used a clever, non-malicious ad hominem in a jury case. His opponent, an experienced lawyer, wore a shirt buttoned at the back. Lincoln told the jury that the man did not even know how to wear his shirt, which helped him win the case. Ad hominem has been used for centuries, by Sophists and in politics too. President Eisenhower's health was questioned during the 1956 nominations and in 1944, Roosevelt's opponents claimed a government policy was simply wrong because it came from "that cripple in the White House", demonstrating a very cruel kind of ad hominem.
