Introduction

Aligarh movement, initiated at the end of 19th decade at Aligarh by Sir Syed Ahmad Khan, was a pure educational movement that stirred sense of nationalism in Muslims. It was started under the platform of Aligarh educational institution that strengthen Muslim morales in the subcontinent. Apart this, it has long term political objectives, as it has raised awareness in Muslims brought Muslims equal to Hindus, reduced gap between Muslims and Hindus and promoted educational development through keeping Muslims away from politics. Not only this, it also strengthen Muslim nationalism through uniting Muslims under one platform, becoming base of two Nations theory and paving way for Pakistan Movement. This question examines political objectives of Aligarh movement and its impacts on Muslim Nationalism.

Although Aligarh movement seems as an educational effort, in fact, it has long term political effects on the subcontinent.

Contextualizing the Aligarh Movement.

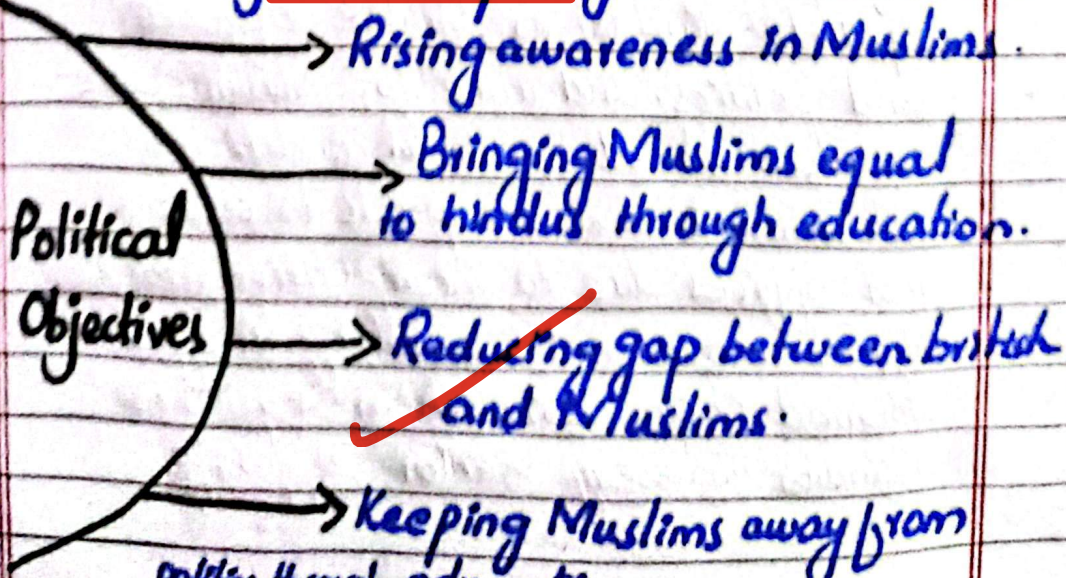
Aligarh movement started from the development of aligarh school and college in subcontinent that later converted into Aligarh University in 1920. It was developed by Sir Syed Ahmad Khan with the aim of social development and strengthening Muslim position in the subcontinent that is deteriorated from the 1857 mutiny against the British empire in subcontinent.

After 1857 revolt, British treated Muslims with harsh hands, removed them from government services, discourage religious education and erodes Muslim Nationalism.

The hands of British fell harsher on Muslims as compared to the Hindus.

Political Objectives of Aligarh Movement.



1. Rising awareness in Muslims.

The objectives of Aligarh movement was to rise awareness among Muslims. As the muslims after collapse of Mughal empire detached from modern education and sticked toward religious education that moved them toward social and economic decline. The aligarh movement through developing education institutions such as MAO school and college in 1874 and MAO university in 1920 raised awareness about social evils and political conditions of the subcontinent.

2. Bringing Muslims equal to Hindus.

Aligarh movement brought Muslims equal to Hindus in public offices and politics. Undoubtedly, Muslims were unaware about political condition of subcontinent and incapable to occupy govt offices due to incompetitive education. Aligarh movement started by Sir Syed Ahmad Khan bring them equal to hindus in every sector of life.

Aligarh movement has developed muslim society through providing them modern education.

3. Reducing gap between Muslims and British.

The gap between british rulers and Muslim society widened after 1857 revolt because british alleged Muslims as the major cause of 1857 war. They removed them from jobs and introduced new education system based on english and overthrown old systems that is based on Persian and Urdu language. Aligarh act as a pure educational movement that on one hand provided them education and on other hand helped to strengthen trust among british and Muslims. As the Sir Syed Ahmad Khan aptly said to Muslims, loyalty toward british empire reduced marginalization and economic deprivations of Muslims.

4- Promoting education and keep Muslim away from Politics.

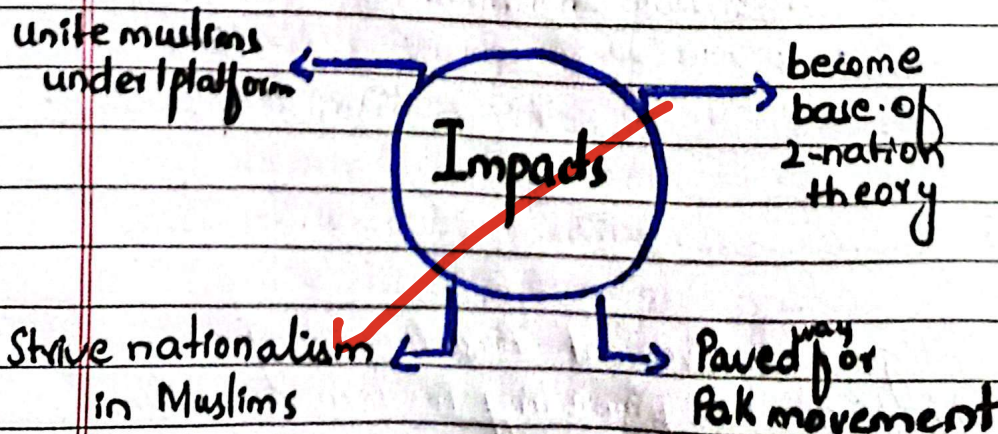

Sir Syed ahmad khan developed scientific society that translate english books into persian and urdu and publish journals for promoting education. Unite Muslims under one platform.

Aligarh movement unite muslims under a single ideology. Undoubtedly, muslims were confused and dispersed due to spread of different ideologies such as deobandis, bareilly and many other. Sir Syed Ahmad Khan bring them out from different ideologies and united them under the platform of aligarh educational institutions through combining religious and modern education.

Sir syed ahmad Khan used the opportunity offered, not for personal interests, but the interest of co-muslims.

Strive Nationalism in Muslims

Aligarh movement strengthen muslim nationalism through raising awareness and developing intellect through education in Muslims.

It strive sense of unity in muslim and realized them their culture is not preserved in subcontinent and protect their religion. For instance, students of aligarh institutions demand for separate electorates and opposed hindu nationalist movements.

Become base of two Nation theory

Aligarh movement paved the way for Pakistan movement as it raised awareness among people that later built new political party, demand for separate homeland. For instance, Mohsin-ul-Malik, Nizam-ul-Malik, Malik Wajid are the founder of Muslim League that was the majority party played its role in independence of Pakistan.

The grounds of the Aligarh breeds the nationalists that played role in Pakistan movement.

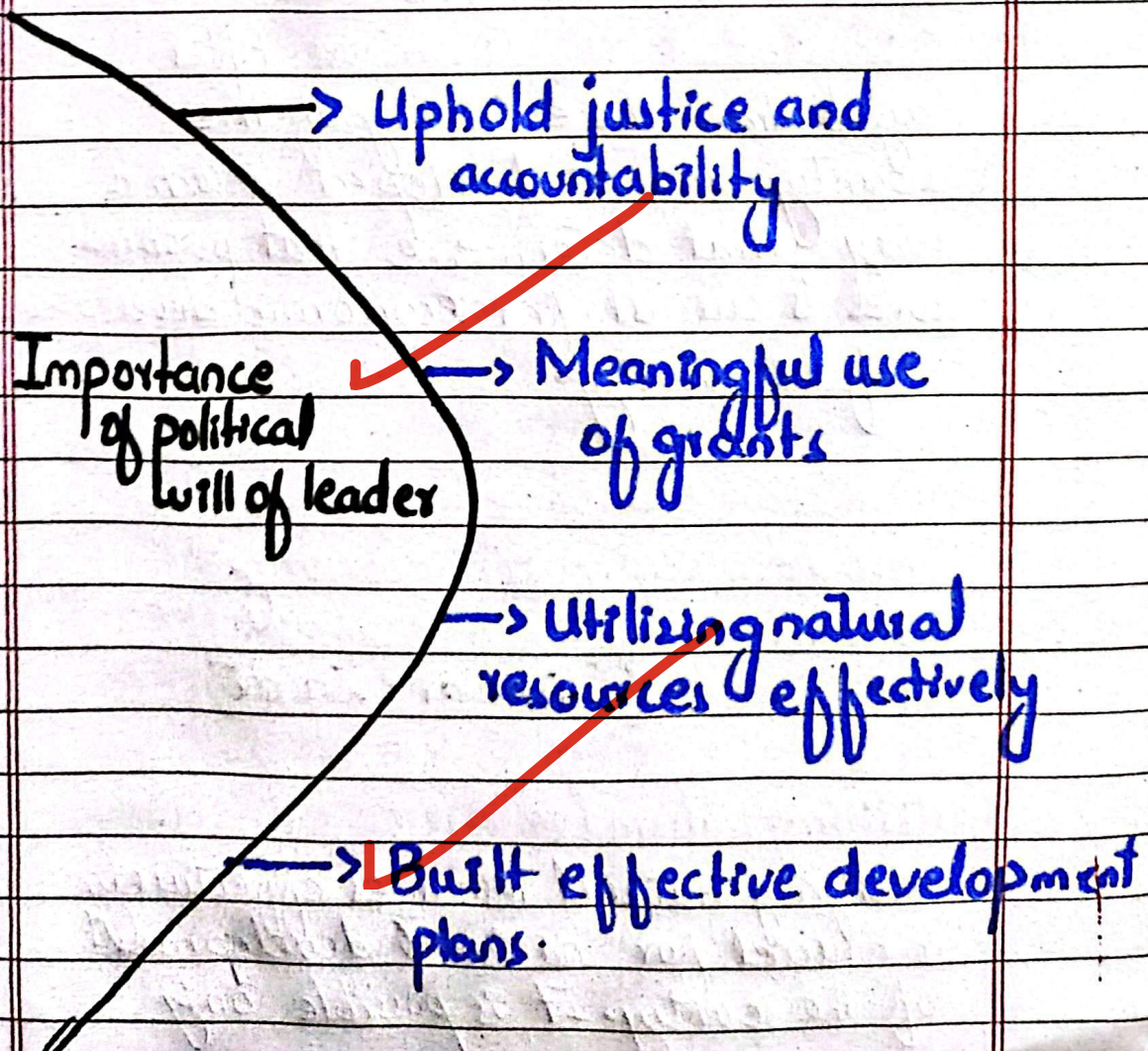

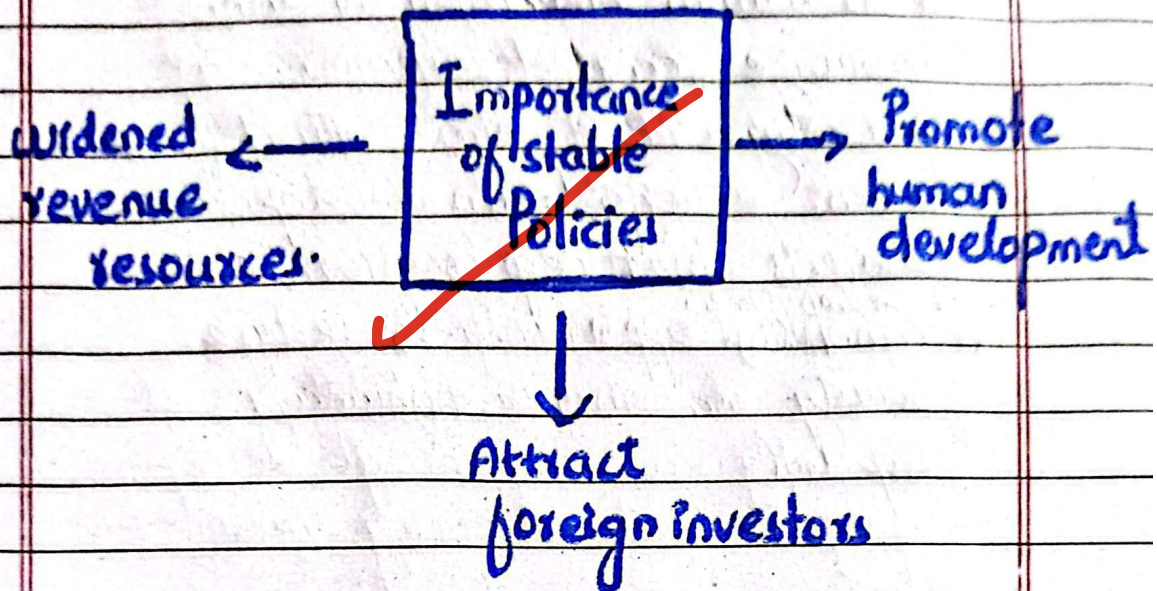

1) Attract foreign investors..
