attorney for the defence takes the floor, his friend gave him a note which was suggesting to discredit and abuse the opponent, which the jurists call ad rem, to the man, ad hominem.

Another story of Lincoln who was a younger lawyer and was confronting to a well experienced lawyer with legal points on his side to win. When Lincoln's team came, he used the same tactics to discredit him on his knowledge and abuse him on his outdated shirt which buttoned up in the back.

The writer says that similar vicious kind of ad hominem was being practiced in the nomination of President Eisenhower in 1956 when he was questioned on his health. Similarly with Franklin Roosevelt in 1944, when his enemies questioned the government policies and connected them to the one of white house's.

Such tactics divert attention from substantive issues to irrelevant personal traits.
