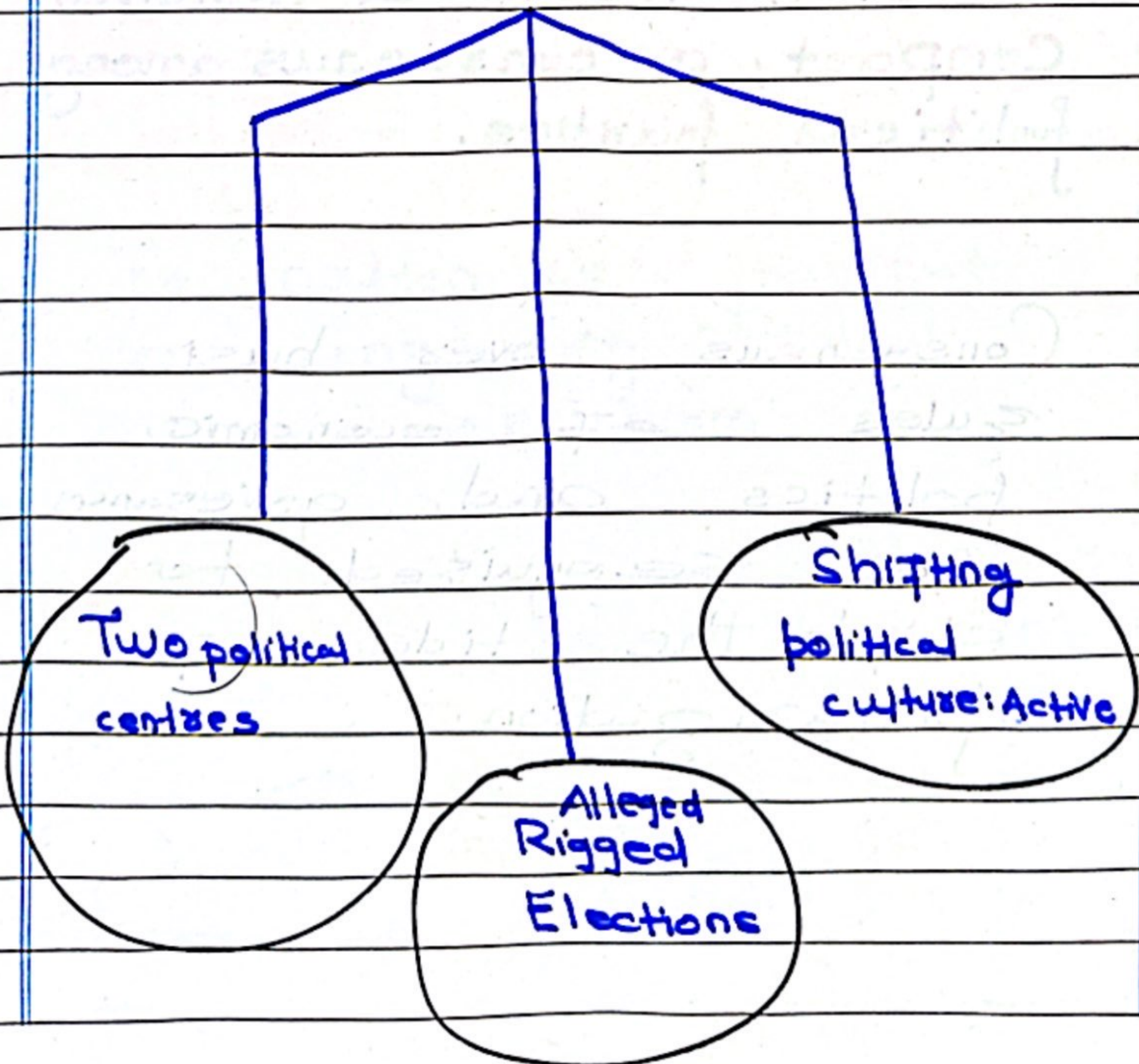
In the past, the apex court also played its part in furthering polarization

At high court level, the same constitutional bench mantra would serve in addition to regular benches.

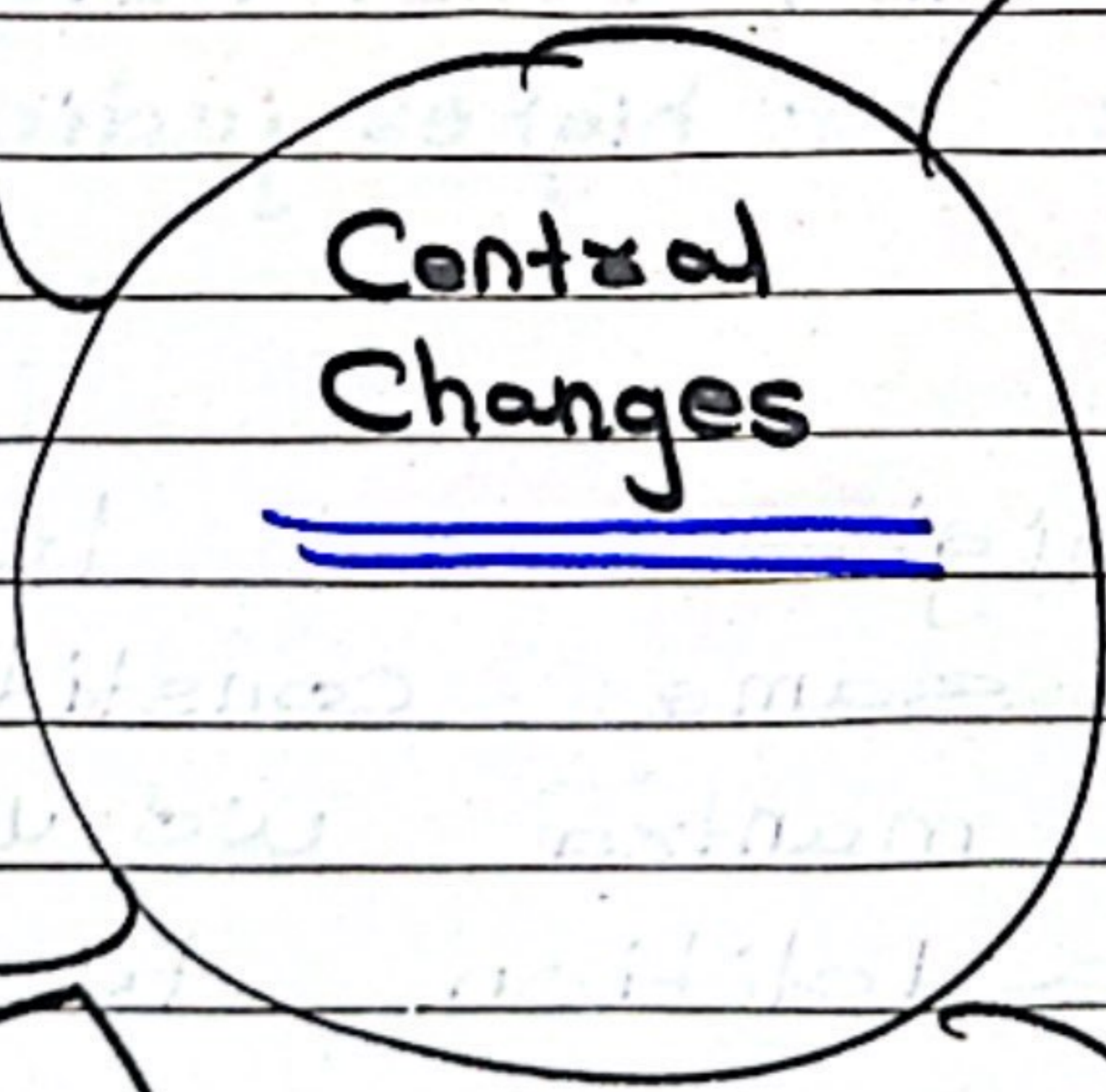
Composition of
