#### Introduction:-

The United States of America has long standing democratic system in their politics, having strong federalism. However the US have some glitches in its political landscape. Furthermore, the concentration of power among different branches of the government is highly distributed to prevent dominance of one. It has a strong accountability system with high conviction rate.

#### Strengths of US federal system:

→ The system is enriched with diverse mechanism.

##### 1- Strong political culture:

The system has strong political culture which helps to prevent the right election of their leaders and to participate for the formation of policies. The strong political culture strengthened political environment and maintain

peace in society

## 2- Rule of law:

The American government has strong rule of law mechanism, with higher conviction rate. For instance in 1970s the President Nixon, faced in corruption of political rigging and conspiracy case. He finally impeached. It is the mechanism and strong rule of law which hold accountable to their rules, regardless where they are appointed.

## - Strong Cabinet of President:

After election, the president appoints different person on different positions according to their specialization. It creates a strong political environment with highly professional.

## - Senate power against president:

Senate holds maximum power of legislation, along with impeachment of president. Whenever president vetoes any bill and decision, if the one third majority of senate agrees upon it then president will be ignored and decision takes place on the basis of Senate recommendation.

## Strong accountability system:

The direct democracy enable road map for the people to directly accountable the ruler. The US accountability system is more effective than any other where President has been asked directly by people while in public meeting and speeches regarding any decision which is against the right of people.

## The weakness of US Federal system:

### 1- Two party system:

The democracy thrive where the right of association completely given and supporting by the government. The US has only two party system, soaring the political polarization between Republicans and Democrats. People suffer two stances having no any other option to accept. Therefore, it is a weakness of US political and Federal system.

## 2- Lobbying in Federal system:

Strong lobbies are created in the federal system of US, like AIPAC, which for support to Israel, on any cost, these lobbies are influencing on overall Federal system and undermining true spirit of democracy. Therefore, it is a weakness of US Federal system.

## 3- Low vote Turnout:

According to Recent survey of US based think tank, the 2024 elections for American Presidency ship overall the US, the total vote casted only 47.5% which is very low for the father of democratic system, where democracy is highly promoted. It is because of ineffective system of governance for people and also conflicting policies which are strongly dominating the vote bank, therefore, it is the weakness of US Federal system.

The system of checks and balances for preventing concentration of power:

## 1- US President veto power:

The American president is the most powerful person in the political setup of the country. It has special veto power to check on the decisions of senate and cabinet. The president can control multiple authorities through veto. Like, President Franklin D. Roosevelt used veto power more than 635 times during (1933-1945).

## 2- Senate power against President Veto:

The two-third majority power can dismiss the veto power of US president, due to unlike deciding & create a balance between powerful entities in Political system and prevent from the concentration of power.

Sir Syed Ahmed Khan was a prominent personality in the time of awakening of muslims in subcontinent. ## Aligarh College:

In the end of the 19th century and the begining of 20th Century muslim people had very remarkable

## Introduction:

In elections of 1937, Muslim of British India highly failed to establish government. Most of the provinces of the country were won by Congress and individual Muslim leaders. The All India Muslim League can not achieve government in a single province.

However, from 11 province, 8 were in majority won by Congress rest of provinces merge with coalition of Independent muslims and Congress

Therefore, Government was made by Congress. The atrocities of congress over muslims were intense after making government and muslims of India feel hurdle in their daily life.

### Consequences of the 1937 provincial elections:

→ Decline in political struggle of Indian Muslim:

When the majority of provinces won by congress and independent muslim personalities, and after that they merge and form coalition regime, the muslims of India feel offensive due to no political influence in any province had occur, no any government could formed by muslims and struggle of party members gradually become low and they even not went any public session of the party.

→ Morale decline among Muslim League:

Most of the members decided to leave the goal and accept the suppression of congress and British

raj due to huge failure in the elections.  
and like others Muslim leaders  
they also decided to join  
Congress.

### Inefficiency of the party clearly appear:-

The party leaders were in angry  
mode and they were accusing to  
each other for inefficiencies. However,  
the whole structure and leadership  
of the party were very weak, the  
consequence occur due to less  
political campaign and unity  
among Muslim communities. Therefore,  
some Muslim leaders joined  
Independence side and some of them  
became candidate from Congress  
side.

### Atrocities of Congress during 1937-1939.

#### 1. Ban on Azan:-

Congress gradually demonstrated  
their brutal intentions. They restricted  
on the Azan and create troubles to  
offer prayer. Muslims of subcontinent  
feels more degradation after failure

elections. Congress openly offended the muslim practices, create comic on them and disunify the muslim brotherhood by spreading fake information.

## 2- No right for muslim leaders:

After making government in majority provinces by congress party with coalition of independent muslim leaders, no they confined their authorities by lobbying and restricted their share of economy and create trouble in protests. Therefore, Muslim feels very hard time and some of the leaders left congress due to no any privilege given by the government.

## 3- Vande Mataram -imposition

The government of congress impose the policy to sing vande-mataram the offensive words for the faith of a muslim, and create punishment mechanism for those who didnot sing these words.

## Oppression on Urdu language:

Like other atrocities, congress not stop and take action brutally against oppression of Urdu language which was the sign of Muslim on that time, they impose restriction on Urdu, close news papers of Urdu and ban on Urdu Learning, only Hindi and English were the language which can be speak without restriction.

## Conclusion:-

The elections of 1937 clearly demonstrated the weakness of Muslim political parties, and highly demolish the political struggle of All India Muslim Leaders. Moreover, after making government in majority provinces, the attitude of Congress change at one eighty degree they create trouble in daily life against Muslims, and impose many restrictions to suppress separate homeland ideology and rule over Muslim himakat.
