The excessive spirit of community service based on either religious reasons or humanitarian grounds promotes the

begging culture, the norms and a big begging mafia in many areas. A number of underdeveloped countries are entrapped by this curse of begging, leading to a number of negative consequences.

First and foremost, the social service promotes begging in any society by providing ways for making easy money. The access to easy money making in a competitive society naturally promotes the selfish acts of begging. Rather than finding a livelihood or adopting or learning a new skill, people

are inclined towards begging.
As the spirits of social service supports them, the number of people adopting and participating in these acts of begging gets increased. As the social service is backed by religious reasons and humanitarian grounds, there is an excess ~~line~~ of public service. The countries with the most begging are mostly the ones with excessive charity as it is a form of livelihood for many. For example, if a labourer earns 800 Rs for a ^{days} work, a beggar would earn 10 times more by begging on the street. Thus it is a way of easy money making and the social service aids begging in this manner.

Similarly, the spirits of community service perpetuates begging

by unchecked financial assistance to the poor. Without having a proper check and balance of the people asking for money or acting as being deserved, majority of the fake poor people benefit from this and adopt begging as a profession with no accountability of the people receiving the money, the begging culture gets promoted. Many social programs do not undergo solid background checks and thus many a times, fake beggars participate in these programs and benefit from them. Thus the social service promotes the acts of begging in a society. Furthermore, begging gets culture in a society is promoted due to the community service and spirit of social assistance.
