They show Islam in their own belief system rather attacking directly with rationality, as everyone knows that reasoning always wins over accusations and they are accusers only. There are number of ways to counter it

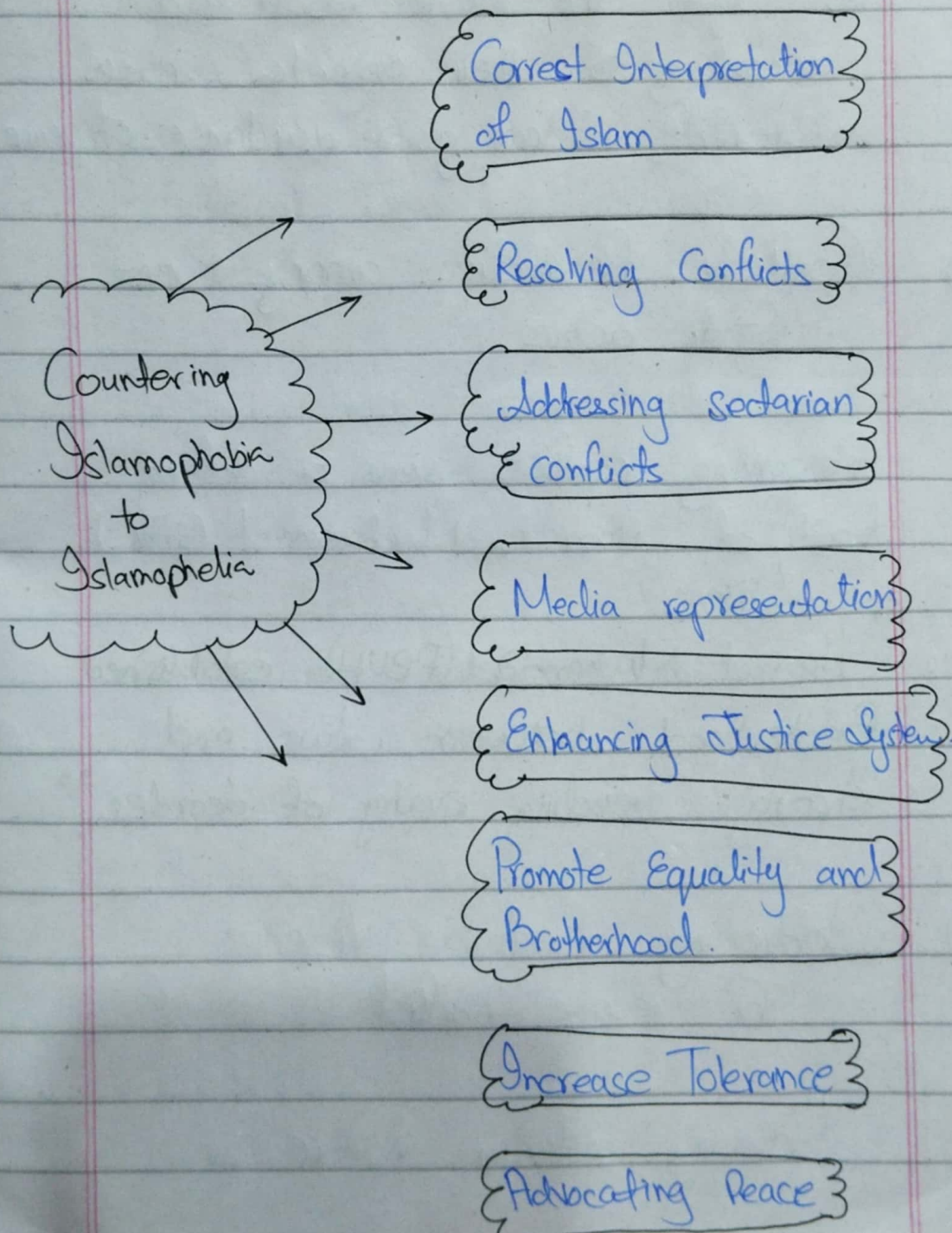
and transform Islamophobia, as a threat to Islamophilia, as a guard or guardian, mean love and respect for Islam.

Advocating Peace can also exterminate Islamophobic from spreading. As in Hadith

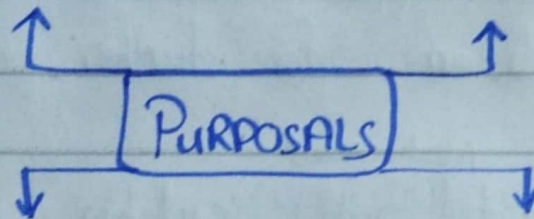
"Do you want to know what is better than jihad and Prayer?

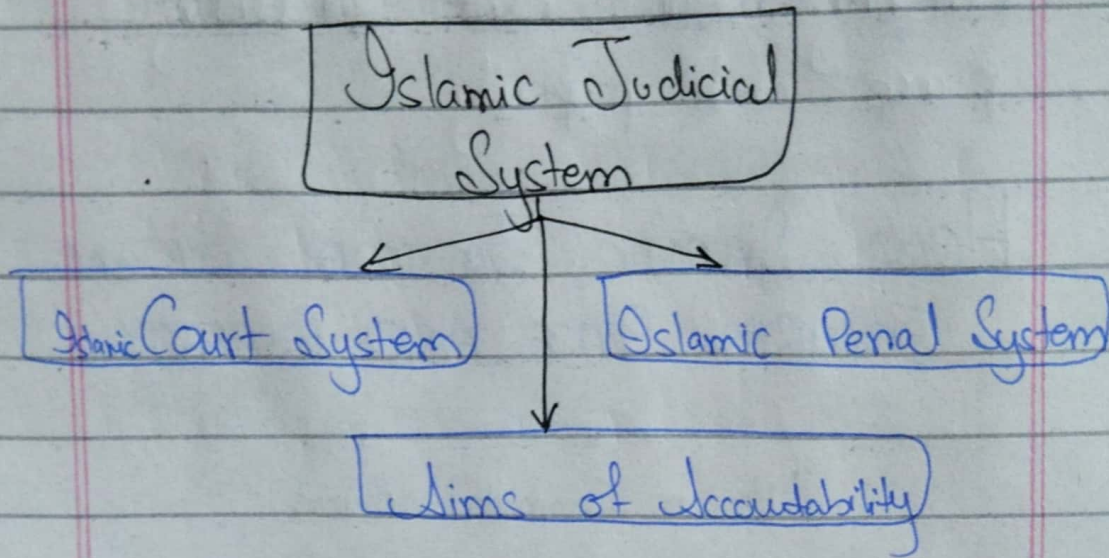
removing evil while establishing

1) Islamic Court System Promotes Peace and Prosperity By Fair Dealings.

i) Establishing Prompt Justice System

Islam establishes prompt justice system for the persons or cases how required instant justice. It was established by Hazrat Umar (R.A) and He named it as Qifta.

2) Fair Trials

Islam gives equal

right to both parties and also cross examination to ensure fair dealings and justice. As mentioned.

3) Double Check system Ensures Righteousness

Islamic Judicial system proceeds in 2 steps to ensure accountability. Step 1 is open Justice system where hearings are made publically, Step 2 is verification of accusation by investigating secretly that either the blaim and accused are right or wrong.

4) Free Guidelines and Trial

Islamic Judicial System gives free trials and lawyers to ensure justice among poor equally as in rich.

Article 10A of Pakistan's Constitution also gives right of free and fair trials to its citizen.

5) Expert Judiciary

Islam provides justice under the expert ~~at~~ penel of Judges.
According to Al-Mawardi

“The judge should be of sound mind, expert of fiqh and jurisprudence, dignified and reputable for Islamic System.”

B ISLAMIC PENAL SYSTEM ENSURES Justice WITHIN SOCIETY Promoting PEACE AND Equality

1) Punishment of Drinking Alcohol.
Alcohol drinker is punished
for 80 lashes, 40 lashes for drinking
and 40 lashes for lying.

2) Punishment of adultery in Islam

If adultery is done by unmarried
person, it is 100 lashes and if
adultery is committed by married person
with 4 witness he/she is punished to death.

3) Consequences of Theft and Robbery

Punishment of theft is cutting
hands as famously heard by
Hazrat Muhammad (PBUH) about his daughter
Fatima and the pick pocketor comparison.

Whereas Robbery is punished
by death sentence

4) Result of Bribery

Bribery is the severe evil conduct

“ Bribe is the material of Hell fire ” Al-Gurani.

5) False accusation of Adultery

If someone accuses falsely about adultery he or she is severely punished in Islam.

6) Apostasy and Reward

The one who left Islam ~~are~~ is given chance to return in 3 days otherwise he or she will be rewarded with death penalty
