Thesis Statement -

Structurally charity is considered a societal ill, which ultimately promotes laziness or ineffectiveness generally and dependency and control specifically. It is in the favour of the people to get empowered instead of getting charities.

Body paragraphs:-

Naturally all men are created equal and with equal capabilities. It is the human who has created differentiation and classes among them. Economically the capitalist societies are responsible behind the ideas of getting rich and letting others poor. Now among the three classes which are differentiated by the economists, two other ^{also} sub classes exist, those are who is giving charity and who takes it. Charity is to a greater extent, is an ill phenomenon which impacts the society badly. It infuses a sense of inferiority complex among the lower class which resultanty compells them to surrender their integrity as well as dignity. Furthermore, the management among the charity giving organisation often

used to be a compromised one which encourages favoritism there as well. Hardly a deserving person gets the deserving quota. The exercise of alms and charity always promotes longlasting begging among people, which is poison to a working society. Although it provides them a short term relief but entangles themselves in the shackles of laziness and dependency. These people, later on becomes burden on public and private sectors. Empowering public through skills and other ways to make their bread and butter is the way to success, not the short term relief.

There are a lot of dark sides of the charity. Charity compromises the integrity and the social status of humanity. It promotes a sense of dependency and laziness. The person who is accustomed to the alms and giveaways will not strive to lead a tougher life, neither he always give priority to the soft and easy ways to earn bread and butter. In pakistan a major chunk of

the people, regardless of any genders wandering here and there to collect a sum to lead life. Majority of all those people are healthy and able by all means, but they prefer the soft earning over the hard one. These are the some dark sides of the charity.

Charity is being considered as a temporary solution not a permanent one. Because those public and private sectors who provide charity, does not think of the root problem behind poverty or other factors which contribute towards charity. Rather these institutions trying to solace the hunger of the last of the problems through a temporary way, that is, providing them a way to get what they want for a small time period. It is stated by a Chinese philosopher "Do not give my people a fish, rather give them a net." So, instead of giving people charity we must promote the culture of empowering them, because charity is not a permanent solution.

Another dark side of charity is that,

it makes people vulnerable and dependent upon the welfare organizations. Charity and being dependent upon charity is not only an issue of the people of developing or underdeveloped countries, instead the developed countries are also facing this issue to a significant extent. In western europe, which is considered the most developed world, good number of people are waiting at the banks of roads, for those people who will provide them some amount to meet up with their needs. Although, contrary to the developing and underdeveloped world, these people do have to bundles of opportunities to get a job and to do work by their own. As these people have become dependent upon the aids of the government and other people. so, they do not want to do work. Beside aforementioned assertions, another big dark side of charity is the compromisation of self integrity and dignity. usually, charities are not given by going door to door or by respecting keeping

the privacy of the people. People have to asked other people for that favour publicly. Now in the period of the emergence of social media, providing charity has become a public stunt. People provides favour to those who are demanding in front of the camera and later on post on social media platforms. In this way the integrity and dignity of people is getting compromised.
