Moreover, agriculture sensitivity to climate change become a huge threats to human life due to global warming. The increase in temperature and shortage of water affects agriculture sector adversely across the world, which leads to food shortage and reduction in productivity level. As per report, due to flood 2022 in Pakistan loss about 6.5 million acre of crops and also due to heat stroke 30-40% reduction recorded in mangoes production. These condition leads to ~~food~~ wheat crisis in Pakistan 2022 and food shortage. Therefore, global warming is considered as the reality.

In addition, global warming contribute to melting of glaciers across the world, which leads to increase in sea level. Global warming increased the average temperature of the Earth by trapping sunlight radiation through greenhouse gases. These increase in temperature leads to melting of glaciers at large level. According to the report of world glaciers and ice, the European glaciers are the second largest melting glaciers of the world. It also says in Antarctica larger than London city ice cap merged into the ocean water. From industrial revolution about 8-9 inch increased had been recorded in the sea level. This shows that, global warming have significant role in



melting of glaciers which contribute to flooding. Therefore, global warming is considered as the reality of 21st century.

In the same way, bad air quality due to global warming have severe impacts on human health. Due to global warming the concentration of pollutant become over increase in the troposphere which have influence on human respiratory and immune system. Bad air quality caused Emphysema, Shortage in breathing process and even leads to lung cancer. According to WHO report due to bad air quality life expectancy in Pakistan reduced about 3.9 years and also says that in Lahore the life expectancy reduced upto 7 years. These negative environmental impacts are seen due to



global warming. Hence, these severe condition of air pollution shows that global warming is the reality of 21-st century.

Further more, excessive drought condition due to climate change or global warming lead to political conflict. These political conflict arises due to shortage of water among states and provinces. Glaciers is considered as the reserve source of water for domestic and agriculture use, but due to global warming the process of glaciers melting become rapid. So in some area it ~~cause~~ <sup>leads to</sup> flood while in another it cause shortage of water. ~~For~~ For instance, the water dispute between Pakistan and India and also between Pakistan and Afghanistan is due to global



warming which cause shortage of water. Moreover, it also rise conflict among provinces like water issue between Sindh and Punjab and among KPK, Balochistan and Punjab. This shows that, global warming is the reality which have significant role in political disputes among states and provinces.

Similarly, excessive heat stroke leads to loss of human lives due to global warming. Global warming increased the average temperature of the Earth due to which people across the world facing lethal consequences. Such increasing temperature make human vulnerable and unable to compete the changing environment, which leads to loss of life. According to WHO report in 2023 about 46,000 people died in Europe due to excessive heat stroke, in which most of



them are at child and old ages people. This shows that heart stroke leads to loss of life. Hence, global warming is the reality have a pivotal role in increase in temperature that contribute further to loss of <sup>human</sup> life.

Some people is also presented global warming as an expensive hoax due to economic benefit of certain entities. it. According to IPCC ~~IPCC~~ Northern  
developed states climate change  
is caused due to both developing  
and developed state emission. As  
per UNECCC about 15% emission  
produced by USA, 35% China,  
7% India and 9% Europe. They  
want to stop these emissions and  
work for the promotion of <sup>clean</sup> green  
and green environment. As a result,  
global North want to interfere in



industrial development of developing state to maintain their hegemony.

Therefore, global warming is presented as propaganda by developed states to show that it is an expensive hoax.

Furthermore, developed states portrayed flawed scientific data for their political interest to present global warming as expensive hoax.
