## Introduction

History has witnessed the powerful rule of muslims in Al-andalus and ottoman Empire. This was possible because muslims had pure faith in Allah and maintained unity. Unfortunately, the muslim ummah is now facing numerous challenges, despite being most populated and resourceful states. # Political challenges faced by Muslim Ummah

There are total 57 muslim countries out of total 193 countries in the world. But, the most disturbance found among muslim states especially Middle east. The whole tenure from arab spring in 2011, to Bashar al-Asad downfall, and Israel's genocidal attacks on Palestine, Lebanon and Syria, marked with devastating political issues. Moreover, presence of weak democracy and strong autocratic rule presents challenges to muslim world. The recognition of Israel by Saudi Arabia, UAE and Oman further escalating the tensions in the region, and results in division of muslim Ummah.

## Economical challenges

Despite control of muslim world on world's 76% natural resources, they are dependent on west for aids resulting into various crisis related to economic. For instance

Rise of inflation causes severe poverty in the region. Moreover presence of interest based system is also a main hurdle in progress of Muslim ummah, as Allah in Quran says,  
"Allah has forbidden interest." (2:275)

## Ideological challenges

Along with political and economical issues, muslim ummah are facing ideological issues too. Ideological issues includes, rise in Pan Islamism, extremism and sectarianism conflicts. The increasing islamophobia due to orientalism from west against muslim serves as a biggest threat for muslim ummah. Saudi-Iran rivalry on basis of sects is also posing a bigger threat. Allah has mentioned in Quran,

"Those who have divided their religion and becomes sects. You (Mohammad) are not associated with them in anything. ~ (6:159)

## Intellectual challenges

The backwardness in education and technology pose a big threat to muslim ummah. As they are unable to compete with Israel and external powers. Mohammad

(ﷺ) said;

"Education is obligatory

on every man and woman."

This shows importance of education, in Islam. In contrast muslim ummah is far behind in education and technology.

## Social and Cultural Challenges

It is seen in muslim world, that liberalism has been increased due to emulgamation of muslim culture with the west. It causes disintegration in society. This westernization leads to erosion of Islam identity and causes cultural imperialism of west over muslim culture. Allah has mentioned

in the Quran

"Hold firmly to the rope of Allah all together and do not become divided."

## Implementation of Shariah

### Development of Islamic Bank

To reduce reliance on US debt trap "IMF", muslim ummah should introduce Islamic bank for support of developing muslim states, as the concept of Bai-ul-mal already exists.

### Common Currency adoption

Muslim Ummah, should collectively adopt common currency in order to minimize reliance on US dollars, - this will not only uplift the the economy of countries but also reduce reliance on US dollars.

## Common trade Market

76% resources are under control of Muslim ummah, should introduce Common trade market which should be interest free. This will raise their importance and counter other powers.
