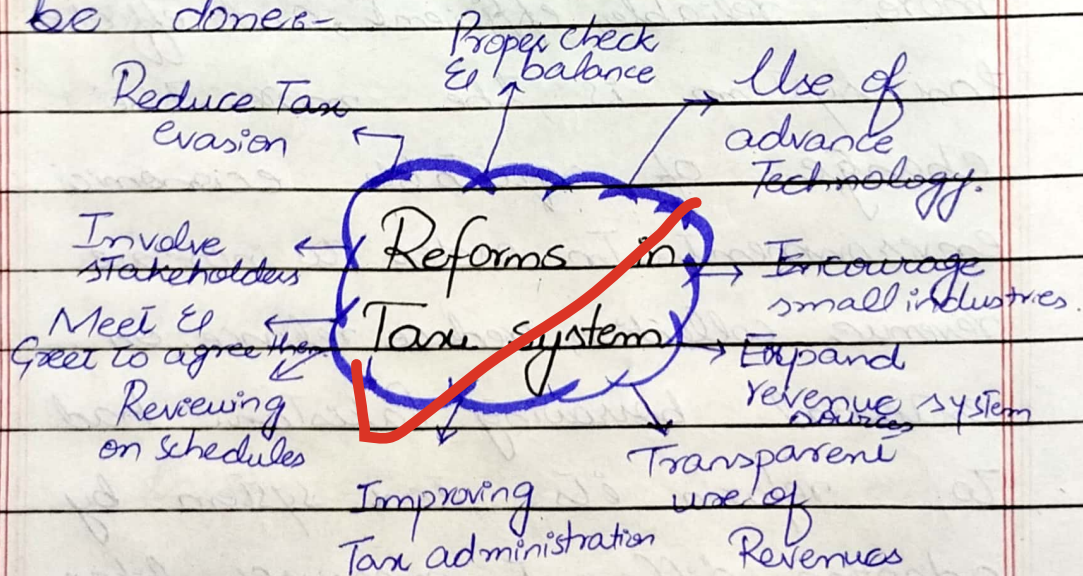
system, engaging stakeholders, and much more.
