In the past, many mughal emperors fell prey to this power negative trait of power and it led to the fall of the mughal dynasty.

Thus absolute power allows easy access to corrupt practices without any checks and balances, implemented in system and with no accountability for ^{overall} actions.

Similarly, absolute power can lead to absolute corruption due to lack of strong opposition. Many a times the executive, sovereign that have absolute authority and

power can are faced with
either very less or no opposition
at all. The ~~pres~~ absence of

In Pakistan, dictators have played
