### ANSWER

#### 2 → Introduction

Situation in Syria has been under complexities since the starting of Bashar-al-Asad's regime. The situation got more worst in 2011, when the movement of Arab Spring arose out in Middle East. However, He (Asad) remained successful to protect his regime against the rebellion but he gave

a spirit to the rebel groups against himself. Since 2011, the economic, political and social condition of Syria has remain below the average line. Finally, in December 2024, Rebel groups along with the support of local population became successful to overthrow the regime of Bashar-al-Asaad.

## 2 → Overview of the brutal regime of Bashar-al-Asaad

Hafez-al-Asaad, the father of Bashar-al-Asaad remained in power from 1971 to 2000. In 2000, Bashar-al-Asaad took the regime after the death of his father. From the last two decades, Syria has become

a hotspot for wars and conflicts. Millions of people had have lost their lives and are relocated.

In a nutshell, Assad family regime proved to be a brutal rule.

## 2 → Reasons behind the downfall of Assad's regime

There are multiple reasons behind the downfall of Assad's regime. These reasons provided a clear path to the people and rebels to overthrow the regime. These includes:

### 1) Aristocratic Rule of Assad

2 → Weak Economy and Untrained Military: provided a clean path to the rebels.

The economy of Syria has been almost collapsed since the civil war has started in the country. Moreover, the government remained unsuccessful to provide the good weapons and training to the military. This helped the rebel groups to overtake the country without any resistance.

## 2 → Advancement of Rebel Groups and the Support of International Community

There are many small and large rebel groups operating in Syria but the most prominent among them is the HTS (Hayat-ul-Tahir-ul-Sham). This group is led by a former Al-Qaeda member named as Mohammad-At-Jalani.

## 2 → Military and Economy of HTS

HTS, has been backed by the west with latest weapons and economic help. According to the international media debates, HTS was backed by Israel, USA and UK.

## 2 → Response by the Government

Syrian government has shown

little retaliation against the rebels. In fact, Bashar al-Assad fled from the country on 08 Dec-2024 and his government personals decided to negotiate with the HTS to avoid any destruction.

Hence, HTS started from 5 December 2024, first they captured Aleppo and Hama and on 09 of December they remain successful to control more than 70% of the Syria.

## 2 → Current Situation and Future of Syria

Negotiations have been done between the government officials and the HTS leaders. It is decided that the current PM will leave the country until the next Prime Minister as government. Moreover, it is decided

US, being the largest economy in the world, has influenced the world with his dollar diplomacy. Today, the trades between different countries are done through the dollar payments. Similarly, it has become an international or global currency.

Likewise, Swift is an online payment method which helps the users to send and receive online payment anywhere in the world in the

→ BRICS+ and Their Strategies to Counter Western Influence

BRICS was founded in 2009 with only 5 members. The main moto behind the formation

of organization was to trade among the member states without any barriers. With the passage of time, the organization expanded and became BRICS+. Currently it has Brazil, Russia, India, China, South Africa, Egypt, Ethiopia, Indonesia, Iran and UAE. It holds 54% of the global population and 42% of the global wealth.

### → Barrier free trade

Members of BRICS+ has no barriers in between their trades. Trade can be done without any duty or custom. Likewise, sea routes, cargo, by roads and by air, this can be happens.

### → New Development Bank (NDB)

Another biggest initiative by BRICS+ is the formation of New Development Bank. This

is a substitute to the IMF and WB aid programs. Member states can easily seek aid and loan without any policy recommendation by the institute.

→ Formation of BRICS PAY: an alternative to Swift

Russians have Mir network, China has Weipay and India uses Unified payment method. Collectively, a new payment method will be adopted by using the technology of UPI and Weipay. More importantly, BRICS has started the interbank transactions, which allows the user to send and receive local currency without converting it into dollar or any other currency.

2 → Adaptation of Crypto payment methods

Moreover, BRICS has also started using block chain technology for the payment gateways. The method is decentralised and requires no third party to participate. This will not only enhance the trade but will also counter the hegemony of dollar.

## 2 → Critical Analysis

Although US and other western countries has led the world through dollar diplomacy as a tool for exploitation, but with they have also helped the third world countries to come over their difficulties and economic problems. But with the growing influence of BRICS and China economy, the west is losing their

dominance in the southern nations. China along Russia, sees US as their sole enemy and wanted to finish its influence from the region. For this purpose both countries has been involved in multiple bilateral agreements and organizations.

## 2 → Withdrawal of America from Afghanistan, Giving Control in the Hands of Taliban

In Sep 2021, US completely withdraw its forces and officials from Afghanistan and without any retaliation the Afghan Taliban took the country under their control. They installed their own

→ Afghan Taliban are being used as a proxy against Pakistan

The presence of Afghan Taliban in the provinces of KPK and Balochistan makes it easy for other countries as entities to launch them against Pakistan. According to the reports, currently there are about eight proxies who are working for other countries especially India.

→ Effects of Terror attack on Pakistan

Terrorism on the soil of Pakistan

has detracted the image of Pakistan in international arena. Pakistan is known as a Terrorist state globally. Furthermore, economy had faced severe challenges, FDI stoppage, Pakistan was also placed in Grey list. Most importantly Pakistan lost 58,000 lives in these deadly attacks (ISPR Report-2024). Similarly in 2024 only, Pakistan was attacked 538 times, which is 171% more than the 2023. (PIPS)

## Recommendations

Both countries leaders should sit and decide the policy to stop this violence. Both nation are facing severe

security challenges.

## 2 → Construction of Durand Line
