(1) Introduction:-

Sir Syed Ahmad Khan's vision of educating the Muslims of India would cure the miseries of them were the right choice. The Muslims were alienated after the war of Independence because all the tables had turned against them. From education to Unemployment they were outnumbered by the Hindus - This pushed Sir Syed Ahmad Khan to pursue education and enlighten Muslims. Sir Syed's effort for educating Muslims to facilitate good ties with the Crown were remarkable achievements which later on resulted in the formation of All-India-Muslim League and the realization of identity preservation and fight for the cause were all the result of Sir Syed's untiring efforts for Aligarh movement.

(2) Muslims after the war of Independence:-

War of Independence was the joint effort of Muslims and Hindus for Britishers unfair policies and practices that subjugated

The people of Sub-Continent. However, after the end of war of Independence, Hindus change their life and accepted all the new changes implemented by the Govt. However, the Muslims remained unaware of the sudden change - which resulted in change of language in professional sphere and denied their right of employment. That was the catalyst more by the Hindus and bitterness to life-time Muslims.

(3.5) Tehzeeb-ul-Ikhlag to highlight the pain-points of muslims cause:

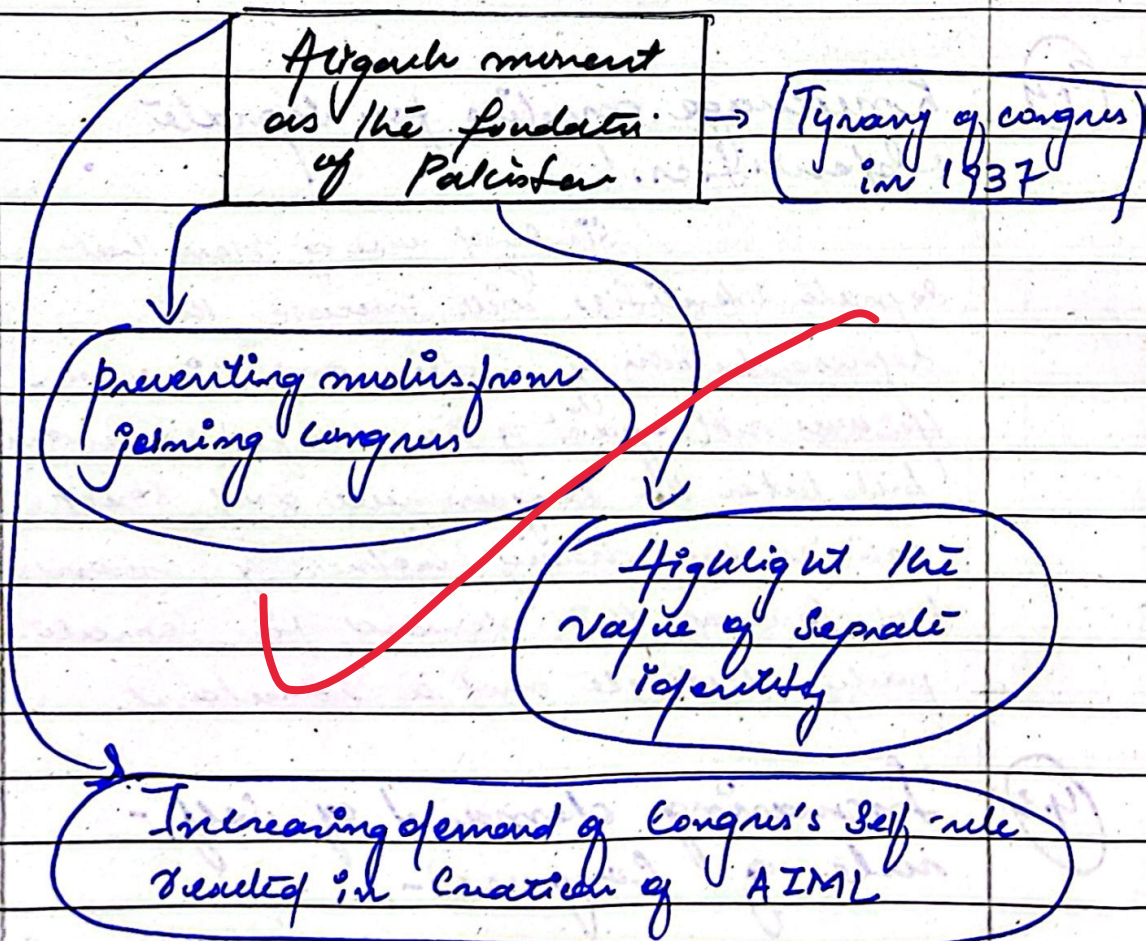

Climate change has posed a real threat to the humanity and the planet. The Paris agreement of stopping the temperature at 1.5°C has been attacked with extreme weather events.

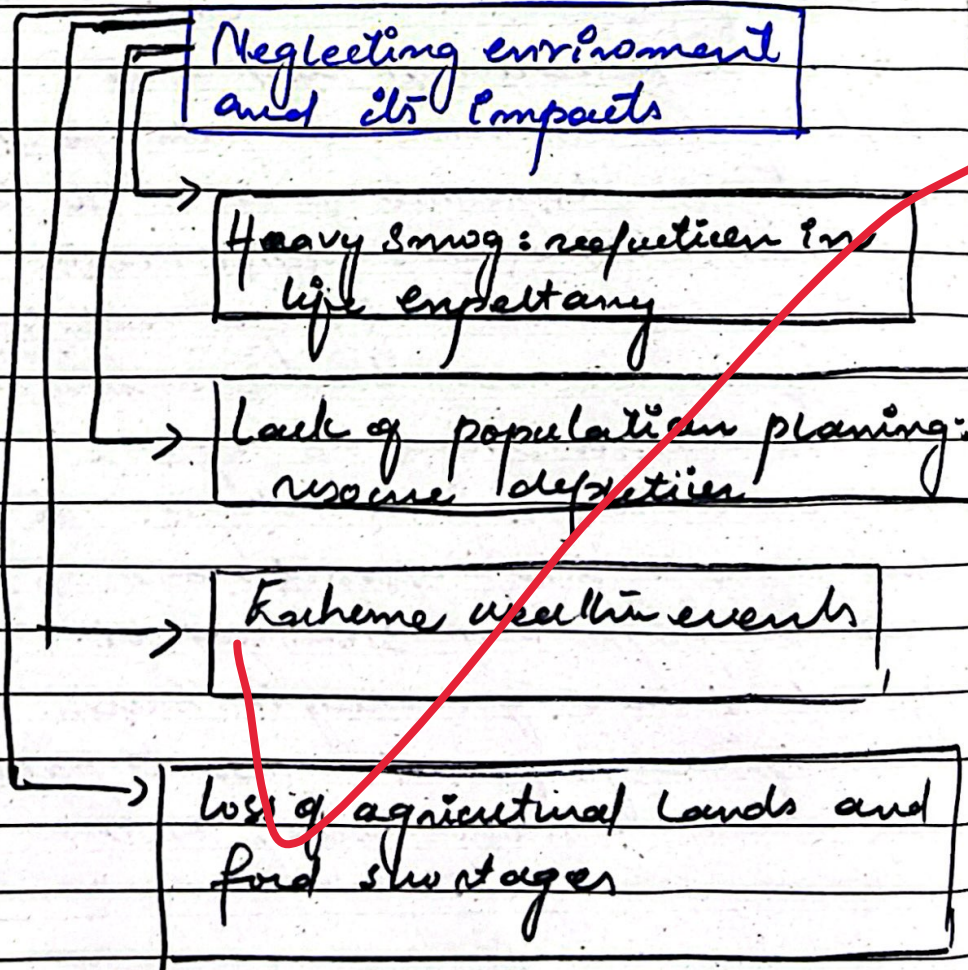

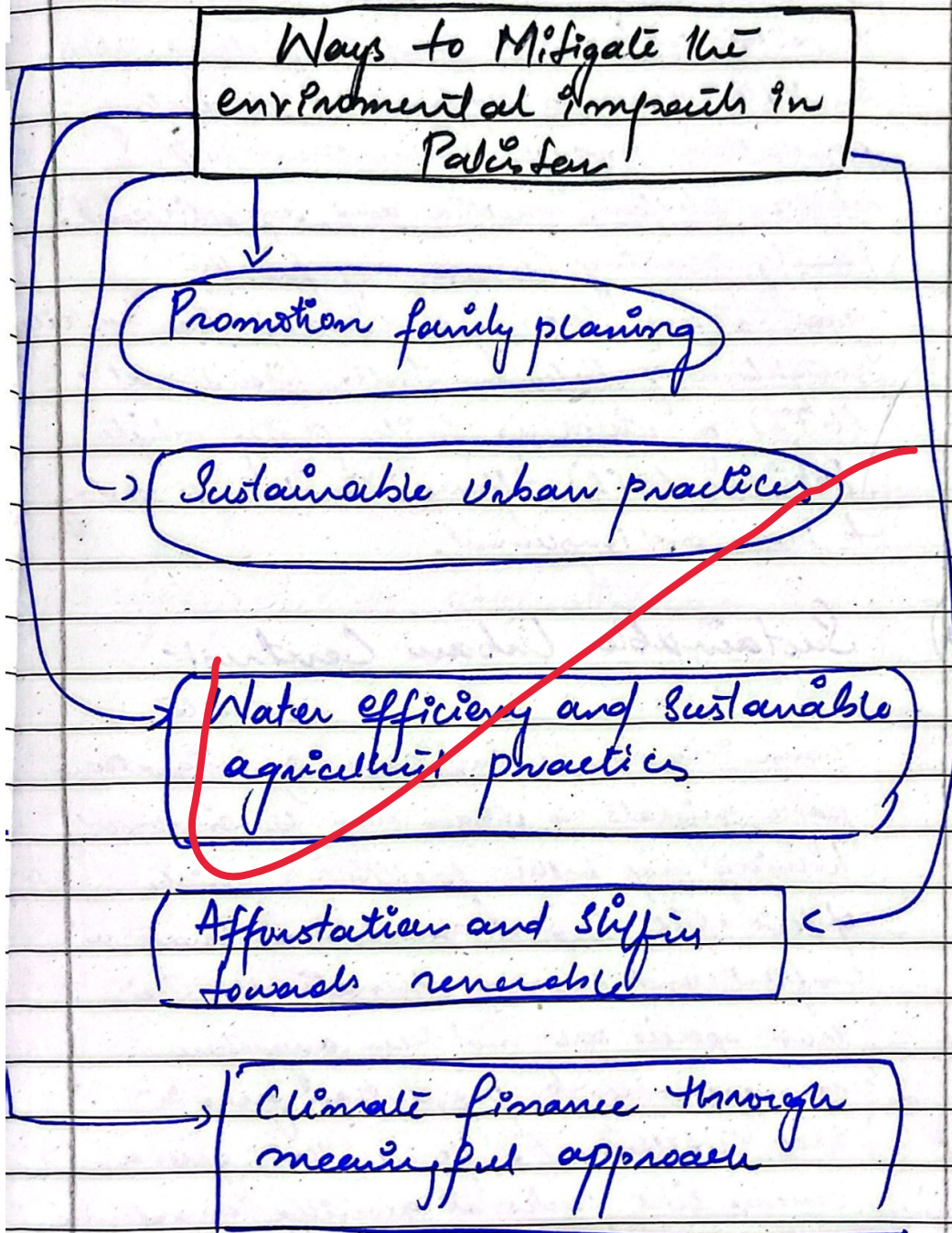

The economic plight of a country is a result of many unfortunate issues. Some of them are discussed here under.

(3.1) Chronic dependence on External Borrowing:-

Pakistan has repeatedly turned to external sources for its funding including loans from International Monetary Fund (IMF), World Bank (WB) or foreign governments to meet its fiscal deficit and stabilize its economy. The country is caught in a vicious cycle of loans which are used to service previous debt, creating long term dependency on foreign aid.

(3.2) Inefficient Tax System:-

Pakistan's tax system has remained one of the world's most inefficient tax systems. A narrow tax base, large informal economy and complex fragmented tax structure hinder revenue generation. The country relies heavily on Sales Tax, which are regressive.

disproportionate to poor. The inability to increase tax revenue has eroded the economic uses of a country.

3) Loss-making State-Owned enterprises:-

Pakistan state-owned enterprises are in a peril of loss that is getting worse with each passing year. The inability of privatizing the SOEs of a country creates a loophole for inefficiencies. According to report published by Federal State Owned enterprises in between July 2023-2024 Pakistan lost Rs 406 billion rupees in the SOE.

4) Political Instability:-

Pakistan's politics has witnessed the instability in the country due to power tussle between the opposition and ruling government. According to International justice Pakistan is an authoritarian regime due to heavy politicization and narrow space of consensus left no room for growth.

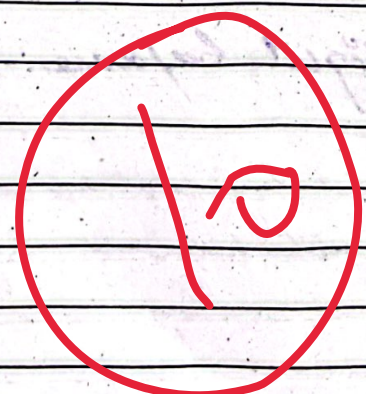
