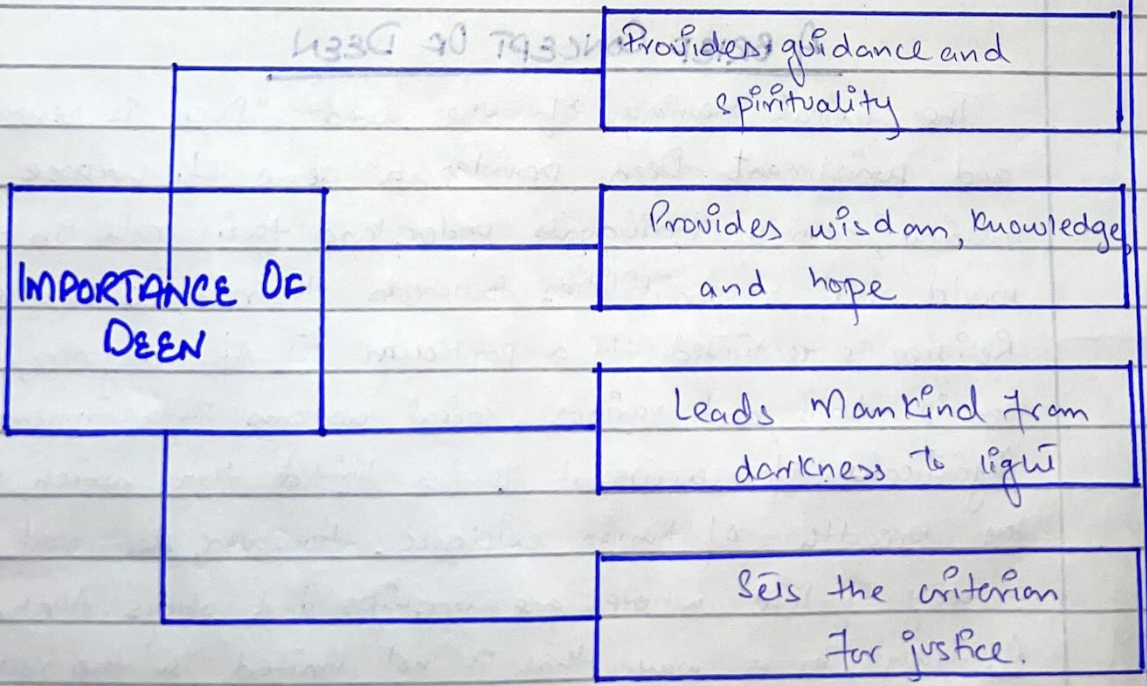

### QUESTION NO.4

Explain the concept and importance of Ijtihad and explain its principles.

### ANSWER

#### INTRODUCTION

According to the Islamic law the process of reaching decision by independent interpretation of the legal sources - The Quran and the Sunnah - is known as Ijtihad. The one who practices Ijtihad is called muftahid, who is required to be an Islamic scholar. Term "Ijtihad" refers to the effort of striving which involves hardships. A conversation between Holy Prophet (S.A.W) and Muadh bin Jabal, Holy Prophet (S.A.W) questioned him about how he would make decisions to which he replied that he would judge according to Quran and if Quran contains nothing to guide him than he would act on the precedents of Holy Prophet (S.A.W) and if he still can't find it he would personally make an effort and judge according to that. It is said in various books that Holy Prophet (S.A.W) was satisfied with his answer. Therefore, ~~the~~ Ijtihad is acknowledged as one the sources of Islamic law alongside Quran and Sunnah.

#### CONCEPT OF IJTIHAD

Literal meaning of the word Ijtihad means to strive, exert or to make an effort to deduce a principle. Ijtihad means to exercise one's judgement

or opinion in a jurisprudential sense. which means that when there is no explicit or implicit divine rulings, one should consider what is more in line with proper reasoning and then implement the decision.

### IMPORTANCE OF IJTIHAD IN THE LIGHT OF QURAN

And if any tidings, whether of safety or fear, come unto them, they noise it abroad, whereas if they had referred it to the messenger and such of them as were in authority, those among them who are able to think out the matter would have known it. If it had not been for the grace of Allah upon you and His mercy you would have followed Satan, save a few.

The Ayah highlights that men who hold authority or have information must carry out Ijtihad. Quran promotes Ijtihad but also says that Prophet or men with authority or power should perform this function, who have true knowledge of Quran and Sunnah.



## IMPORTANCE OF IJTEHAD IN THE LIGHT OF SUNNAH

Significance of ijtehad was first emphasized by the Holy Prophet (S.A.W). The famous conversation of Holy Prophet (S.A.W) highlights the importance of ijtehad. At the time Holy Prophet (S.A.W) showed satisfaction and gratitude to Allah, saying,

"Praise be to Allah, who guides the Messenger of His Apostles as He pleases".

Hadith indicates Prophet's (S.A.W) endorsement of the concept of ijtehad. It also demonstrates that the companions of Holy Prophet (S.A.W) were aware of this concept and applied it according to the situations.

### PROFICIENCY IN ISLAMIC KNOWLEDGE:

A scholar undertaking ijtihad must have a deep understanding of the Quran, Sunnah and classical Islamic jurisprudence.

### ADHERENCE TO ISLAMIC LAW:

The overarching goals of Shariah, such as the protection of life, intellect, religion, property and lineage, must guide the process of ijtihad.

### AVOID CONTRADICTION WITH ESTABLISHED TEXTS:

Ijtihad cannot contradict with the already defined rulings of Quran and Sunnah. It can only be applied to areas where there is ambiguity.

### CONTEXTUAL UNDERSTANDING:

Mujtahid must consider the specific, social, cultural and economic contexts of the issue to ensure relevant and practical rulings.

### SINCERITY AND ETHICAL RESPONSIBILITY:

Ijtihad requires the practitioner to approach the process with sincerity, integrity and commitment to uphold Islamic values.

In today's rapidly changing world, it is very crucial to address challenges like AI, financial systems and human rights. Modern day scholars apply ijtihad to ensure that Islamic teachings remain practical.

## CONCLUSION

In a nutshell, after Quran and Sunnah, Ijtihad is a source of Islamic law. It is the primary distinction between divine revelation and prophetic law and the ongoing development of Ijtihad. Ijtihad is only used in a peripheral manner in this modern era. It cannot be used in any other way.
