### ① Efficiency and Equity:

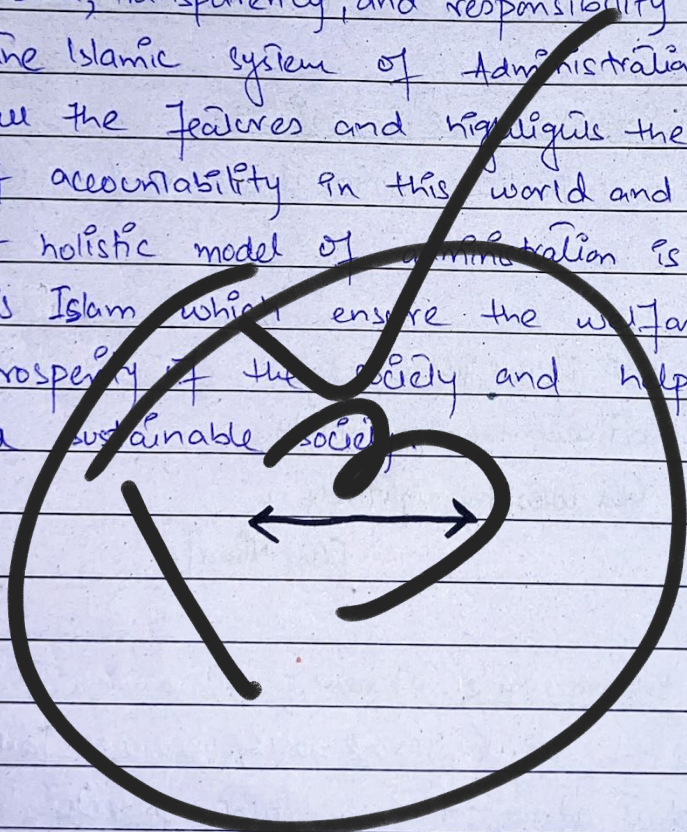

## LETTERS OF HAZRAT UMAR (R.A)

Hazrat Umar (R.A) - second caliph - was known for his extensive correspondence with his governors and officials. His letters emphasized justice, accountability, and welfare of the people.

For instance the letter of Hazrat Umar (R.A) to the Governor of Basra included following words;

"Keep yourself away from luxuries, and fear the cry of oppressed, for the plea of the oppressed is answered"

The world highlighted that justice must prevail to get away from the plea of the oppressed. These letters give a lesson to the Muslims to not be arrogant as even if you are a leader in this temporary world, you are still a servant of Allah (S.W.T).

"He has ordered him to fear Allah, to prefer obedience to Him and to follow what He has commanded in His Book (Holy Quran) out of His obligatory and elective commands"



## LETTERS OF HAZRAT ALI (R.A)

Hazrat Ali (R.A) - Fourth caliph - wrote comprehensive letters to Malik Al-Ash'ar when was appointed as the Governor of Egypt. The letter is preserved in Nahj-al-Balagha, which outlines the principles of justice, equity and the responsibilities of the rulers. He highlighted his advice in a line in following words;

"Let the dearest of your treasury  
be the treasury of righteous action"

Hazrat Ali's (R.A) letter highlighted many advices and focused on the importance of accountability, consensus and being compassionate towards the subjects.

## GOLDEN RULES IN LETTERS

### ① Be Forgiving and Tolerant:

Hazrat Ali stated this in the following words;

"Habituate your heart to mercy for the subjects and to affection and kindness for them."

Hazrat Ali (R.A) highlighted the importance of Forgiving and focused on not to use the powers in a wrong way.



## ② Justice and Fairness:

Both caliphs emphasized the importance of justice. Hazrat Umar (R.A) instructed his governors to treat all citizens equally, stating that the strong should not oppress the weak. Hazrat Ali (R.A) advised Malik Al-Ashhar to be just and avoid favoritism.

## ③ Accountability:

Hazrat Umar (R.A) was known for holding his officials accountable and reminding them that they were entrusted with public welfare and would be answerable to Allah for their actions. He warned the ~~caliphs~~ governors against corruption and misuse of power.

## ④ Consultation and Inclusiveness:

Both the Caliphs highlighted the importance of consultation in governance. As Hazrat Umar (R.A) had established a council of advisors and encouraged his governors to seek counsel in decision making.

## ⑤ Welfare of the people:

Letters of the Caliphs prioritize the welfare of their citizens. Hazrat Umar (R.A) advised his governors to be accessible to the people and address their needs. Hazrat Ali (R.A) instructed Malik to show compassion towards his subjects.
