One of the most important burden on Pakistan's economy is state owned enterprises, which are continuously eating economic cake of the country including Karachi steel mill, PIA and among others. Therefore, to take the economic path the country needs to reform in their skeleton like privatization of their fragile enterprises to reduce the burden and expand the revenue. The privatization model of "Margaret Thatcher" the former UK's Prime minister is very best example that how it should be done to privatize the national assets.

State Owned enterprises - and their burden:

Since the 1960's the national enterprises are continuously in decline and tremendously suffering from fiscal deficit. According the National monetary committee, an annual

basis Pakistan International Airlines burdening up "75 billion rupees". Moreover, the Pakistan railway annually eating "50 billion rupees". Along with them, the most burdening enterprises is Karachi steel mill which is creating annually up to "206 billion rupees deficit". These are the major sectors which are responsible for the country's continuity in fiscal deficit. The accumulated amount is approximately "1 trillion rupees" which is a handsome figure bear by the country.

Faulty Mechanism of State owned Enterprises:

In the SOE's there are thousands of people who are not contributing even of single rupee in national exchequer, opposite to it they are privileged with luxury environments. ~~After~~ Junaid Popal - A analyst and Entrepreneur discover that the average flight of PIA - contain "207 people" excluded to passengers

as helping staff. Whereas actual need is up to 10 people like other airlines.

Therefore, most of the employees are recruited on unaccountable basis.

Politics on Privatization:

The recent bid on Pakistan International Airlines was "12 Billion rupees" whereas actually worth was 58 Billion. This low bid is arranged by some Politicians for their personal interests and this is further creating barriers between Government and bid owner towards privatization. Moreover, Most of the Politicians are non-pragmatic in the privatization due to complex mechanism and low bid by few of the business seekers.

Privatization is necessary - for economic uplift:

It has been seen in developed and developing countries where national bodies were ineffective they were

Privatized them for national benefit and creating suitable border of enterprises to manage them effectively. By the Government. Therefore, the country needs to minimize the cricle of its institutions to manage effectively.
