Government should address this issue to build the new infrastructure to prevent water wastage. So that maximum water could be given to the provinces and its areas.

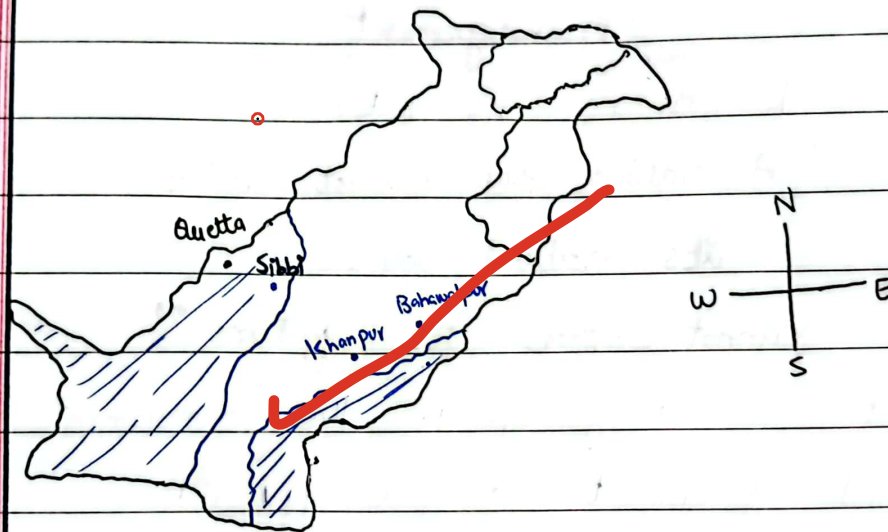

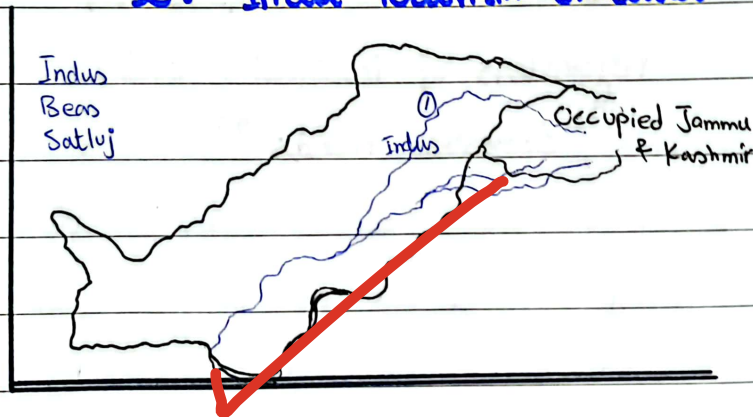
also take steps to address climate issues as well as it should negotiate and take help to the neighbouring countries who are the root cause of this issue.
