Woodrow Wilson - Father of Public Administration describe the public administration dichotomy in which he explains that administration

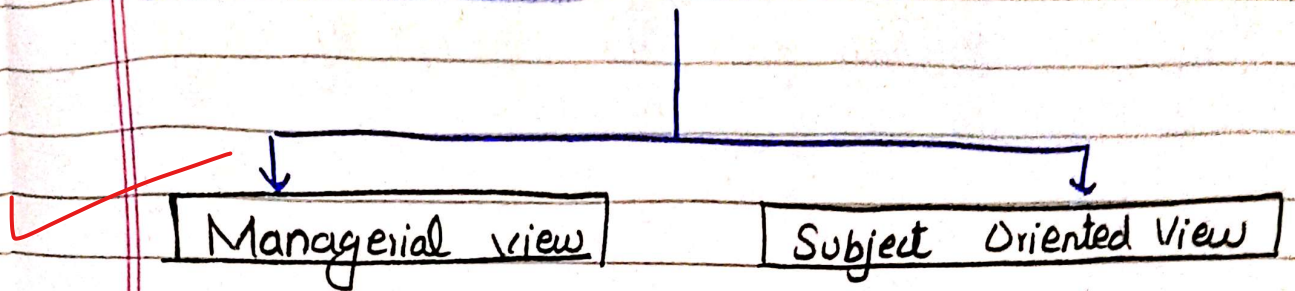

SCOPE OF PUBLIC ADMINISTRATION IN A SOCIETY AND IN PAKISTAN.



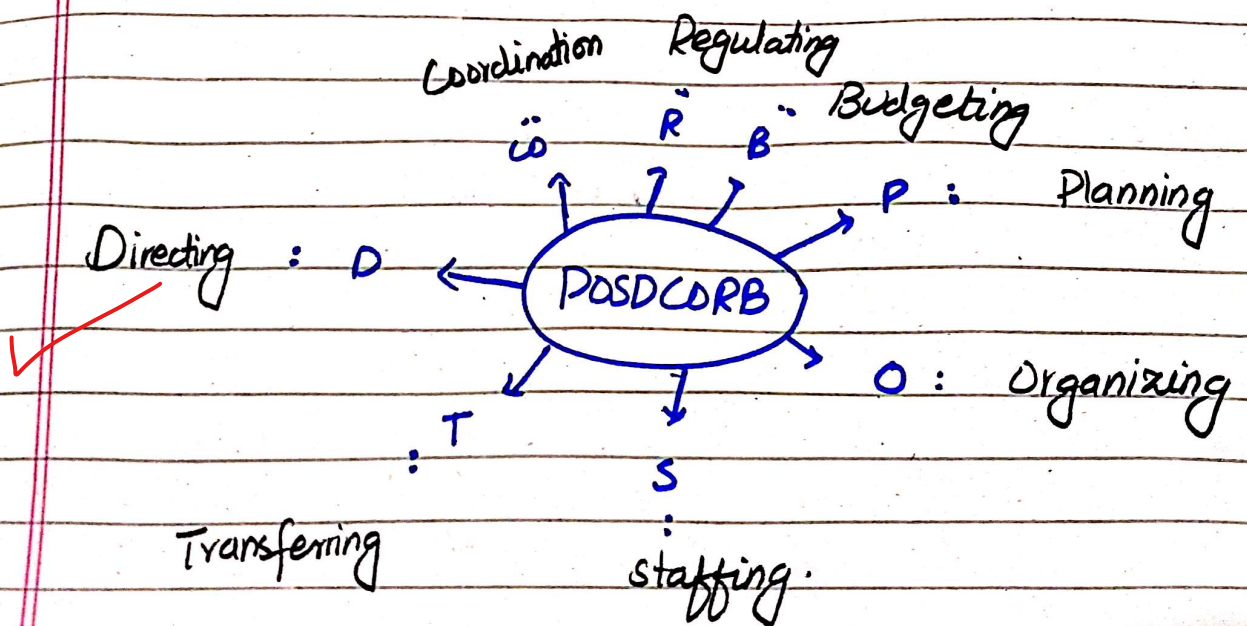
•) Managerial view in public Administration:

This explains that there are manager in a hierarchy in an organization.

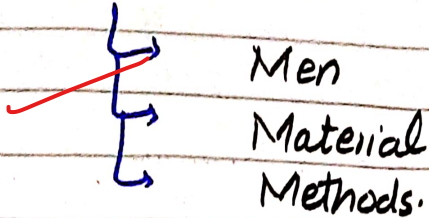
•) Also known as Empirical Approach in public Administration.

The political Administration Dichotomy with reference to this.

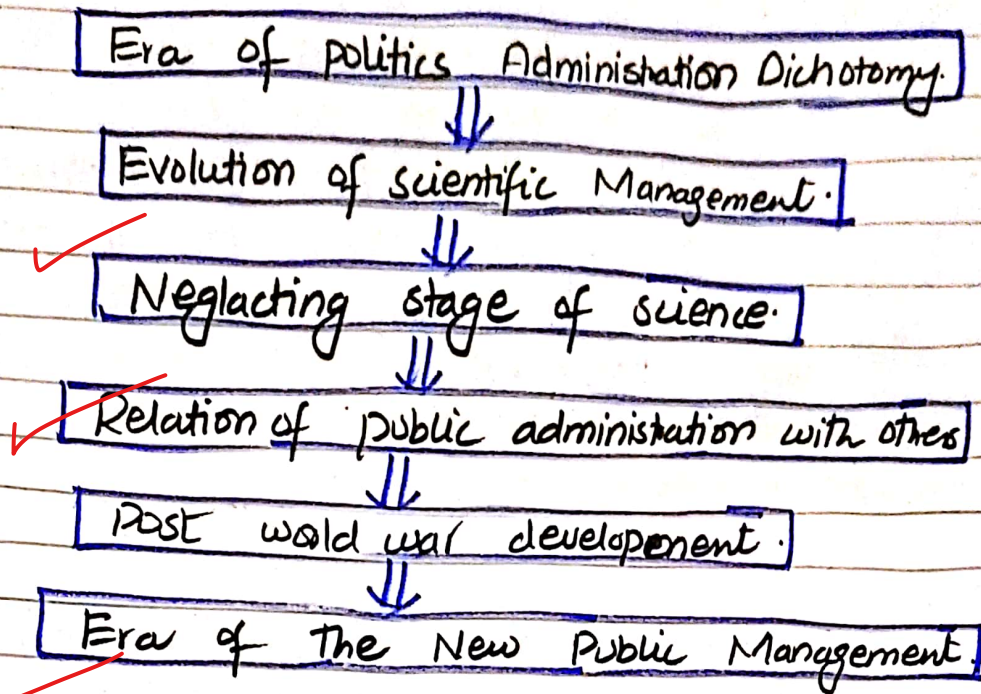
Introduction.

Administration and politics are two important features in public administration. However, for the efficient working of both there should be separation among both pillars. This is described in various stages of the public administration that evolve from previous era and move towards the new public management. However, the different stages in politics administration dichotomy focuses on the evolution of public administration. The execution of policies is only maintained by administrators, rather than negotiations and debates on the policies that results in slow services delivery.

POLITICS ADMINISTRATION DICHO TOMY :

The concept of politics administration dichotomy refers to "separation of Administration from politics." This concept evolved from the early stages of development of public administration and developed to the latest of new public management concept. In all stages, the emphasis was on separation of politics from administration.

STAGES OF EVOLUTION OF PUBLIC ADMINISTRATION DICHOTOMY.



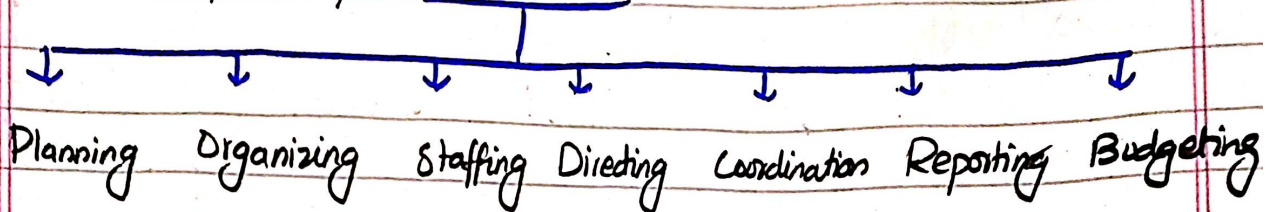
•) Era of politics Administration Dichotomy in public administration.

The era of politic administration dichotomy starts from the Woodrow Wilson - Father of Public Administration. In 1884, he wrote first essay on the evolution of politics administration dichotomy. From that time separation of politics and administration evolved. The other contribution is from

L. D. White; who wrote first book of public administration named "The politics Administration Dichotomy".

•) Evolution of scientific Management in public administration:

On the next era of politics administration dichotomy, the scientific management approach was introduced. They called it the era of scientific management. **Luther Gulick and Urwick** are important contributors in this era. As Luther Gulick gave the concept of **POSDCORB**.



All these concepts are involved in the evolution of scientific research in public administration.

•) Neglecting the scope of science in public administration.

The era of neglect of science in public administration was given by **Elton Mayo**. He was working along with **Hawthorne effects** in which he describes that there is no value of mechanical and scientific approaches in public administration. He neglected this concept in politics administration dichotomy.

•) Relation of public administration with other subjects:

The stage in the politics administration dichotomy is its relation with the other subjects. In this era **Herbert Simon** and **Robert Dahl** wrote books to relate it with other subjects emerging in administration. Its relation was discussed with psychology, physiology, sociology and with many other sciences.

•) Era of Post world war in public administration

The era of post world war brings a lot of changes in politics administration. In this **F.W. Riggs** wrote a book on administration named as **Ecology of public administration**. This concept gave rise in the politics administration dichotomy.

•) Era of New Public Management in public administration.

The era of new public management rises with a lot of changes and new evolutions.

Frank Mariani wrote a book on this:

The Development of Administration in Three Stages.

KEEPING ADMINISTRATION SEPARATE FROM POLITICS :-

By keeping the administration, separate from the politics, the system can work with more efficiency. There will be improvement in the execution policies. This will lead towards the continuity of policies. However, there are certain challenges that are faced by the keeping aside of administration from politics.

CONCLUSION.

In politics administration dichotomy, there is separation among the politics and administration. However, due to this the working of system will be more efficiently. To effective accountability mechanism, the performance measurement is necessary. This involves to know about the performance of the public administrators in different fields.

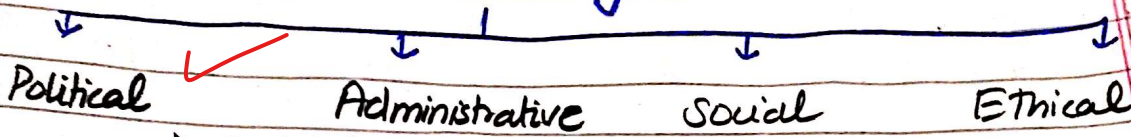
e.g. To know about the performance of civil servants that is recruited to a specific area. Either he or she is fulfilling the duty with concern goals.

•) Audits - tool of accountability in public administration.

Types of Accountability.



•) Political Accountability in public administration. :-

The accountability of the political officials with regard to their services is known as political accountability. As in this, ministers are responsible and accountable before the public.

•) Administrative Accountability in public administration.

The accountability of the administrators to their officials or the public is known as administrative accountability. This is the reason that civil servants remain accountable before their duties.

•) Social Accountability in public Administration

On social accountability, the officials can be remained accountable before the public for their service. e.g. initiative of citizen portal for citizens

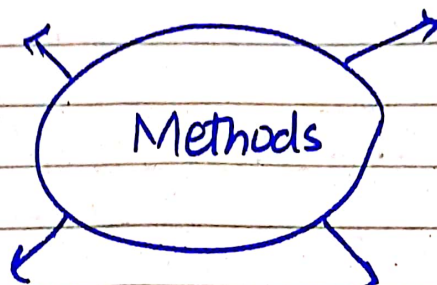
•) Ethical Accountability in Public Administration
