While, the political leaders are still focused upon seeking their political gains. The people living in these war zones have been forced to migrate to the neighbouring countries and many have been internally

Another crisis of ethics and morality is visible in the form of politically influenced and biased media. Media channels are used to polarize the public and shape the narratives of public in order to seek political support. For instance, CNN in US provides the narrative of the US government and portrays biased reporting on global issues such as Palestine-Israel issue. The Israel-Hezbollah ceasefire agreement and the Oslo Accords both saw its ineffectiveness as the violence continued. The next day after Israel-Hezbollah ~~agrees~~ agreement, 10 people were killed in Lebanon by Israeli forces. This showcases the Israel's actual commitment level to the agreement which truly lacks ethical and moral guidelines in its political decisions.

In addition, the international organizations have also failed in settling geo-political tensions. There has been outright violations of international laws and resolutions passed by the UN. The laws and resolutions passed protect the sovereignty and the rights of public in countries. India's political move of abrogating

the Article 370 revoking special status of Kashmir and making demographic changes in the region is against the resolution passed by UNSC. However, despite raising concerns over the matter by Pakistan and other countries like China for peaceful resolution of the issue, the UN has yet failed to implement its resolutions due to political influence. There has been killing of innocent Kashmiris, and the right to own property has been discarded by the Indian government. Instead, it has changed the law in favour of Hindus so that the Kashmir becomes a Hindu-majority area before the referendum.

Veto power is similarly used as a political gains rather than promoting peace and stability in the world order. The five permanent members hold the power over the rest of the nations, therefore dividing the world into groups and alliances in order



to dominate the global politics through increasing their influence. This results in political decisions which lack ethical or moral conduct. The decision of a single permanent member outrights the will of the majority which is against the ethics of democracy. The ceasefire resolution for Gaza was passed by UNGA with 158 nations in favour, while US vetoed the resolution in UNSC which resulted in the failure. This decision was made by US to back Israel in the war and led it continue their aggression.

Another crisis of ethics and morality is seen in the countries backstabbing their allies in order to fulfil their political gains or interests. This is against the morality as betraying the ally then leads to complication in relationships and often hatred towards each other. The Abraham Accords saw the weakening of Muslim

alliance against Israel. UAE, Ethiopia, Bahrain and other countries normalized their ties with Israel, despite their ongoing complication of Palestine - Israel issue. These countries earlier had participated in the Arab- Israel war in support of Palestine, however later on they shifted their support in order to seek personal gains. Israel and UAE trade in between was around 3 billion dollar in 2023. Thus, the weakening of Muslim alliance was a result of immoral and unethical decisions.
