3) POLITICAL SERVICES

The political services include;

1) Conceptualized two-nation theory:

He was of the view that Muslims and Hindus were two separate nations on the basis of language differences. He

opposed the Hindu-Muslim collaboration in any joint venture.

II Protection of Urdu

In 1867, Urdu was the court-language of India, but ^{Hindu} ~~Muslim~~ were trying to curb it. They wanted Hindi to be the court language. But Aligarh movement protected Urdu in this Urdu-Hindi conflict.

III Removed a enmity between Muslims and British:

One of the objective of Aligarh movement was to remove the enmity between Muslims and British. He wrote some books and articles to remove the misconceptions of British ^{about} ~~among~~ the Muslims.

IV Arsenal of Muslim League:

All India Muslim League; the force behind Pakistan movement was created on the occasion of Educational Islamic Conference, held by Aligarh movement. Hence it became the main force behind Pakistan movement.

ALIGARH MOVEMENT AS FOUNDATION OF PAKISTAN

Aligarh movement is considered the foundation of Pakistan movement for the following reasons:

I Muslim Nationalism:

Aligarh movement inculcated the sense of nationalism among the Muslims of India. They started considering themselves as a separate nation. This realization led to formation of Pakistan.

III Cordial Relations between British and Muslims:

British people had a misconception about the Muslims that they were the ^{reason} ~~relation~~ behind 1857 war. Aligarh movement tried to remove the enmity. The "Loyal Mohammedans of India, & Risala Asbab-e-baghawat-e-Hind" succeeded to form cordial relations between Muslims and British.

26th Amendment

I) INTRODUCTION:-

on 21 Oct,
2024, The parliament of Pakistan
passed the 26th amendment
to the Constitution of Pakistan.
Its main objective was
to curb the extraordinary
powers of Judiciary and
Supreme Court. Where many
people across the country
supported the amendment, also
there are some opponents
of the amendment ^{who} that
argue that it is an
attack on the judiciary.

II Features of 26th Amendment:

The main features of
the amendment are as
following.

I) JCP's Structural changes:

The Judicial Commission of Pakistan was previously comprised of 8 members; including chief justice, 3 senior most judges, 1 retired judge, an attorney general, law minister and a member from council bar. But now the number of members are increased to 13. The 5 Parliamentarians are added.

II) Bench Formation:

Bench formation was the power of chief justice. But now the power has been shifted to JEP to form a constitutional bench.

III) Appointment of CJP:

The chief justice of Pakistan was previously appointed by president among the top 3 senior most judges. But now the Parliamentary committee will decide the name for CJP among the top 3 judges and then

Prime Minister will advise the President.

v Constitutional Court:

As per 26th amendment, a Constitutional Court would comprise minimum 5 and maximum 7-9 members. It would be headed by the 4th senior most judge and it would deal with all the legislative matters.

v Suo moto Power:

Suo moto power of CJP has also been given to the JCP. The JCP that comprises of government led parliament would have the power to take suo moto action.

vi Evaluation of Performances of Judges:

The ^{Supreme} Judicial Commission had the power to evaluate the performance of the judges, previously. But now JCP and parliamentary committee have the power to evaluate and review the performance.

→ The new mechanism of reviewing the performance of judges will erode the impartiality of judges.

iv Dependence of Industries on Foreign Exports:

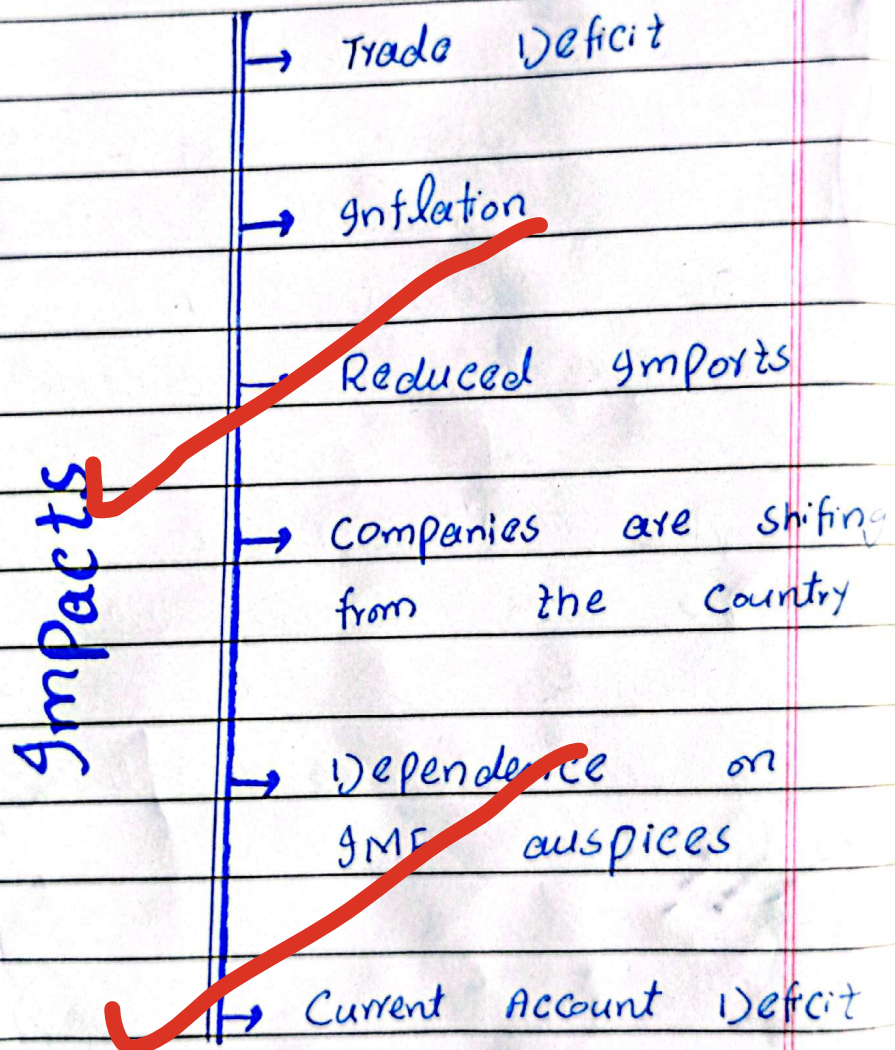

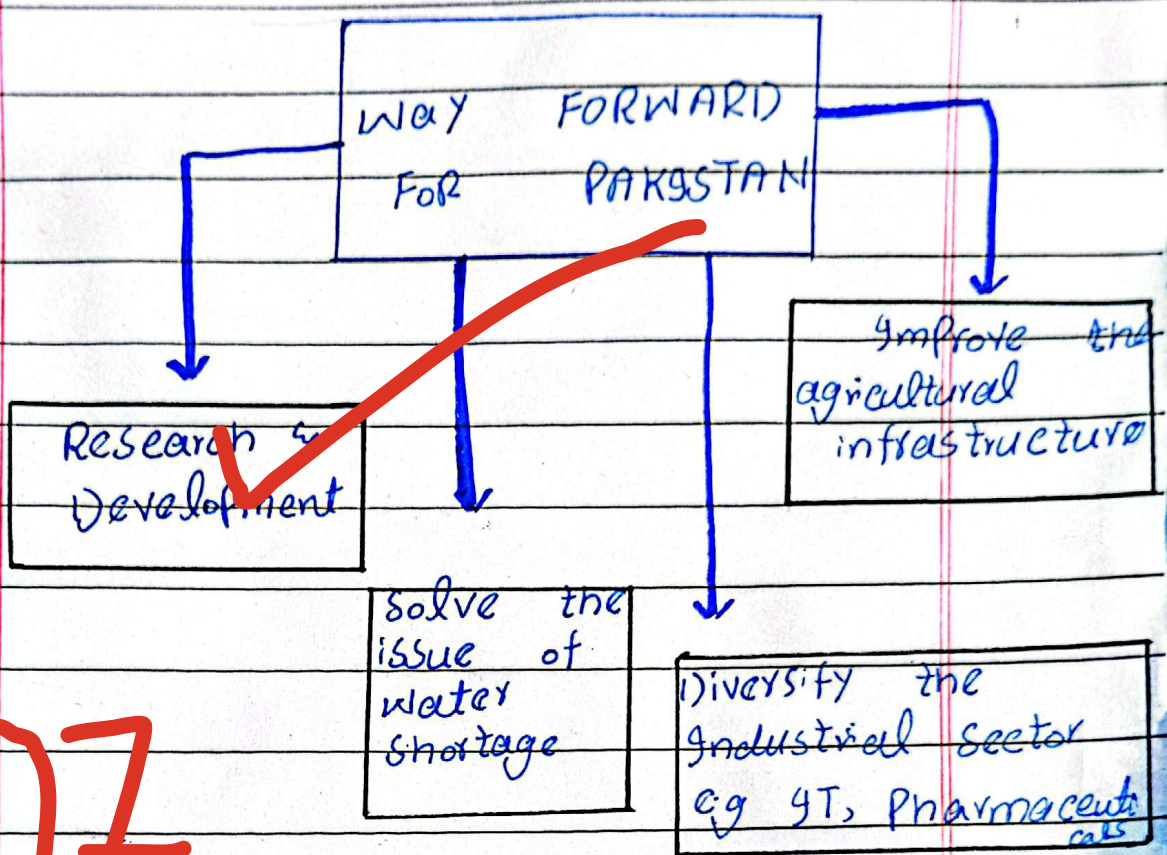
