South Asia rivers are Transboundary in nature and shared by hostile neighbours particularly india, pakistan and china. With the gradually impacts of melting glacier, population growth, water mismanagement and climate change these all factors lead the water toward a geostrategic problem not only resource.

Indus water Treaty (1960)

The Indus water Treaty (1960) was signed between india

Pakistan it allocated

Western River: (Indus, Jhelum, Chenab) Pakistan

Eastern River: Ravi, Beas, Sutlej to India.

Despite the multiple wars the TWT has survived for over 60 years until India's decision to unilaterally suspend it in 2024-2025.

Political Tension between India and Pakistan: This is due to territorial disputes especially over the Kashmir cross-border incidents and also the

Pulwama Attack: A suicide bombing killed 40 Indian soldiers in Pulwama (Indian-occupied Kashmir).

Facts/Impact of this Attack:

India blamed Pakistan-based group Jaish-e-Mohammad lead to Balakot airstrikes by India Pakistan retaliation and aerial

dogfight

Impact:

India threatens to review the Indus Water Treaty and said "Blood and water cannot flow together." (PM N. Modi)

This leads the hypothetical / Recent Escalation Loc 2025:

In 2025 tension reignited with cross-border shelling along the line of Control (Loc)

India accused Pakistan supporting militants in Kashmir, Pakistan accused India's unprovoked aggression.

This situation further escalate when India withdraw from Indus water Treaty in (March 2025).

Effect:

Pakistan declared India move "water aggression" and a violation of international law triggering international concern. These tensions are not just military but also hydro-political as India is attempting to use water as a tool of pressure against Pakistan particularly during crises. These issues Pulwama and IWT 2025, Loc incidents have transformed water into a geopolitical weapon in South Asia.

Implications:1 Violation of international Law:

The Vienna convention governs how international treaties are made, maintained and terminated. parties must perform treaties in good faith, Article 62 allow withdrawal in case of fundamental change of circumstance.

2 India unilateral withdrawal from IWT.

Violate the article (62) since India cannot consult or mutually agree with Pakistan / World Bank on IWT. and undermine the global legal norms.

3 Increase ~~the~~ water insecurity in Pakistan:

When India violate the global legal norms on IWT Pakistan face the water insecurity Tension because Pakistan relies on Indus River system for 90% it's agriculture water. Pakistan face

- 1 Reduced Crop yield
- 2 Drinking water shortage

3 Industrial disruption.

That water insecurity leads pakistan to words the "Drought in south punjab and sindh."

2 Food inflation, unemployment and rural migration.

White pakistan is already a water-stressed country (Lahore & Karachi Islamabad Rawalpindi).

Leads to Threat to Regional peace and Escalation of war.

This happens because water now becoming a strategic weapon in South Asia, That india move may provoke retaliation especially in pakistan view it as "Water Terrorism" Because in

post palawma 2019, india threatened to pakistan (stop water flow)

The "10 May 2025" is the direct Result of water-related escalation

Impact of india is Exist from IWT and china decision of Brahmaputra Dam.

India unilateral withdrawal from IWT sets a dangerous precedent. Countries feel emboldened to disregard international law water agreement in future conflict. Now Both India and China are using water as a geopolitical tool. It signals a global shift of "Hydro-hegemony" where the upstreams controls downstream ones.

"Water is the new oil in Asian geopolitics" (Brahma-Ch)

Because China decision to Build a dam due to achieve carbon neutrality by 2050 and reduce its dependency on coal,

This proposed dam will generate the 60 gigawatt (GW) more than the three Georges Dam making the world largest hydro electric project.

China also want the control on strategic water Resource :

By Building dam control the downstream water flow. But this

opportunities for China in the trade tariffs
imposed by US on both adversaries and
allies?

Ans:

"America First" economic policy
under Trump a domestic push to
reduce the Trade deficits and restore
U.S. Manufacture dominance. The
Tariff was imposed under the Section
301 (Targeting China for unfair practice)
and Section 232 (National security restrictions
on steel / aluminum).

High tariffs also applied to allies
(current average U.S. tariff rates
(2015) on China stand at ~51%
and China reciprocates with ~33%.

on us goods. If the no deal is reached after August 12 tariffs could jump to ~145% on Chinese goods/Exports.

China facing the different challenges.

1 → Export contraction:

China export to US fell sharply machinery down 36% electrical equipment down 42% year-on-year by May 2025.

US Exposure remains a significant risk exports to US accounted for ~\$25 billion in 2024.

2 → Economic Drag:

China also facing the economic drag by US Tariff threat are estimated to reduce the GDP growth by about 1.5 to 3% points. J.P. Morgan raised China full-year growth forecast 4.8% due to partial tariff relief. potential job loss up 15-20 million particularly in export intensive growth.

3 Global supply chain Disruption.

U.S. Tariff escalation is reshuffling global supply chains, companies are relocating to Southeast Asia (Vietnam & Cambodia) to avoid Tariff exposure.

Exports face uncertain demands and rising cost.

4 Erosion of U.S. Global Leadership

Boat Tariff on allies like Canada, Mexico, EU, Japan have unsettled the U.S. allies, helping China position itself as a reliable Trade partner.

5 Opportunities for China:

China have diversified Trade partnership ties with EU, ASEAN, Europe reducing dependency on U.S. Markets: its pursuing multilateral diplomacy through forums like SCO, BRICS to shape global Trade norms.

Critically evaluate the Russia and China growing relations and its implications on global power politics?

Ans

Since 2022 China and

(W)
Russia have deepened their relations into what analysts call a "no limit friendship". They are conducting joint naval exercises aligning diplomacy and coordinating at strategic forums like BRIC and SCO.

Trade between them reached approximately \$240 billion in 2023 and remained in that range into 2024 with China accounting for 41% of Russia's imports and 30% exports. This alignment is grounded in the post-Cold-war Primakov Doctrine (Advocating the strategic ties with China to oppose the U.S.).

⇒ Strategic Characteristic of the partnership:

The relationship is asymmetrical. Russia is the junior partner, as China wields greater economic power while Russia provides energy and defense collaboration. They pursue coordination yet autonomous actions, often aligning with

UN while diverging on some regional priorities. Their combined institutional influence through BRICS and SCO effort to reform global governance bodies.

→ Global implication of power politics:-

→ Push toward Multipolarity.

Their combined influence challenges the US dominance signaling a move toward a multipolar system. They have expanded institutions like BRICS and SCO to legitimate their new order.

→ Strategic Diversification & Sanction Resilience.

Western sanctions have isolated Russia but China's economic lifeline provides resilience. They have redirected energy trade and developed alternative supply routes easing Russia's economic crisis. Military exercise like the Joint Sea 2025 near Japan and air patrols.

Redrawing Global Trade Architecture.
Integration of china BRI with
Russia led Eurasian economic
union aims to reshape Transcontinental
Trade and governance offering
alternative to western led
institutions.

Relevance to Pakistan / impact on
Pakistan:

Pakistan is the part of china
Russia axis leveraging CPEC as
a conduit to connect with Eurasian
markets and Russia. This alignment
aims to counterbalance India and the
US India axis.

Islamabad is exploring the Russia
energy deals (gas pipelines)

Russia and Pakistan signed their
first barter trade deal. But

Russia now diversifies its alliance
beyond the India including Pakistan
in military exercise and energy
projects.
