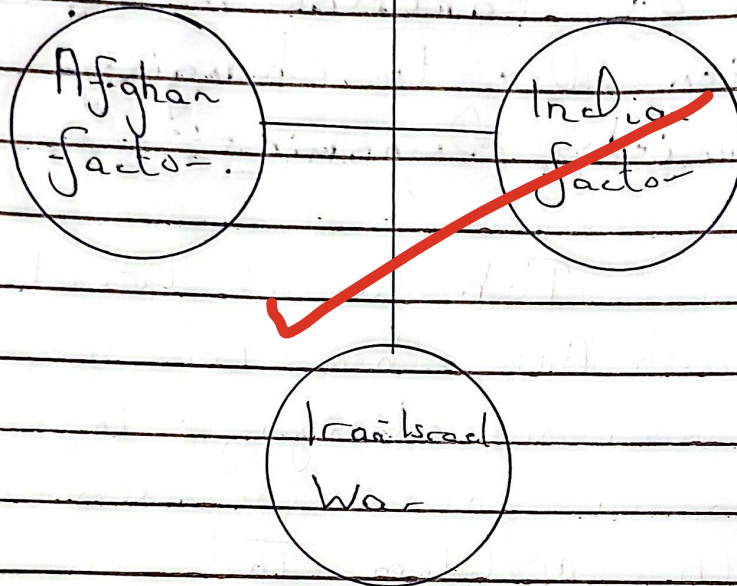

b) Indian factor ~ A potential nuclear flash point ~ Pakistan's defensive role against Delhi's policies :-

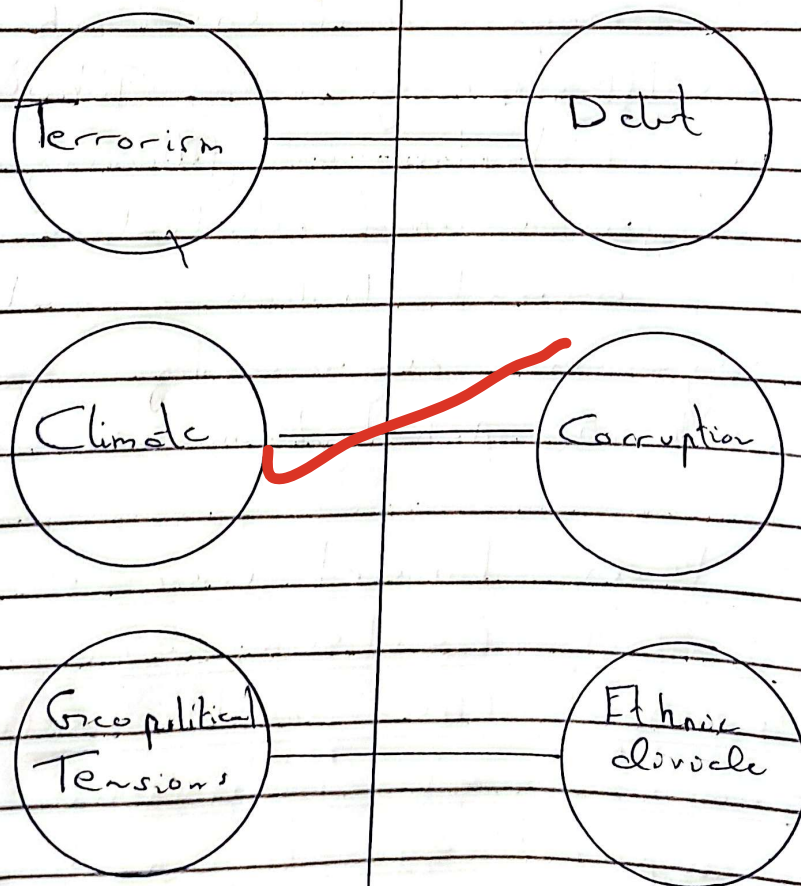

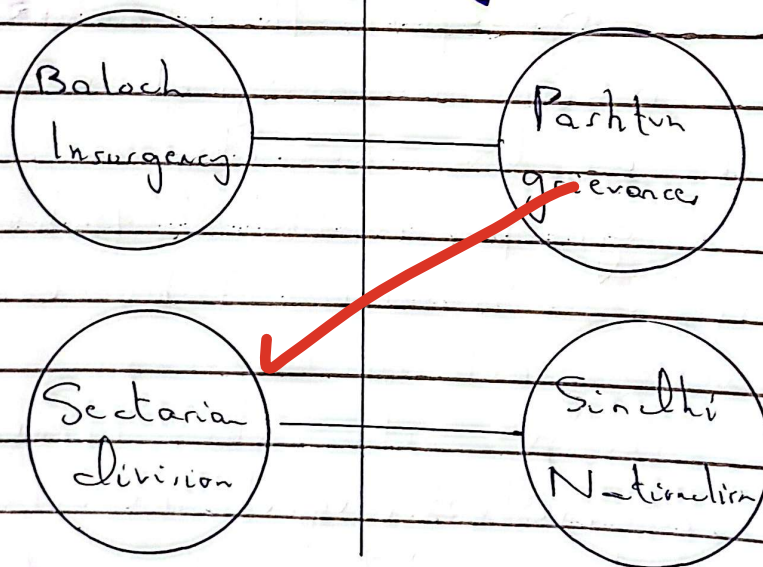

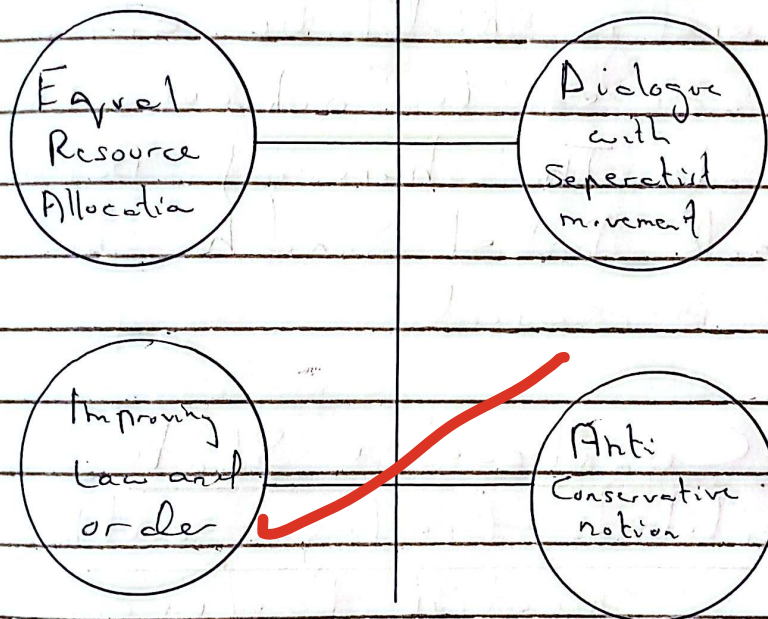
The rural Sindh is deprived of the basic facilities. However, the urban Sindh is more developed in terms of infrastructure. This has fueled tensions between local people.

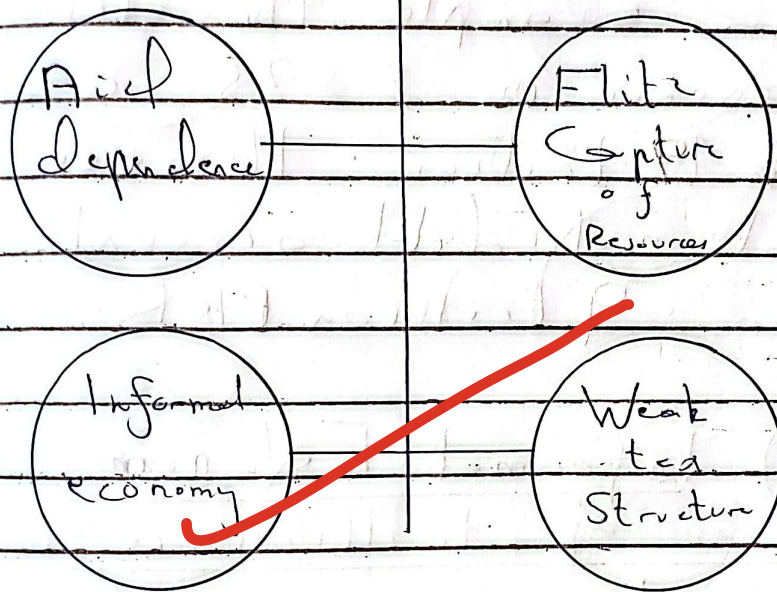
